Kollye Kilpatrick stated to council that since the last council meeting, he had complied with the attorneys per email to discuss his grievance appeal. On March 18, 2024, he met with Mayor Erica Gillum and verbally told her his concerns, as of today he has not received a response, he feels like he is being discriminated against.

Barbara Bezub stated that she is on the Planning and Zoning Commission and wanted to let council know why they did not approve the request for the rezoning of Block 610. She stated that the owner was not in attendance at their meeting. The property is adjacent to the Waller County Library. Her concerns are parking and the number of vehicles, and it's not the best area to have multi family in a residential area. Also, the five lots behind this property will have no way to gain access since there is no alleyway.

Attorney Charles Williams stated that the turnover was due to a transition of attorneys since two senior partners retiring and the illness of Art Pertile. Councilmember Karon Neal stated she would like to see our city grow and put into place what is needed to get things done. Attorney Charles Williams stated that the transition is completed and he is currently our appointed attorney. Councilmember Cindy Pearce stated that Olson & Olson is not the reason we aren't prospering and that they are not out to sabotage us.

Councilmember Mildred Jefferson made a motion to approve the authorization for the mayor to submit Request for Qualifications for City Attorney. Lack of second motion, motion denied.

8. Consideration and action on an Ordinance of the City Council of the City of Hempstead pursuant to the authority of Chapter 504, Subchapter D, Section 504.171 authorizing the Hempstead Economic Development Corporation, a Type A Corporation, to undertake a Type B Project under the provisions of Chapter 505 of the Local Government Code; making certain findings and containing provisions related to the subject.

Dr. Ramiro Bautista stated to council that this is one of the wrongs he wants to make right under his leadership. This would be a city project specific to the Master Plan to be split between the two corporations Type A & B. Both corporations can fund the project and not just Type B. Councilmember Mildred Jefferson made a motion to approve the Ordinance. Mayor Pro-Tem Lonnie Garfield seconded the motion and it carried unanimously.

9. Consideration and action on Resolution of the City Council of Hempstead approving as a project of the Hempstead Economic Development Corporation Type B, the Hempstead Gazebo Park Project 2024 for the installation of benches and vintage light poles at Hempstead Gazebo Park.

Dr. Ramiro Bautista stated that the 60-day waiting period for this project will expire on April 18, 2024. Councilmember Cindy Pearce asked if the light poles match the ones in the downtown district. Dr. Ramiro Bautista stated no they will be different. Mayor Erica Gillum also stated that they will be conducting a survey going around the city to get a poll to change the color of the gazebo. Councilmember Mildred Jefferson made a motion to approve the Resolution. Mayor Pro-Tem Lonnie Garfield seconded the motion and it carried unanimously.

10. Consideration and action on a Resolution from the City Council of the City of Hempstead determining the time and place of the meetings of City Council of the City of Hempstead, Texas; making findings and containing other provisions related to the subject.

Councilmember Karon Neal asked if the meetings would interfere with the functions going on at the Recreation Center. Mayor Erica Gillum stated no. Councilmember Nora Hodges stated that her purpose for wanting to move the meeting location is to have enough space so that all citizens who want to attend can do so. Councilmember Cindy Pearce would like to keep the meetings at city hall since Dr. Bautista's office is only temporary and we will regain that space in the near future. Mayor Pro-Tem Lonnie Garfield made a motion to table the item. Councilmember Mildred Jefferson seconded the motion and carried unanimously.

11. Consideration and action on approving the procurement policies and procedures for the Resilient Communities Program Grant.

Councilmember Nora Hodges asked who served on the committee and also asked the City Secretary could she send a copy of the scoring sheets to Langford. Councilmember Nora Hodges made a motion to approve the procurement policies and procedures. Mayor Pro-Tem Lonnie Garfield seconded the motion and carried unanimously.

Nora Hodges made a motion to approve the Resolution. Mayor Pro-Tem Lonnie Garfield seconded the motion and carried unanimously.

13. Consideration and action on a Resolution granting a permit to Mr. B Fireworks to have supervised public fireworks display on July 4, 2024, at Hempstead City Park.

Mayor Pro-tem Lonnie Garfield made a motion to approve the Resolution. Councilmember Mildred Jefferson seconded the motion and carried unanimously.

14. Consideration and action on a Resolution of the City Council of the City of Hempstead establishing a policy for the City of Hempstead Business Park, to provide for the city mowing and maintenance of property owned by the Hempstead Economic Development Corporation; making findings and containing other provisions related to the subject.

Dr. Ramiro Bautista stated that these are the lots in the business park that a vendor was being paid without an invoice for many years, he would like to terminate the service and have the city mow the lots.

Councilmember Hodges made a motion to approve the Resolution. Councilmember Mildred Jefferson seconded the motion and carried unanimously.

15. Consideration and action of an Ordinance of the City Council of the City of Hempstead amending Ordinance No. 23-112 which will amend the City Budget for the 2023-2024 Fiscal year and authorizing amended revenues and expenditures as therein provided. (Date to be Determined)

Mayor Erica Gillum stated that the festival will be held in June, the city will have to get with the performer and see what day is available for the festival. Mayor Pro-Tem Lonnie Garfield made a motion to approve the Budget Amendment. Councilmember Mildred Jefferson seconded the motion. AYES- Mayor Pro-Tem Lonnie Garfield, Councilmember Karon Neal, Councilmember Mildred Jefferson, Councilmember Nora Hodges. NO's-Councilmember Cindy Pearce. Motion carries.

16. Consideration and action on as proposal from IDS Engineering to perform additional Professional Engineering Services for an Asphalt Roadway Rehabilitation Program for the City of Hempstead.

Travis Sellars with IDS stated to council he has worked with the city before on a street rehab program. He will put together a bid packet and work along City secretary to post in the local paper. The contract has a one-year life for the streets. It will be in June or July. IDS will provide inspection once the streets are done. Councilmember Hodges made a motion to approve the proposal. Mayor Pro-Tem Lonnie Garfield seconded the motion and carried unanimously.

- 1. Nora Hodges- Thirty-nine attendees attended the educational workshop for Medicare on Thursday, March 21, 2024, wanted to thank everyone who attended. Had lunch and a speaker and prizes. - 2. <u>Karon Neal-</u> Big thank you to Sabrina Alvarez & Leslye Gonzalez in the City's Secretary's Office for all their hard work. Also, big shout out to the Electrical and Street Department for working after hours and keeping the city going.





### SECTION 9. PAYROLL PROCEDURES AND COMPENSATION

#### A. Vacancies and Announcements

Department heads notify the Mayor immediately when job vacancies occur in their department. Only those vacancies allocated in the annual budget or new positions authorized by the Mayor and budgeted by City Council will be filled. Vacancies may be filled through public announcement and promotions. Current employees who wish to transfer to a different department, may apply for an opening in that department, attend an interview, and if the department determines they are the most qualified applicant, the City may transfer that employee into the vacant position in the new department.

Job announcements, insofar as practicable, will specify the title and nature of the job and the required qualifications. Announcements will also contain a statement affirming the City's commitment to equal employment opportunities. An adequate period of time will be allowed in the selection process to ensure fair and open competition for vacant positions.








- 6. The Commission and CITY OF HEMPSTEAD wish to further the goal of safe operations of earth movement activities near pipelines containing flammable, toxic, or corrosive gas, a hazardous liquid, or carbon dioxide, within the State of Texas.
- 7. The Commission has considered any history of previous violations by CITY OF HEMPSTEAD, the seriousness of any alleged violation, and any hazard to the health or safety of the public, and has determined that the facts of this case warrant an informal disposition of the Commission's concerns under the terms of this Order.

- 8. CITY OF HEMPSTEAD has elected not to avail itself of the opportunity for public hearing.
- 9. The Commission has jurisdiction to assess an administrative penalty against CITY OF HEMPSTEAD. Tex. Util. Code §§ 121.206 and 121.207.
- 10. An administrative penalty in the amount of TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00) shall be paid to the Commission for the alleged violation(s) asserted against CITY OF HEMPSTEAD.
- Respondent has paid the Commission funds in the amount of TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00) as payment of administrative penalties assessed in Damage Prevention Docket No. 084377.
- 12. The person signing hereunder for CITY OF HEMPSTEAD has authority to represent CITY OF HEMPSTEAD in this matter.

Jurisdiction of this docket having been established and an agreement of the parties having been reached, it is, therefore, ORDERED by the Commission that CITY OF HEMPSTEAD be assessed an administrative penalty in the amount of TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00), and that Damage Prevention Docket No. 084377 be informally disposed of by the Consent Order and closed. All relief not granted in this Order is DENIED.
