# Jo Daviess County Board of Health Meeting

Wednesday, August 10<sup>th</sup>, 2016 at 7:00 pm Jo Daviess County Health Department Conference Room MINUTES

## 3. Approval of Minutes

a) Minutes from June 22, 2016 Board of Health Meeting – After review, Elizabeth Blair motioned to approve the minutes, as presented, second by Kim Barrett. All were in agreement, motioned passed.

#### 5. Unfinished Business

i. Discussion and possible action to approve a recommendation from the Board of Health Finance Committee for the Successful Bidder for the Main Level Commercially Rated Luxury Vinyl Tile Project – Gary Jobgen motioned to recommend acceptance of the Knautz Flooring bid for installation of luxury vinyl tile flooring, second by Bill Bingham. The Finance Committee has previously reviewed, packets were given out to the other BOH members to review. Ron shared the concerns the Finance Committee discussed. The flooring brand, quality and references provided by the two companies were taken into consideration. All in favor, motion passed.

After much discussion, the BOH would like to get a bid from another company, compare the two and then make a decision. A roll call vote resulted in 6 Nays, motion did not pass.
