**Dam Insurance:** Rob has not heard anything further from Kris McNally. The last correspondence he had with her was regarding the \$2,200.00 policy amount. Per Commissioner, Gene Anderson, a class 3 policy is difficult to obtain.

**Aerators:** Per Kyle the signs are all set to be placed. The signs will be placed on 2-22-20 by Board Members. The signs will need to be checked every two days and moved if necessary. DNR needs to be notified and the power needs to be turned on. Customer service needs to be called with the time and location. Rob with notify Leslie George with his replacement information.

**River:** There has been no new information on this subject. The attorney is still working on the contract that may be presented to Mr. Rosnow.

**Weeds:** Per Terry, DNR has grant money for 2020 in the amount of \$2,400.00 which needs to be applied for ASAP. Ron Dewey from Minnesota Aquatics will do the paperwork and apply for this grant for Knife Lake Improvement District. Terry has the letters regarding spraying for 2020 printed, in envelopes and stamped ready to be mailed.

**AIS:** Per Kyle, KLID will be receiving funding for curly leaf spraying. Kyle is still working on getting donations from other lakes. AIS funding is based on ramps and the number of parking spaces. The county would like to hire two inspectors for a total of \$12,000.00 - \$15,000.00. Soil and water are hiring two of which the funding will come out of AIS.
