Old Business

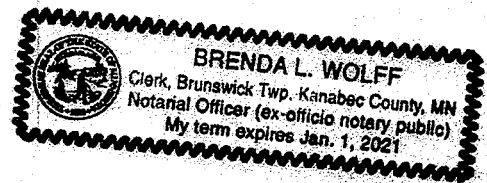
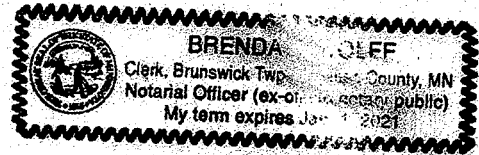
Insurance policy for the town hall building. M/S/C Rick Kawalek to put the insurance on the building Seconed by Jeff Akkerman Motion Carried.
