

Brunswick Township Approved Meeting Minutes

Monday, August 13, 2018

Call to Order: Chair Rick Kawalek called the meeting to order at 7:00 PM. The following were in attendance: Supervisor, Rick Kawalek; Supervisor, Jeff Akkerman; Supervisor, Peter Gravich; Zoning Adm., Walt Argetsinger and Clerk, Gladys Nelson; Treasurer, Shari Hartog. There was a sign-in sheet provided for all others. Pledge of Allegiance was said.

Agenda: Rick asked if there is any addition or correction to the agenda. Rick made motion to add road report; seconded by Jeff . Motion carried.

Clerk Report: Gladys read the minutes from July 9, 2018 meeting. Rick asked for any addition or correction; Jeff made a motion to approve the minutes as amended; second by Peter. Motion carried.

Treasurer Report: Shari read the treasurer report ending July 31, 2018 and reported total cash of \$ 380,679.82. Motion by Jeff to approve the report and file for audit; second by Peter . Motion carried

Claims: Supervisors reviewed the claims. Motion by Jeff ; second by Peter to pay claims. Motion carried. (Total of claims paid on August 13, 2018 was \$ 39,404.60 ; check # 6971 - 6986.)

Zoning Report: Walt reported two land use permits issued; one to Held and one to Milbrath.

Comments from the floor: Loren Barnick present and commented on the chloride application on the road near his home. Motion by Peter and seconded by Rick to have H&P Gravel & Grading cover the chloride sprayed area near the Barnick property with gravel. Motion carried.

New / Old Business:

**Motion by Jeff; seconded by Rick to certify the 2019 tax levy as approved at the July 23rd Special Town Meeting in the amount of \$ 122,000.00 with the Revenue Fund set at \$ 10,000.; Fire Fund set at \$ 32,000.; Road and Bridge Fund set at \$ 80,000. Motion carried.

**The Inspection Report done by HomeWise Inspections LLC of Ogilvie was discussed. The Clerk was asked to run an ad in the Mora Advertiser for 2 weeks to secure details and cost for the following: chimney; water heater; furnace; vents; gutters; down spouts; cracks in foundation. Interested parties to contact Clerk to receive further information; further discussion at September meeting.

**Road Report - check culvert and replace as needed at junction of 153rd Avenue and Highway 65. Rick will ask Besta of Rush City to give quote to brush some roads. Motion by Jeff; second by Peter to have H&P Gravel & Grading do 100' of rip rap on Lumber Street to help with erosion during flood stage. Motion carried.

** Shari noted paperwork for signature updates on the Spire account was ready to sign. Motion by Rick; seconded by Peter to have all elected officers and deputy Clerk and Treasurer sign the needed papers at Spire Credit Union in Mora. Motion carried.
