

Brunswick Township Approved Meeting Minutes

Monday, September 10, 2018

Call to Order: Chair Rick Kawalek called the meeting of the Brunswick Board of Supervisors to order at 7:00 PM. The following were in attendance: Supervisors, Rick Kawalek, Jeff Akkerman and Peter Gravich; Zoning Adm., Walt Argetsinger; Clerk, Gladys Nelson; Treasurer, Shari Hartog. There was a sign-in sheet provided for all others. Pledge of Allegiance was said.

Agenda: Rick asked if there is any addition or correction to the agenda. Rick made motion to add painting town bridge; seconded by Jeff . Motion carried.

Clerk Report: Gladys read the minutes from August 13, 2018 meeting . Jeff made a motion to approve the minutes; second by Peter. Motion carried.

Treasurer Report: Shari read the treasurer report ending August 31, 2018 and reported total cash of \$ 341,766.77. Motion Peter to approve the report and file for audit; second by Jeff . Motion carried

Claims: Prior to review of claims, a discussion was held on painting town bridge. Motion by Jeff; second by Peter to have Nelson Painting do a second coat for a cost of \$ 443.00. Motion carried. Supervisors reviewed the claims. Motion by Peter ; second by Jeff to pay claims. Motion carried. (Total of claims paid on September 10, 2018 was \$ 22,797.48 ; check # 6987-7009.)

New / Old Business:

**Zoning Report: Walt reported no land use permits issued. Discussion was held on the new home located on junction of Highway 65 and 145th Avenue. The new home would establish 4 homes per 40 acres which is against Brunswick zoning. Walt reported the permit was received from Kanabec County Environmental Services. Rick asked Clerk to gather information about the lot and he would take to Attorney Hofstad for an opinion.

**The Clerk reported on a meeting with Chad Sivigny, the only contractor who responded to our ad for repairs and maintenance. Jeff will work with Chad during the month and report back in October.

**Road Report – Richard will check on a culvert on 127th Avenue, on a ditch near a house on Lewis Lake and Shady Acres. More discussion in October.


