

**Brunswick Township Approved Meeting Minutes**  
**Monday- - June 8, 2020**

**Call to Order:** Chair Rick Kawalek called the meeting of the Brunswick Board of Supervisors to order at 7:00 PM. The following were in attendance: Supervisors, Rick Kawalek, Peter Gravich, Jeff Akkerman; Zoning Adm., Walt Argetsinger; Clerk, Gladys Nelson; Treasurer, Shari Hartog. There was a sign-in sheet provided. Flag pledge.

**Agenda:** Rick made motion to approve the agenda; second by Jeff. Motion carried (3-0).

**Clerk Report:** Gladys read the minutes from May 11, 2020 Board of Supervisors meeting. Jeff made a motion to approve minutes; seconded by Rick. Motion carried (3-0).

**Treasurer Report:** The treasurer report ending May 31, 2020 reported total cash of \$ 319,484.35 Motion by Peter to approve the report and file for audit; seconded by Jeff. Motion carried (3-0).

**Claims:** Motion by Jeff; second by Rick to pay claims. Motion carried (3-0). (Total of claims paid on June 8, 2020 was \$ 23,623.17; check # 7288-7298.)

**Comments from the Floor:** Blair George was present; he wanted the Board to help clarify where the Township road ends near their property. After discussion a motion by Jeff; seconded by Peter that the Town road near the Lewis Lake public access ends at the mailboxes and becomes a private road from there. Clerk to prepare an email with this information for the Kanabec County Environmental Services office. Motion carried (3-0)

Julie Rivard and Josh Kunde appeared to discuss the building of a pole building on their .5 acre of land. They discussed what has taken place thus far. Because of the inability for the Rivard's to meet setback requirements, a motion was made by Jeff; seconded by Peter to ask them to apply for a variance. The date for the Public Hearing was set for Monday, June 29, 2020 at 6:00 p.m. Motion carried. (3-0)

**New / Old Business:**

**\*\* Zoning Report -** Walt reported three permits issued. A motion by Jeff; seconded by Rick to continue with the preparation of a document to terminate current Conditional Use Permits as requested by landowners. Motion carried (3-0)



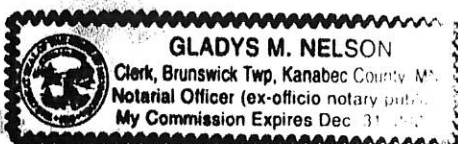
**Adjourn:** Jeff made motion to adjourn; seconded by Rick at 9:00 pm. Motion carried (3-0).
