

Brunswick Township Approved Meeting Minutes
Monday - June 14, 2021

Call to Order: Chair Rick Kawalek called the meeting of the Brunswick Board of Supervisors to order at 6:00 PM. The following were in attendance: Supervisors, Rick Kawalek, Peter Gravich, Jeff Akkerman; Clerk, Gladys Nelson; Treasurer, Shari Hartog; Zoning Adm., John Teichroew.

Agenda: Peter made motion to approve the agenda; second by Jeff. Motion carried (3-0).

Clerk Report: Gladys read the minutes from May 10, 2021 Board of Supervisors meeting. Jeff made a motion to approve minutes; seconded by Peter. Motion carried (3-0).

Treasurer Report: The treasurer reported total cash of \$ 352,311.39 as of May 31, 2021. Motion by Jeff to approve the report and file for audit; seconded by Rick. Motion carried (3-0). The Treasurer received an email from MN State Auditor indicating receipt of the 2020 Audit information.

Claims: Motion by Jeff; second by Peter to pay claims. A claim submitted by Ronald Peterson was tabled to July pending the need for more information. Motion carried (3-0). (Total of claims paid on June 14, 2021 was \$ 27089.12; check # 7460-7471)

Comments from the Floor: *Sheila Peterson* representing *Accelerate, Kanabec County*, discussed the purpose of the group. Motion by Peter, seconded by Jeff to adopt a Resolution stating Brunswick Township supports the groups purpose to provide high-speed internet to every home and business in Kanabec County. Motion carried (3-0)

Sarah Larson discussed her desire to build a garage on her property in Section 29. The size of her parcel in Kay Mar Estates is small and would not be able to satisfy the setback needed. She was advised to apply for a variance.

Richard Hall gravel pit: Roger Johnson, representing the Lewis Lake Property Owners, gave an update from last meeting and discussed some statistics. Richard Hall explained his Operational Plan and answered questions. Motion by Jeff; seconded by Rick to table discussion and any decisions to July meeting. Motion carried (3-0)

New / Old Business:

** Zoning Report – John issued three permits; reported that Ann Dropps will be sending an Application for a Hearing before the Brunswick Township Board of Appeals/Adjustments


**Roads – Motion by Jeff; seconded by Peter to hire Brian Rootkie to mow the road ditches one time. Motion carried (3-0)
