

**Brunswick Township Approved Meeting Minutes**  
**Monday - July 11, 2022**

**Call to Order:** Chair Rick Kawalek called the meeting of the Brunswick Board of Supervisors to order at 6:00 PM. The following were in attendance: Supervisors, Rick Kawalek, Peter Gravich, Jeff Akkerman; Clerk, Gladys Nelson; Treasurer, Shari Hartog; Zoning Administrator, John Teichroew.

**\*\*\*Zoning:** John reported issuing 1 land use permit. John reported that Brian Swanson did not put in a metal culvert; the Supervisors advised John to ask Brian to remove current one and replace with metal. Motion by Jeff; seconded by Rick to set the fee for a sign permit at \$ 40.00. Motion carried. (3)


**\*\*\*Roads:** The Clerk to consult with Richard Hass on road damages from the May 30<sup>th</sup> rain. All extra charges related to storm damage is to be submitted to FEMA for potential reimbursement.

**\*\*\*Misc.:** Jeff reported that the replacement of the Town Hall ramp to begin about August 15<sup>th</sup>. A motion by Peter; seconded by Rick approve Resolution 2022-003 in regards to Election Judges and their training and wages. (3) Motion by Rick; seconded by Jeff if MAT Attorney Fenske does not get a settlement with the Ron Peterson issue, the Board approves to mail Attorney Hofstad the information. Motion carried. (3)


Peter met with the landowners at 1677 – 130<sup>th</sup> Avenue & determined the fence in place was OK.
