Statement of Evidence:

SOUTH QUARTER CORNER SECTION 34, T. 43 N., R. 23 W., 4th P.M.

1865 U.S. Deputy Surveyor Ablion Barnard conducted the original government survey. A wood post was set to mark the corner.

1990 Aitkin County Survey Technician Tracy Fairchild conducted a survey on the south line of Williams township. A corner search turned up no evidence of a monument or witness trees. The corner was computed using proportionate measurement between the southwest corner of section 33 and the southeast corner of section 34. A monument was set and accepted as correct perpetuation of the corners location. The following witness trees were marked:

- 7" Ash N. 38 degrees E. 30.45'
- 14" Aspen N. 71 degrees W. 19.01'
- 12" Burr Oak S. 27 degrees W. 22.94'
