Statement of Evidence:

In October of 1851, Deputy Surveyor John Gay set a post to mark the East Quarter Corner of Section 27, Township 42 North, Range 23 West, 4th Principal Meridian.

Reference ties were taken to:

11 inch Sugar at North 49 degrees West a distance of 39 links

12 inch Elm at North 84 degrees East a distance of 9 links

All of the original Government corner evidence was searched for. None was found.

1914— A Supervisor's Township Road Order was filed in the Office of the County Auditor opening a town road along the east line of Section 27. A survey of the road by T.B. Vickery was attached to the road order. Vickery lists a distance of 78.69 chains along the east line of Section 27, but gives no information of the East Quarter corner of Section 27. (I measured about 88 feet shorter than Vickery along the East line of Section 27.)

In May 2017, a survey was made around Section 27, Township 42 North, Range 23 West, 4th Principal Meridian for Dan Plattner to locate existing monuments, lines of occupation and establish search areas.

On 5/23/2017 I made a search for the corner using a metal locator at three locations. The first was at the centerline of the old road bed, halfway between the Northeast and Southeast corners of Section 27. The second was approximately 80 feet north of the first position at an occupation line. The third was at Vickery's proportioned distance across the east lines of Sections 27 and 34 (approximately 36 feet south of the first position). No evidence of the corner was found. I did not make any excavations at any of these locations for fear of destroying the underlying road bed. There is quite a bit of evidence of road excavation, filling, and cutting in this area. Any evidence of the original corner would have been destroyed by construction of the road.

On 5/24/2017 I set a 7/8" x 20" Rebar with Aluminum Cap at the centerline of the old road bed and halfway between the Northeast and Southeast corners of Section 27. Established reference ties and assigned Kanabec County Coordinates.

This location was determined to be the best available evidence of the original corner location.
