Statement of Evidence:

In October of 1851, Deputy Surveyor John Gay set a post to mark the East Quarter Corner of Section 28, Township 42 North, Range 23 West, 4th Principal Meridian.

Reference ties were taken to:

6 inch Maple at South 83 degrees East a distance of 38 links 14 inch Balsam at North 75 degrees West a distance of 38 links

All of the original Government corner evidence was searched for. None was found.

There is no resurvey information on file for this corner.

In May 2017, a survey was made around Section 27, Township 42 North, Range 23 West, 4th Principal Meridian for Dan Plattner to locate existing monuments, lines of occupation and establish search areas.

On 5/23/2017 I made a search for the corner using a metal locator and by probing with a machete halfway and on—line between the Northeast and Southeast corners of Section 28. No evidence of the corner was found. I set a 7/8" x 36" Rebar with Aluminum Cap on—line and halfway between the Northeast and Southeast corners of Section 28. Established reference ties and assigned Kanabec County Coordinates.

This location was determined to be the best available evidence of the original corner location.
