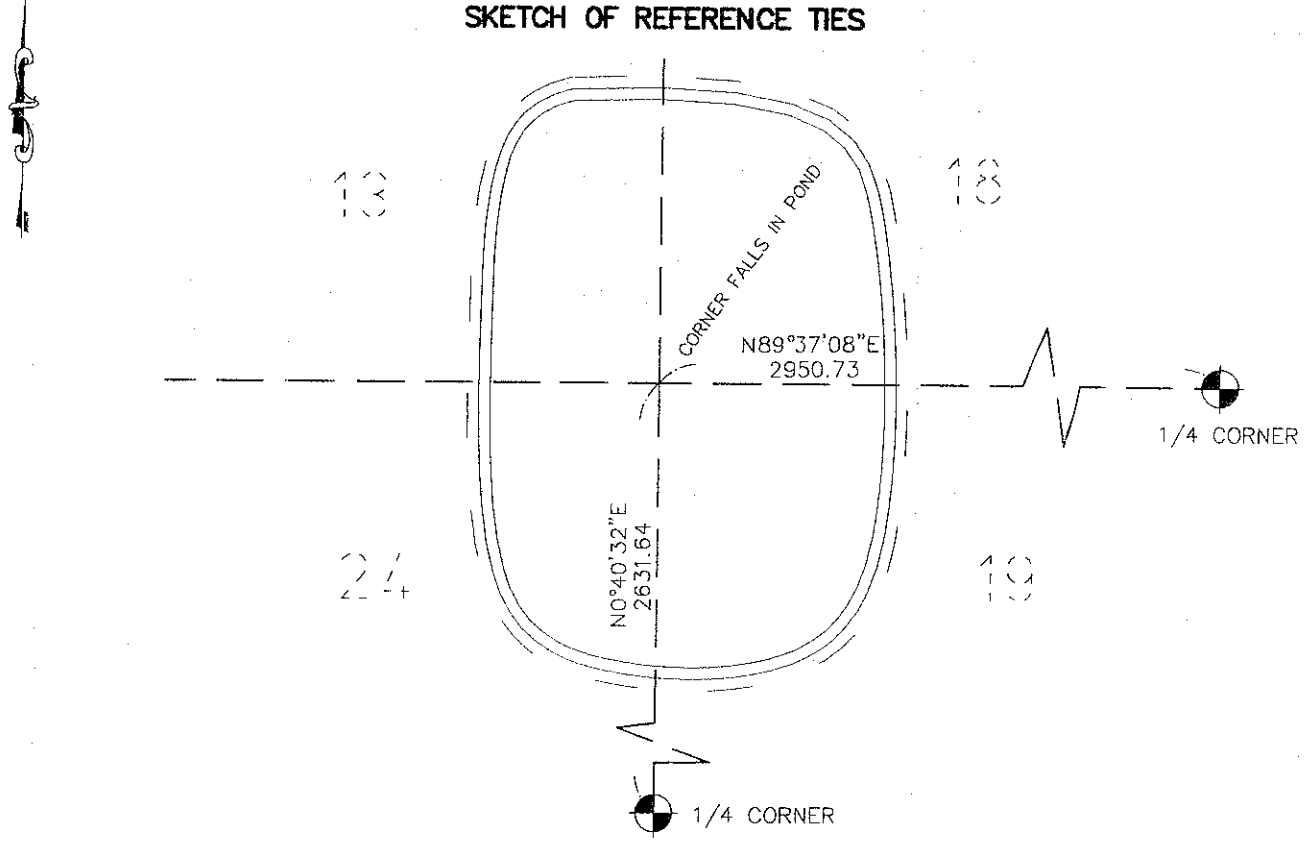

STATEMENT OF EVIDENCE

THE ORIGINAL CORNER WAS SET BY DEPUTY SURVEYOR ISAAC BANKER ON OCTOBER 4TH 1849 IN A TAMARACK SWAMP.

NO RECORDS OF ANY SUBSEQUENT SURVEYS COULD BE FOUND AT THE KANABEC COUNTY COURT HOUSE.

TODAY THIS CORNER FALLS IN A POND SO ANY PHYSICAL EVIDENCE IS NOT PRACTICAL TO FIND.

IN 1981 M.B. RUDE SET A THEORETICAL LOCATION ON THIS CORNER TO SET THE NORTH QUARTER OF SEC. 24, T.41, R.24.

IN MARCH, 2009 E.G. RUD AND SONS RAN A SURVEY AROUND SECTION 19, T.41, R.23 AND SECTION 24, T.41, R.24 TO LOCATE EXISTING MONUMENTATION AND LINES OF OCCUPATION. THE LINES OF OCCUPATION AND GOVERNMENT MEASUREMENT TO EDGE OF SWAMP AGREE VERY FAVORABLY WITH M.B. RUDE'S THEORETICAL LOCATION. THEREFORE THIS LOCATION WAS ACCEPTED AS THE BEST EVIDENCE TO USE AS THE CORNER.

KANABEC COUNTY COORDINATES WERE COMPUTED ON THIS LOCATION AND TIED INTO EXISTING GOVERNMENT CORNERS.
