



Statement of Evidence:

In October of 1851, Deputy Surveyor John Gay set a post to mark the North Quarter Corner of Section 7, Township 41 North, Range 23 West, 4th Principal Meridian.

Reference ties were taken to:

5 inch Tamarack at South 42 degrees West a distance of 3 links

7 inch Tamarack at North 17 degrees East a distance of 25 links

All of the original Government corner evidence was searched for. None was found.

1907— T.B. Vickery surveyed the Plan of Warman, recorded at the County Recorder's Office. The plat shows a stone monument at the Southeast corner of Section 6 and a stone monument 578 feet west of the Southeast corner of Section 6. In March of 2017 I made a search for the stone at the southwest corner of the plat of Warman. This corner falls near an old east-west fence line. We found many stones, but none with any markings.

In March 2017, a survey was made around Section 7, Township 41 North, Range 23 West, 4th Principal Meridian for Tom Aiels to locate existing monuments, lines of occupation and establish search areas.

On 3/6/2017 I made a search with a metal locator at the lost position between the Northeast and Northwest corners of Section 7. I found a 1/2" iron pipe with Aluminum Cap within 1 foot of the lost position. I called former County Surveyor Ernie Rud and he stated that his company had set the corner. I accepted the 1/2" iron pipe with Aluminum Cap set by Ernie Rud as the best available evidence of the original corner location. I established reference ties and assigned Kanabec County Coordinates.
