

RESOLUTION NO. 2022-07

**A RESOLUTION ESTABLISHING A SCHEDULE OF FEES FOR
THE TOWNSHIP OF LANCASTER,
LANCASTER COUNTY, PENNSYLVANIA.**

WHEREAS, the Township of Lancaster, Lancaster County, Pennsylvania (hereinafter “Township”), incurs administrative expenses in providing services to its residents; and,

WHEREAS, the administrative expenses incurred by the township are offset by charging fees for ordinance books and maps, zoning procedures, permits, subdivision and land development fees, and charging penalties for delinquent fees under the Municipal Solid Waste Management Ordinance (Ordinance 1990-02 and 1996-05); and,

WHEREAS, the current fees and penalties do not adequately offset administrative expenses, thereby burdening both the township and its residents; and,

WHEREAS, the board wishes to update fees as follows:

Section 1. Schedule of Fees, Penalties and Other Charges. The following fees, penalties and other charges shall be imposed for their respective purposes upon all persons or any other entities whatsoever as follows:

- i. If the actual engineering and legal review cost incurred is less than the escrow/deposit account, a refund will be issued. If the escrow/deposit account is diminished below \$200.00, an additional \$500.00 deposit will be required to cover any future engineering and legal review costs. No further review or inspection will be made on the plan, subject to the escrow/deposit account, until the township receives the additional \$500.00 deposit. The township will not continue with any plan that has a negative balance in the escrow/deposit account.

Section 3. Duration. The fees as set forth in this Resolution shall continue in full force and effect until such time as an updated Fee Schedule is approved by Resolution of the Township of Lancaster.

Section 4. Limitation. No other part of any Lancaster Township Resolution or Ordinance is intended to be repealed, amended, modified or changed in any way by this Resolution, except as provided herein.

Section 5. Repeal of Inconsistent Resolutions. Any Resolution or any part of any Resolution conflicting with the terms of this Resolution, shall be and the same is hereby repealed to the extent of such conflict.


Section 6. Validity. The provisions of this Resolution are severable, and if any chapter, article, section, sentence, clause, part or provision thereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining chapters, articles, sections, sentences, clauses, parts or provisions of this Resolution. It is hereby declared to be the intent of this Board that this Resolution would have been adopted if such illegal, invalid or unconstitutional chapter, article, section, sentence, clause, part or provision had not been included herein.

Section 7. Effective Date. This Resolution and the fee schedule set forth herein shall be effective five days from the enactment hereof.


