

**TOWN OF LANESBOROUGH**  
**HEAVY EQUIPMENT USE / TEMPORARY ACCESS ANNUAL LICENSE**

Pursuant to its authority, including but not limited to powers conferred under G.L. c. 40, §22, and in order to protect and ensure public safety on its public roads and appurtenant easements and right-of-ways, and in order to secure assurances from operators whose use of said roads, easements and right-of-ways, exposes the Town to risk of damage and repairs above and beyond usual maintenance associated with average vehicle use, the Town of Lanesborough acting by and through its Board of Selectmen, requires operators of heavy equipment seeking temporary access over the Town's roads, easements and right-of-ways, to apply for and obtain this Heavy Equipment Use Temporary Access License annually. Heavy equipment includes vehicles and machinery typically used in construction and/or excavation operations, whether self-propelled or relying upon the use of other vehicles for mobility. Operation of such heavy equipment on Town roads, easements and right-of-ways without a current Heavy Equipment Use Temporary Access License from the Town is strictly prohibited. ***A copy of the approved license must be available at all job sites. Failure to have approved licenses on-site may result in a temporary shutdown of the project and a possible fine of \$100.00. This License expires on December 31<sup>st</sup> of the year of issuance and needs to be renewed annually.***

FURTHER, I AGREE THAT AS A CONDITION OF THIS LICENSE FOR USE OF HEAVY EQUIPMENT/TEMPORARY ACCESS THAT IF THE TOWN OF LANESBOROUGH, MASSACHUSETTS 1.) SUFFERS ANY LOSS, COST, DAMAGE OR EXPENSE OR 2.) IS SUBJECTED TO ANY CLAIM, SUIT, OR DEMAND, OR 3.) LOSES THE USE OF ANY TOWN PROPERTY (INCLUDING INFRASTRUCTURE AND UTILITIES) RESULTING FROM MY USE OF HEAVY EQUIPMENT AND/OR TEMPORARY ACCESS (1-3 COLLECTVELY "COSTS"), I HEREBY PERMIT THE TOWN TO ACCESS THE BOND AS PROVIDED UPON WRITTEN NOTICE TO ME OF THE AMOUNT REASONABLY ANTICIPATED TO MAKE THE TOWN WHOLE FOR THE COSTS. I ACKNOWLEDGE THAT THE TOWN'S ACCESS OF BOND FUNDS DOES NOT SERVE AS A WAIVER OF ANY RIGHT OTHERWISE RESERVED BY THE TOWN TO SEEK REIMBURSEMENT FOR COSTS. I HEREBY ACCEPT THE CONDITIONS OF THIS LICENSE AND AGREE TO CONFORM STRICTLY TO THE TERMS THEREOF. I ENCLOSE THE REQUIRED **LICENSE FEE OF \$25.00.
