**ENTERTAINMENT LICENSE APPLICATION**

(M.G.L. Chapter 140 § 181)

Instructions:

1. Fee in the amount of \$25 per day or \$100 annually must accompany this application.
2. If the applicant does not own the premises, submit a letter from the owner granting permission for purposed use or copy of the lease.
3. Applicant must be approved by all departments listed on the bottom of this application

**INCLUSIVE: SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS**

1. That \_\_\_\_\_ shall be the responsible head and director of the licensed entertainment for and on behalf of the licensee.
2. That adequate provision be made for the protection, safety and security of all persons, whether patrons or otherwise, on or about the grounds and adjacent thereto.
3. That all mechanical equipment or devices of every description, particularly, but not solely, ferris wheels, merry-go-rounds, swings, and similar equipment, shall be covered at all times by a policy or policies of liability insurance in sums adequate for the protection of passengers, patrons, specters, attendants, visitors or any other person or persons on or about the grounds. **Such policy or policies shall be deposited with the Town of Lanesborough at the time of the issuance of this license, and this license shall be limited to such mechanical equipment or devises covered by such policies.**
4. That no unreasonable sounds of noises shall result from such lawn-party; and the peace and quietness of the neighborhood of grounds shall not be disturbed unduly.
5. That all entertainment and operations shall terminate each evening at such hour to be fixed by the Chief of Police.
6. That nothing contained in this license shall authorize or permit any work, entertainment or operation on Sunday.
7. That upon the completion or termination of the entertainment authorized by this license all debris and refuse shall be removed from the grounds.
8. That this license is granted subject to all existing laws, statutes, and ordinances, and subject to all and any rules, regulations and orders of the Police Department and Fire Department of the Town of Lanesborough; and nothing contained herein shall be construed to authorize or permit the discharge of any firearms, gambling of any nature, or the violation of any law.
9. That this license may be revoked at any time by the Police Department or the Board of Selectmen.
