Chairman Zender called the meeting to order at approximately 10:30 a.m. in Room 302 of the County Complex.

#### **MINUTES**

The minutes from May 11, 2023 were briefly reviewed and discussed.

Motion by Knisley, supported by Bustle, to approve the minutes from the May 11, 2023 meeting of the Properties Committee meeting as presented. Motion carried unanimously.

# **NEW/GENERAL ITEMS**

BUILDING & GROUNDS- Request to approve construction on 264 Cedar St to house ACT Program

CMH- Discussion for a new building to house the Stepping Stone and Case Management Program

PARKS- Discussion on a name for Torzewski Disc Golf Course

#### **BUILDING & GROUNDS**

Request to approve the construction on 264 Cedar St. to house ACT Program. Discussion on construction included making office space, the bathroom handicap accessible, replacing ceiling tile, adding a countertop and sink, and enclosing the entry to create a lobby for safety purposes. Discussed the need for the fiber network, which would allow a hardline access to the secure CMH network.

1. Motion by Knisley, supported by Kohlman, to recommend to the Full Board to approve the construction on 264 Cedar St. for CMH to house ACT Program at a cost not to exceed \$50,000.00 to be paid for by CMH funding, at no additional cost to the County's General Fund. Motion carried.

#### **CMH**

Lauren Emmons discussed plans for a new building to house the Stepping Stone and Case management program. Programs are currently housed at Maple Grove and there are concerns with the continuating need for maintenance to the building. Discussion about how much space would be needed and how to accommodate additional space in the future. Emmons discussed needing biddable plans to be drawn up for design and architectural purposes. Emmons did give an update that all CMH vans are back from GLTA. Emmons discussed other CMH leases for their group homes.

2. Motion by Kohlman, supported by Bustle, to recommend to the Full Board to approve CMH to receive architectural designs at a cost not to exceed \$5,000.00 to be paid for by CMH funding, at no additional cost to the County's General Fund. Motion carried.

#### **PARKS**

Discussion on possible park names for the new Disc Golf Course at Torzewski. The company is ready to move forward with signage and needs a name. Several names were submitted and discussed. The discussion for signage for the parks continued due to the lack of signage on the roads directing people to the park. Bustle shared that there was previously a discussion with the Road Commission, however, the information and pricing would need to be updated. Zender requested a follow up for the next properties meeting.

3. Motion by Bustle, supported by Kohlman, to recommend to the Full Board to approve "Torzewski Twisted Greens" as the name for the new disc golf course at Torzewski County Park. Motion carried.
