1. A non-refundable deposit fee of \$50.00 is required to reserve the Historic Courthouse.
2. A cleaning deposit of \$100.00 is also required, which will be refunded if no cleanup costs are incurred, or I may choose to use the \$100.00 to purchase a brick in honor of our wedding.
3. The cost of renting the Historic Courthouse is \$100.00 per hour for a 2 hour minimum – this includes the \$50.00 deposit fee as stated above.
4. County property must be left in the same condition as found.
5. I must provide my own Magistrate or Minister to perform the ceremony.

COUNTY DEPARTMENT OF BUILDING AND GROUNDS, OR BY THIRD PARTIES, OR BY
THE AGENTS, SERVANTS, EMPLOYEES, OR FACTORS OF ANY OF THEM.
