SUBJECT: Swimming pools

Introduction

What prompted this discussion?

- In the past few months, residents have inquired about the erection or installation of swimming pools. The city regulates swimming pools in Section 5.14 of the Zoning Ordinance and Section 14 of the Municipal Code.
- The Building Official has determined that the standards contained in the municipal code only permit in-ground pools and that above-ground pools are prohibited.
- Staff is interested in the perspective of the Planning Commission as to whether above-ground pools should be permitted in the city and whether any ordianness should be amended for clarification.

Current Language

What do the Ordinances say?

Zoning: Section 5.14 Swimming Pools. Swimming pools are permitted in all residential districts, subject to the following:

- A. Requirement for Fence: A fence or similar enclosure shall be erected and maintained around any swimming pool. Such fence or enclosure shall be approved by the Building Department in conformance with the city's Building Code.
- B. Setback: Swimming pools, spas, hot tubs, similar facilities and surrounding decks, walks or similar accessories shall be at least fifteen (15) feet from any lot line.
- C. Restriction from front yard: Swimming pools, spas, hot tubs and similar devices shall not be located in any front yard. Accessory private swimming pools are permitted in the single-family residential districts provided that they are located in the rear yard and meet the requirements herein.

Municipal Code: Section 14-184 regulates placement and elevation of swimming pools as follows:

- (a) All outdoor swimming pools shall be located so as to comply with the city's zoning ordinance.
- (b) The apron of the swimming pool, which is the hard-surfaced area at ground level adjacent to and surrounding the pool, shall not be higher than the grade level line of the premises, and in no event shall it be constructed so that water therefrom shall flow onto adjacent lots or any adjacent right-of-way.

I've managed Ferndales program for years and can get you some info when I'm in the office next.

It is a long process with public hearings before and after construction.

We have written a software program for running Ferndales program on GIS which prepares and addresses residents estimated costs and final costs. Sends letters (we still need to mail them) and information to the affected residents. Etc, etc.

To start, we mark each flag of sidewalk to be replaced or horizontally sawcut (these are stunners cut for ADA compliance) and reference the work to each address.

In order to place on the winter tax rolls, the final public hearing to approve the roll is required around the middle of October.

There's a lot more too it but the above is a start.

Honestly, our fees are quite high in comparison to other projects based on a percentage of construction but it's a lot of work. FERNDALE used to add all our fees to the residents but not just 10% of the cost and they pay the remaining cost.

FERNDALE also pays for sidewalks damaged due tot a City tree (damage caused by a tree located in the right of way). They get a lot of complaints about paying for sidewalk repairs due to City trees and a lot of them tell the city to cut down the trees which as you know doesn't go over very well.

The City completed an inspection of sidewalks in your area for the purpose of insuring that all sidewalks are in compliance with City Ordinance Chapter 62. Article 2 Div. 3 Section 62-121-62-124. The present program is the same as all past sidewalk replacement programs.

The sidewalk abutting your property has been inspected and found to be in need of replacement. The sections, or "flags" of sidewalk marked with an **(X)** are those which are in need of replacement. Based on measurements taken by the sidewalk inspector, you have $\frac{\text{«M 4}}{\text{ s}}$ square feet of 4" and $\frac{\text{«M 6}}{\text{ s}}$ square feet of 6" sidewalk in need of replacement.

Sidewalk replacement cost provided by the City contractor - Passalacqua Construction, Inc. @ (734) 782-9353 are: \$2.75 per square foot of 4" concrete

\$3.50 per square foot of 6" concrete

(A typical 5x5 flag would cost approximately \$68.75 for 4" and \$87.50 for 6" to replace.) Based on the square footage amounts, the cost of the replacement work is estimated at \$ "Total".

If you wish to have the City contractor perform the work, please sign, date and return the attached authorization form to the City within 10 days. If we fail to hear from you within 10 days, the City shall perform the required work and bill accordingly.

Please note that pursuant to our Ordinance you are <u>not</u> required to utilize the City's contractor to make repairs to the marked sections of your sidewalk. You have the <u>option</u> of having the sidewalk replaced/repaired by **1.** Yourself, or **2.** By a contractor of your choice. If you choose either of these options, a permit must be obtained from the City prior to the start of the work AND work must be completed within 20 days. **There is a minimum \$10.00 fee for sidewalk permits.**

If you choose to replace the sidewalk yourself or hire your own independent contractor, please notify Customer Service Coordinator, Allison Dawson, via e-mail Adawsonlv@comcast.net, fax 248.557.2602, or by written correspondence on or before August 31, 2006 (absolutely no voice mail option accepted). September 1, 2006, the City will proceed with the replacement. Please remember - permits are required for sidewalk replacement. Thank you for your cooperation. Please feel free to call us with any questions.

All unsafe sidewalks, as determined by the following established criteria, must be replaced.

- 1. Differential elevation that exceeds 3/4".
- 2. Flags that will move if adjacent flag(s) are removed.
- 3. Holes that could be considered a trip hazard.

***PLEASE NOTE: As part of the sidewalk replacement process, some lawn damage may occur. The contractor is responsible for restoration of all damaged areas prior to receiving payment from the City.

Horizontal sawcutting is assessed at \$80.30 per sidewalk joint.

Your special assessment will be billed on your December tax bill, payable without penalty through February 14, 2020 or you may pay your assessment at City Hall, 300 East Nine Mile, Ferndale, MI 48220 through Thursday, November 16th, 2019. (Note: If you plan to sell your property, you must inform the buyer of the special assessment). Please note that if you are a non-profit and do not receive a tax bill, you are still required to pay your assessment at City Hall by November 16th, 2019.

A public hearing will be held in the City Hall Council Chambers, 300 East Nine Mile, on Tuesday, November 12th, 2019 at 7:00 p.m. to confirm your assessment on the Special Assessment Roll.

If you object to your assessment, you or your representative must appear at the public hearing, or you may file a written objection with the City Clerk at City Hall, 300 East Nine Mile, Ferndale, MI 48220 by noon, Thursday, November 7th, 2019. If your objection is not resolved, you may appeal it to the Michigan Tax Tribunal, P.O. Box 30232, Lansing, MI 48909, within 30 days after the Special Assessment Roll is confirmed.

Hardship and Deferment

If your assessment is \$500 or more and if your annual household income is \$20,000 or less; or if your property is a corner lot whose cost of sidewalk replacement for the side portion is \$500 or more regardless of your household income, you may meet with the city's Sidewalk Hardship Committee to request additional time to pay at 5% interest.





If you do not meet these guidelines but believe that your special assessment would cause a hardship, you may still meet with the Committee. To do so, please call the Department of Public Works at (248) 546-2514 or submit a letter addressed to the Sidewalk Hardship Committee at 521 East Cambourne, Ferndale, MI 48220 by 4:00 p.m. Thursday, November 7th, 2019. The Committee will meet at City Hall, 300 East Nine Mile, on Tuesday, November 12th, 2019 at 6:00 p.m. You will need to appear at that meeting and bring proof of your household income, such as your 2018 income-tax return, statement of annual social-security income, etc.

Finally, a state law entitled "Deferment of Special Assessment on Homesteads" allows persons who have been state residents for at least five years and who are age 65 or older or who are totally and permanently disabled to defer a special assessment if it is more than \$300. You can pick up the Michigan Department of Treasury Form 2748 from City Hall, or on-line at https://www.michigan.gov/documents/2748f 2630 7.pdf, if you think you qualify for this deferment. Return your Form 2748 to City Hall and it will be submitted to Oakland County Equalization Division to determine your eligibility. You will hear directly from Oakland County if you qualify. For further information, call Oakland County at (248) 858-0776.

SUMMARY AND BACKGROUND:

Some 9,302 square feet of sidewalk (372 flags) were replaced and 10 joints were horizontally saw cut in Special Assessment Sidewalk District 2019 (Woodward Heights to East 10 Mile, Hilton Rd. to Lennox; and West Nine Mile to Oakridge, Hyland to Woodward Ave) at a total cost of \$53,149.97; construction of \$48,318.16 and engineering / administration of \$4,831.81. The following is a breakdown of the proposed per-sidewalk-square assessment.

If your assessment is \$500 or more and if your annual household income is \$20,000 or less; or if your property is a corner lot whose cost of sidewalk replacement for the side portion is \$500 or more regardless of your household income, you may meet with the city's Sidewalk Hardship Committee to request additional time to pay at 5% interest.





If you do not meet these guidelines but believe that your special assessment would cause a hardship, you may still meet with the Committee. To do so, please call the Department of Public Works at (248) 546-2514 or submit a letter addressed to the Sidewalk Hardship Committee at 521 East Cambourne, Ferndale, MI 48220 by 4:00 p.m. Thursday, November 7th, 2019. The Committee will meet at City Hall, 300 East Nine Mile, on Tuesday, November 12th, 2019 at 6:00 p.m. You will need to appear at that meeting and bring proof of your household income, such as your 2018 income-tax return, statement of annual social-security income, etc.

Finally, a state law entitled "Deferment of Special Assessment on Homesteads" allows persons who have been state residents for at least five years and who are age 65 or older or who are totally and permanently disabled to defer a special assessment if it is more than \$300. You can pick up the Michigan Department of Treasury Form 2748 from City Hall, or on-line at https://www.michigan.gov/documents/2748f 2630 7.pdf, if you think you qualify for this deferment. Return your Form 2748 to City Hall and it will be submitted to Oakland County Equalization Division to determine your eligibility. You will hear directly from Oakland County if you qualify. For further information, call Oakland County at (248) 858-0776.

Dear Property Owner:

Your sidewalk squares (flags) have been inspected as part of our City of Ferndale Sidewalk Replacement Program. This citywide program evaluates sidewalks annually by district with the goal of replacing aging or degrading squares to create safe conditions and reduce the likelihood of slip-and-fall accidents.

The 2019 district includes properties located in the area from Woodward Heights to 10 Mile, Hilton Rd. to Lennox; and West Nine Mile to Oakridge, Hyland to Woodward Ave. Enclosed is the copy of your inspection report sheet outlining the sidewalk squares on your property that need to be replaced and the reasons why. Replacement of these squares is required; your options for replacement are detailed below.

Work Performed by City of Ferndale

The City of Ferndale (via an authorized contractor) will perform the work for the cost of \$132.75 per average $5' \times 5'$, 4-inch-thick square, and \$160.25 per 6-inch-thick square. Stubbers/trip hazards at sidewalk joints that have one inch or less vertical separation, and no other defects, will be horizontally sawcut for \$80.30 per joint.

Your inspection report lists estimated quantities. Final quantities will be determined by field measurements during construction. For instance, your inspection report may estimate 25 square feet of 4-inch sidewalk, while the construction inspection may find 27.5 square feet. You will be assessed based on actual quantities at the contractor's unit prices.

In some cases, additional work may be necessary. For example, if roots of a tree need to be removed for sidewalk construction, the city-estimated assessment is \$29.70 per tree. Likewise, business owners may require 8-inch-thick concrete (\$7.70/sq. ft.) for truck traffic or early-strength concrete (\$8.09/sq. ft.), which typically closes a driveway for only three days in lieu of five. Business owners requesting early-strength concrete should contact the engineer, Scott Ringler at 248-852-3100 (ext. 280).

Your final assessment will be mailed after all construction is completed and will be billed on your 2019 winter tax. Note: If you plan on selling your property beforehand, you must notify the buyer of the pending assessment.

Work Performed Yourself/Via Personal Contractor

You may hire a contractor or, if you have experience, do it yourself. Either way, you must notify the engineer, Scott Ringler, at 248-852-3100 (ext. 280) or sringler@giffelswebster.com. You or your contractor must apply for a building permit at the Building Department in the upper level of City Hall, 300 East Nine Mile Rd., by July 15, 2019. Note: Patching a deteriorated sidewalk is not long-term, so we cannot approve it as an alternative.



Hardship

If your special assessment is \$500 or more and your annual household income is \$20,000 or less, or if your property is a residential corner lot whose cost of sidewalk replacement for the side portion is \$500 or more (regardless of household income), you may meet with our Hardship Committee to request additional time to pay at 5% interest. If you do not meet the above guidelines but feel your special assessment would cause a hardship, you may still meet with the Hardship Committee. Information on how and when to meet with the committee will be mailed later this fall.

Additionally, a state law entitled "Deferment of Special Assessment on Homesteads" allows persons who have been state residents for at least five years and who are age 65 or older or permanently disabled to defer a special assessment if more than \$300.
