Eaves on picnic shelter is in need of repair. Pam Bratschi said she has called for repair of barbeque grill but the contractors did not show up because it's a small project.

Sean Kammer said he is in contact with MDOT regarding the fencing issue. The contractor for the condominium development had issue with an unanticipated sewer line issue. They had to rely on DTE to come out to move electrical wiring which took months for DTE to respond. Works has resumed on the project.

Bruce Copus, 28050 Woodworth Way – website is not good. In favor of Scott Mckee being Chief of Police and Pamela Bratschi as City Administrator. Gave an overview and asked questions regarding the budget, major streets/local streets. Asked why the fund balance being used. Mayor Brock said that most of the Evergreen Road project will use the major street. Using General fund budget to complete the local street funding.

Deborah Hoatlin-Dunn, 27440 Lathrup Blvd., said 11 mile/696 is missing a "no left turn sign" afraid there may be an accident. She asked, is defaming a Council member free speech? Scott Baker said free speech does not come with guidelines and the public can speak on anything that they wish.
