## ZBA-17-09Consideration of a Motion to Approve/Deny the Zoning VarianceRequest for 26237 Southfield Road

David Yoon, applicant gave an overview.

Mr. Quinn said the sign Ordinance only allow signs on walls for businesses. The hardship is because the way the roof overhangs over the wall there is no space to put a sign. The applicant is requesting that the sign be placed on the roof as is the next door business. The sign is 10'x 3',

therefore, the Zoning Board of Appeals has to determine if this is a sufficient hardship to allow the sign on the roof. The fact that he cannot have a visible sign on the wall.
