#### PROPOSED CONSTITUTIONAL AMENDMENT A:

The adoption of this amendment would separate real property into its own class of property for purposes of property tax assessments. The amendment would authorize the legislature to create a subclass of owner occupied primary residences.

## **LODGING TAX OPTION:**

Shall the City of Kemmerer, Lincoln County, State of Wyoming, continue to impose an additional 2% lodging tax upon the sales price paid for lodging services for the primary purpose of promoting local travel and tourism? This tax will be imposed for four (4) years.

Shall the Town of Diamondville continue to impose an additional 2% lodging tax upon the sales price paid for lodging services, the primary purpose of which is for the promotion of local travel and tourism? This tax will be imposed for four (4) years.

Shall the Town of Cokeville continue to impose an additional 2% sales tax upon the sales price paid for lodging services, the primary purpose of which is for the promotion of local travel and tourism? This tax will be imposed for four (4) years.

Shall the Star Valley Ranch Town Council, Governing Body for the Town of Star Valley Ranch, be authorized to enact a two percent (2%) lodging tax imposed on hotels, motels, campgrounds, dude ranches, bed and breakfasts, and similar establishments providing quarters or space for transient guests for the primary purpose of promoting travel and tourism in the Town of Star Valley Ranch? This tax will be imposed for four (4) years.

#### MILL LEVY OPTION:

Shall the South Lincoln Hospital District increase the District's Mill Levy from the current (4) mills to (6) mills to continue to provide funding to support the South Lincoln Hospital, Nursing Center, and Emergency Ambulance Services? This tax will be imposed for four (4) years.

## SPECIFIC PURPOSE ONE PERCENT (1%) SALES AND USE TAX:

Shall Lincoln County, Wyoming, be authorized to adopt and cause to be imposed a one percent (1%) specific purpose sales and use excise tax within the County, the proceeds from which and the interest earned theron to be used and applied for funding acquisition of land (if necessary), the planning, engineering, constructing, remodeling, furnishing, equipping and supplying; and, to the extent allowed by law, the payment of operation and maintenance, debt service, federal and/or state grant funds or revenue streams as leverage or a match and/or or lease payments, in the following specific principal amounts for the following specific purposes:

For the following Projects in the amount of \$23,354,078 and interest earned theron:

1. \$4,000,000 to the Town of Afton for Canyon View Park improvements n the south side to include a new Bathroom, Pickleball Courts, and All Abilities outdoor playground space;

- 2. \$1,665,000 to the Town of Alpine for the Palisades Riverwalk Feasibility and Design Project, Alpine Greenbelt Pathway Design and Construction Project, and Alpine Civic Center Backup Power Project.
- 3. \$3,833,727 to the Town of Cokeville to Repave West Main Street and Collette Street, build a new ADA-accessible bathroom for Town Park, and replace the Main Water Line East from Highway 30 to well number 3 and the water line from Main Street north along Highway 30 to city limits.
- 4. \$1,155,175 to the Town of Diamondville for the Town of Diamondville road resurface, repairs, and improvements to West Lincoln Street, Susie Ave, and W Hillcrest Ave. Replace a Truck Sander (Material spreader) for winter road maintenance.
- 5. \$4,483,238 to the City of Kemmerer street/road projects as follows: 1) Repaving and rehabilitation of the following streets and roads: Elk Street (5th West Ave. to Canyon Road); Berry Drive (9th West Ave. and South to Del Rio Dr.); Canyon Road (Del Rio Dr. N. to Patch S. Side Antelope); Del Rio Drive (Canyon Road thru 9th West Ave. intersection); Canyon Road (Del Rio Drive South to 2016 patch); and 2) Reinforce retaining wall with Block Facing for MSE Wall on Sage Ave for safety purposes.
- 6. \$1,647,938 to the Town of LaBarge for Back-up generators for the Town Hall, Fire Hall/Clinic, and Water Treatment Plant. Replacement of non-compliant air masks (SCBA) for the fire department. A new fire engine to replace a portable rink for summer/winter entertainment for our community.
- 7. \$169,000 to the Town of Opal for Town of Opal backup power for the water system, including the Town Hall, and upgrade backup power for the wastewater system;
- 8. \$3,300,000 to the Town of Star Valley Ranch for Walking Paths that lead to forest trails, development of Town commons, and pavement of major arterial roads within the Town of Star Valley Ranch.
- 9. \$3,100,000 to the Town of Thayne for Sports Complex (Indoor pickleball Courts, Indoor Soccer Fields, Office, Kids play area, and other recreation facilities)

#### **CAMPAIGN FILING REQUIREMENTS**

October 29, 2024 - Candidates, candidate committees, PAC's are required to file a report before each election. General Election Statement of Contributions and Expenditures due. EVERY candidate, whether successful or not, must file a campaign report.

This includes candidates who neither receive nor spend any money during the campaign. Candidates, committees, PACs etc. who fail to file the required report within the the stipulated time are subject to civil and other penalties. Any person who fails to file a report within the time required shall have their name printed on a list drafted by the appropriate filing office that will be made available to the public. In addition, that person has twenty-one (21) days from the date of notice to comply or be subject to civil penalties of \$500 for failure to file a report with the secretary of state and \$200 for failure to file a report with the county clerk. If you require assistance to vote by reason of blindness, disability or inability to read or write, you may be given assistance by a person of your choice (other than the elector's employer or an agent of that employer or an officer or agent of the elector's union). If you have questions regarding the accessibility of your polling place, please contact the County Clerk's Office.
