Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on March 20, 2018 in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

8. Board of Finance-Beverly Calaway Treasurer

Beverly Calaway, County Treasurer directed the Board of Finance's attention to the Treasurer's Financial Report for the month ending February 28, 2017. Ms. Calaway stated the beginning cash balance for Fiscal Year 2017-2018 was \$10,851,309.72.

Ms. Calaway stated the Property Tax Division Title Examiners would not research properties in Lincoln County until late summer. Ms. Calaway stated this delay would affect the County's delinquent tax balance and the delinquent property tax sale would not occur during the 2017-2018 Fiscal Year. Ms. Calaway informed the County Treasurers office mailed out 10,109 property tax reminder notices. Ms. Calaway stated property taxes were due April 10, 2018 and delinquent on May 10, 2018.

Ms. Calaway noted the interest earned on investments reflected the increased rates nationwide. Ms. Calaway stated she continued to work with local banks to seek the best return possible subject to the requirement of 102% collateralization.

Ms. Calaway reported the Lincoln County Medical Center General Obligation Bond fund held with the New Mexico Finance Authority contained \$21,057,811.39 in the program fund and \$617,020.04 in the debt service fund. Ms. Calaway informed the total cash held by the Lincoln County Treasurer as of February 28, 2018 was \$47,616,422.64. Ms. Calaway further stated the Tax Schedule Maintenance Report as of February 28, 2018 reflected a collection rate of 70% of the 2017 property taxes billed.

9. Forest, Land & Natural Resources Matters:

a. Fort Stanton and Lincoln Historic Sites

Tim Roberts, Regional Manager stated he was pleased with the outcome of the State Budget. Mr. Roberts informed the non-recurring ICIP funding increased for this year. Mr. Roberts stated the ICIP funding included the preservation work on the Tunstall Store and the old County Courthouse in Lincoln. Mr. Roberts stated the historic site received \$20,000 for exhibits in the nurse's quarters at Fort Stanton.

Mr. Roberts stated they are in the process of hiring a plant system operator for the preservation work in Lincoln and Fort Stanton. Mr. Roberts informed they would also hire a curator, a first for Lincoln and Fort Stanton.

Mr. Roberts reported his staff finished up the Tunstall Tour on February 18, 2018 with about 50 people in attendance. Mr. Roberts reported the "Fort Stanton Live" event was scheduled for July 14, 2018. Mr. Roberts informed the Fort Stanton Historic Site planned to host horseback tours in Fort Stanton starting May 12, 2018. Mr. Roberts stated on June 23, 2018 the Lincoln Historic Site would host a San Juan Cultural Festival in conjunction with Old Lincoln Days. Mr. Roberts stated the renovated Visitors Center Exhibit Hall in Lincoln would open Thursday April 12, 2018. Mr. Roberts also reported the Wild West History Association will host a mini conference in Lincoln April 7, 2018. Mr. Roberts stated the event will host speakers related to the Lincoln County War.

b. Smokey Bear Ranger District

Jodi Canfield, District Ranger reported fire season was upon us. Ranger Canfield reported the seasonal fire personnel started this week and will spend two weeks in training.

Ranger Canfield reported the District would issue decisions to authorize three fuel reduction projects, one fuelwood project, forest wide vegetation maintenance, and one wildlife water project. Ranger Canfield stated the Lincoln National Forest completed fifteen decisions related to a forest wide vegetation treatment maintenance project. Ranger Canfield reported the District planned to post the Environmental Analysis for post fire vegetation restoration work at Ski Apache in March and anticipated project work would begin in the fall. Ranger Canfield stated the restoration work included 100 acres of the area burned by Little Bear.

Ranger Canfield commented on the ongoing restoration work of the South Fork Campground including cooperative work with the Upper Hondo Soil and Water Conservation District for oparian restoration. Ranger Canfield stated the District had also received a grant to clear the South Fork Trail up to the White Mountain Wilderness boundary.

Ranger Canfield reported the design work for a bridge at the Cedar Creek trailhead was nearing completion and they were looking for funding to procure the structure. Ranger Canfield stated they were working with the Village of Ruidoso to develop a trailhead in Perk Canyon and Upper Cedar. Ranger Canfield stated progress was made this winter with the help of Eco Servants in developing the new trail segments and anticipated completion of the work by this summer.

c. Cibola National Forest

Ms. Taylor informed the Mountainair Collaborative Committee was continuing to develop its Charter. Ms. Taylor stated the Land and Natural Resources Committee (LANDRAC) Chair Robert Barber will attend their Meeting on March 20, 2018.

d. Community Forrester-South Central Mountain Resource and Conservation District Council

Rick Merrick, Rural Community Forester with the South Central Mountain Resource Conservation and Development Council reported 70 % completion of the Lincoln County Cost Share Program. Mr. Merrick stated the 2018 New Mexico Wood Industry Summit was set for November 16, 2018. Mr. Merrick reported on the Non- Forest Land (NFL) thinning projects and stated they were currently reviewing the submitted proposals.

e. Upper Hondo Soil and Water Conservation District

Laura Johnson, Program Director stated the Upper Hondo had almost completed the rehabilitation and repair work on the Salado Dam. Ms. Johnson thanked Commissioner Allen for touring the Water Trust Board Watershed Restoration Project on the Diamond "A" Ranch on the Rio Hondo.

Ms. Johnson stated the District planned to increase funding for cost share programs for the residents in the district. Ms. Johnson stated the District had two vacancies on the Upper Hondo Soil and Water Conservation Board. Ms. Johnson stated Lela Wright and Clark Taylor were appointed to fill the vacancies.

Ms. Johnson stated the Upper Hondo applied for a grant through the New Mexico Association of Counties for wildfire risk reduction work. Ms. Johnson stated the project would focused on unit three in Ranches of Sonterra.

Ms. Johnson stated the Upper Hondo was currently working through a grant to continue treatment of thistle for private land owners. Ms. Johnson stated the Upper Hondo was also continuing the

treatment of thistle and poison hemlock in the Bonito Lake area in conjunction with the US Forest Service.

10. Lincoln County Community Health Council Update-Shannon Dictson, Chair

Shannon Dictson, Chair of the Lincoln County Community Health Council (LCCHC) presented an update on current council activities. Ms. Dictson stated the LCCHC was a collaborative effort by service providers and community members to promote health related services to the community. Ms. Dictson discussed several of the Council's projects including sponsorship of a mobile food bank; hosting the largest health fair in the area; and the production of a health and wellness guide directory of resources. Ms. Dictson stated the current priorities of LCCHC include substance abuse, youth engagement, health promotions, access to care, and family stabilization.

12. Approval 2018 National Service Recognition Day Proclamation

Ms. Taylor discussed this year's annual day of recognition for National Service is April 3, 2018. Ms Taylor stated this date was set aside to encourage residents to recognize the significance of our national services in the county.

13. 9:30 A.M.: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS (Items are for discussion only – no action will be taken)

Commissioner Stewart reported he attended Joint Land Use Study Group (JLUS) meetings beginning in 2016 including the last meeting held on March 28, 2018. Commissioner Stewart stated Lincoln County committed to \$5,000 of "in kind" matching time towards the JLUS regional planning organizational grant of \$588, 590. Commission Stewart stated he was volunteered state wide, but will not participate unless there is an agreement from the County.

Commissioner Allen reported on the tour of the Water Trust Board Watershed Restoration Project on the Diamond "A" Ranch on the Rio Hondo. Commissioner Allen also stated she attended the Spencer Theater recently and commented on what a great asset the theater was for Lincoln County.

Commissioner Draper stated he met Wayne Johnson, the newly appointed New Mexico State Auditor and spoke to him about recent audit reports in Lincoln County. Commissioner Draper stated he also met with former Ruidoso Mayor Tom Battin and current Mayor Lynn Crawford to discuss school safety. Commissioner Draper stated he was pushing for a summit to collaborate efforts in concern to school safety.

Chair Stone reported he attended the Tunstall Tour in Glencoe. Chair Stone commented on the remarkable history and heritage of Lincoln County. Chair Stone stated he attended a meeting which included representatives from the New Mexico State Police, the Lincoln County Sherriff's office, and the Ruidoso Municipal Police Department to discuss school system safety. Chair Stone commented one area of concern was the length of travel time from any law enforcement agency to Corona and Hondo Schools Districts.

Clara Farah, Creative Aging Director presented an update on current activities. Ms. Farah discussed several projects including a resource center, involvement with Region IX, and a volunteer driver program. Ms. Farah discussed the advantages of having a transportation program and the need for more volunteer divers. Ms. Farah stated they were working on obtaining insurance for the drivers and the program being used for non-emergency medical situations.

Jeff Bleau, resident of the Ranches of Sonterra expressed his concerns about the Bonito Lake sediment removal process.

Heidi Payne, resident of Fort Lone Tree Road expressed her concerns about safety issues on Fort Lone Tree Road. Ms. Payne stated belief the last time Lincoln County had maintained the road was in November of 2017. Ms. Payne stated this was a very active road and speed was a concern.

11. Budget Preparation: Procedures and Timeline - FY 2018-2019

Ms. Taylor presented a timeline of the proposed budget preparation process, a list of external agencies who routinely requested financial assistance, and also requested permission to move the Special Commission Budget Hearing from May 1, 2018 to April 26, 2018.

Ms. Taylor noted the Department of Finance and Administration required submission of the Preliminary Budget by June 1, 2018 and submission of the Final Budget no later than July 31, 2018.

Motion: Approve the timeline and budget procedures for Fiscal Year 2018-2019 as presented and move the Special Commission Meeting to April 26, 2018. Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen.

Vote: Motion carried by unanimous vote (summary: Yes = 5).

Chair Stone recessed the Regular Meeting at 9:51 AM and reconvened at 9:59 AM.

14. Update and Further Discussion Regarding New Horizons Developmental Center

Ms. Taylor reminded of prior direction to determine necessary repairs and associated costs for the County owned building inhabited by the New Horizons Developmental Center. Ms. Taylor stated she received recommended referrals for both an appraiser and an inspector. Ms. Taylor stated the appraiser agreed to commence his work once the building inspection was complete. Ms. Taylor reported the building inspection highlighted several areas which would require immediate attention. Ms. Taylor stated the principal areas of need Identified were paving the parking lot and a new roof along with a number of recommendations for the future. Ms. Taylor reminded the parking lot pavement expense was previously approved and work was scheduled for mid-April.

Ms. Taylor stated the Board of Directors of New Horizon Development Center also requested the Board of County Commissioners address three other issues including development of the new lease agreement; inclusion of a funding request for New Horizons in Lincoln County's ICIP for 2018-2019 Fiscal Year; and approval to utilize the \$50,000 of previously budgeted funding to purchase an emergency backup generator.

Welda Grider, Secretary of the Board of Directors for New Horizons questioned the amount and possible uses of the previously budgeted funding. Ms. Grider explained the facility electric service currently would support one generator but additional work was required to install a second generator.

There was a general discussion regarding the electrical service and wiring for the proposed generators.

Chair Stone questioned if the electrician installing the generator had any recommendations for type and size generator needed for the building and if the \$50,000 was obligated specifically for the generator purchase.

Attorney Morel stated he had begun to draft a lease agreement with New Horizons but it was pending the determination of the fair market rent value prior to submission for approval by the Department of Finance and Administration (DFA) and the Board of Finance. Attorney Morel stated he would work with New Horizons to develop a fair lease agreement.

Ms. Grider stated although the facility had not paid a monetary lease for the facility New Horizons had provided maintenance and other associated costs over the years. Ms. Grider also mentioned the building site currently housed a County ambulance. Ms. Grider informed the facility was not opposed to paying rent but would like the County to consider the facility's operational costs and improvement costs to the building when developing the fair lease agreement.

There was a general consensus to move forward with obtaining a fair market value appraisal, develop a new lease agreement, purchase one generator, and pave the parking lot.

15. Status of Lincoln County Medical Center Replacement Hospital Construction and Clinic Renovation Projects

a) Status of EMS Departmental Move

Ms. Taylor informed the Emergency Medical Services staff estimated a move once the additional construction was complete. Ms. Taylor anticipated completion of the construction by April 7, 2018.

Ms. Taylor noted some of the delay was due to the state inspection process and delivery of materials.

b) Schedule of Request for Proposals (RFP) for Replacement Hospital

Ms. Taylor reported two responses were received by the County in response to RFP 17-18-002. Ms. Taylor stated that the Evaluation Committee determined the offeror was the apparent low bidder. Ms. Taylor stated negotiations for the proposals will commerce on Friday March 23, 2018 in Albuquerque.

c) Clinic Services for Hondo Valley Residents

Ms. Taylor reminded Presbyterian agreed to provide health care clinic services to the Hondo Valley previously served by La Casa. Ms. Taylor reminded of prior discussions regarding relocating an existing EMS building from the hospital site to Hondo for clinic services. Ms. Taylor stated Lincoln County awarded the bid to repair the previous Hondo Clinic site to the lowest bidder. Ms. Taylor stated Presbyterian must finalize the installation of its IT systems at the site, arrange for required insurance coverages, and work out the personnel challenges.

Todd Oberheau, Administrator stated normal daily operations could commence once the repairs were complete and electronic record capabilities were installed. Mr. Oberheau estimated the clinic might open by May. Mr. Oberheau stated Marilyn Shultz, the previous provider for La Casa, now employed by Presbyterian, had expressed interest in the position and they were working on scheduling changes.

Ms. Taylor stated she would research and provide a report for future the direction and authorization approved by the County Commission for the Hondo Clinic in concern to the lease agreement and budget requirements.

18. Tabled: Discussion of Enacting Fire Protection Services County Local Option GRT Increment

Motion: Un-table discussion of enacting Fire Protection Services County Local Option GRT Increment, Action: Approve, Moved by Commissioner Draper, Seconded by Commissioner Allen.

Vote: Motion carried by unanimous vote (summary: Yes = 5).

Yes: Chair Stone, Commissioner Stewart, Commissioner Allen, Commissioner Draper, Commissioner Willard.

Spencer Baldwin, Office of Emergency Services Coordinator reported Lincoln County had traditionally directed the operation of the County in a manner which minimized the imposition of tax increases for the Lincoln County residents. Mr. Baldwin informed Lincoln County had one of the lowest Gross Receipt Tax (GRT) rates in the State of New Mexico. Mr. Baldwin stated if the .125% GRT tax increment dedicated to emergency services was adopted Lincoln County would continue to have one of the lowest GRT rates in the State.

Mr. Baldwin stated the Lincoln County Fire Services Department was the largest department in the County. Mr. Baldwin reminded all County fire departments were volunteer and did not receive funding from the County but rather from the State Fire Fund. Mr. Baldwin stated the State funding formula for departments was based on the percentage of insurance premiums paid collected by the State and each department's Insurance Service Office (ISO) rating. Mr. Baldwin stated the lower the ISO rating the more funding the department will receive. Mr. Baldwin stated each department was trained for structural fires, hazard material accidents, vehicle accidents, cats in trees, and wildland fires.

Commission Stewart stated the change in the State funding for local fire departments was a priority issue for counties to discuss with legislators. Commissioner Stewart stated belief the problem related to distributions from the State Fire Fund was the principal problem.

There was general discussion regarding the State Fire Fund distributions from Fire Protection Fund to the departments.

Commissioner Draper question the financial impact to each department if the tax was enacted.

Mr. Baldwin estimated each fire department would receive approximately \$19,000 annually.

Commission Stewart question if this would require a special election.

Rhonda Burrows, Clerk stated the timing of the adoption of an ordinance would determine the County's placement of the question on the General Election ballot.

- Product Spill of Agric

Chair Stone questioned department's quality of service depending on outcome of the enactment of the GRT tax.

Mr. Baldwin stated regardless of adoption or failure to adopt the GRT increment, the local departments would continue to provide the best performance and services to the residents of Lincoln County.

Motion: Discuss legislative changes with the New Mexico Association of Counties to direct State Fire Fund distributions to fire departments only and not into the States General Fund, Action: Approve, Moved by Commissioner Stewart, None seconded.

Motion: Place a question regarding the enactment of a .125% GRT increment on the General Election Ballot., Action: Approve, Moved by Commissioner Allen, Seconded by Commissioner Willard.

Vote: Motion failed by roll call vote (summary: Yes = 2, No = 3, Abstain = 0).

16. Manager's Report

<u>Legislative Matters.</u> Our legislative delegates helped us celebrate our history and heritage by declaring February 7, 2018 as "*Lincoln County Day*" at the House of Representatives. Thank you to our legislative delegation: Zach Cook, Greg Nibert, William F. Burt and Elizabeth Stefanics

NM Attorney General Approval of the Operation and Management Agreement between LaSalle Corrections West, LLC, and the County on March 13, 2018. The approved checklist issued by the Office of the Attorney General. Attorney Morel, Manager and Warden Anderson worked closely with the office of the Attorney General to satisfy their concerns by amending documents, modifying contract language, responding to a number of inquiries that enabled their understanding and acceptance of our specific language, in some cases, etc. This review and exchange of information commenced in early October, 2017. The red-line version of the contract, showing modifications made. We are lacking approval, and have had no correspondence from DFA or Risk Management.

2017 CLG Evaluation, Lincoln County Certified Local Government Program. 2017 evaluation of the County's "Certified Local Government" Status. CLG Staff found that Lincoln County continues to fulfill its responsibilities pursuant to the terms of the original Certification Agreement, issued in 1991. We were informed that the State of NM codified its requirements for the CLG program in 2008, and that our current Preservation Ordinance would not meet current CLG program requirements. However, that does not change the County's status as a CLG, nor does it affect our eligibility in applying for CLG grants. Acting Planning Director Samantha Mendez will summarize during her departmental update.

Invitation to Attend a Federal Resource Roadshow. US Senator Tom Udali recognizes the many needs that exist across the state, particularly in rural communities, and believes that the federal government should work for us. His office partnering with the Local Council of Governments and USDA Stronger Economies Together (SET) to host a series of roadshows. He invites our attendance at ENMU in Roswell on March 27, 2018. RSVP required by March 21, 2018.

<u>Upper Hondo Soll and Water Conservation District</u> passed a Mill Levy Rate Resolution # 06 2017-2018. This resolution, authorized by a referendum held on February 28, 1985, establishes a

mill levy not to exceed the rate of one dollar .5 per thousand dollars of net taxable value of real property within the District. It is currently \$0.50 per thousand dollars of net taxable value of real property within the District. Manager Taylor reported she had learned the District had not in fact adopt this Resolution.

<u>County Resident Supports Commission</u> decision to not allow a waiver to existing regulations which would allow a re-platting of the Alto Mesa Estates subdivision. Resident clearly points out that his investment decision was made on the written and Inferred promises regarding what was to be the layout of the development and its density; and feels that promises should not die with the changing of the developer.

New Mexico Energy, Minerals and Natural Resources Division (NM-EMNRD) oversees the federal grants and agreements the County enters into with State Forestry. Field Representative was in the County on March 12, 2018 to conduct a Sub-recipient Monitoring Visit (audit) of our records, practices, monitoring of projects, and compliance with Agreements. She was appreciative and complimentary of our thorough record-keeping and teamwork among departments to meet criteria of the grants and agreements.

Coalition of Arizona / New Mexico Counties For Stable Economic Growth. Manager attended Annual Meeting in Safford, Arizona on March 9, 2018.

<u>Professional Services Agreement for Collective Bargaining Matter.</u> The County has worked for years with Management Associates, Inc., to handle collective bargaining matters. Mr. John Martinez who previously represented the County was limiting his work and had referred us to Holcomb Law Office. We have traditionally had minimal need for this type of service and intend to shift budgeted funds from Management Associates to Holcomb Law Office. This comprehensive safety net will include an evening drop-in center, an overnight shelter and related services.

Department Head Updates:

Samantha Mendez, Interim Planning Director provided an update on the CLG evaluation. Ms. Mendez reported the evaluation gave recommendations for the County to update the Historic Lincoln Preservation Ordinance, conduct more surveys in Lincoln, and add other historic landmarks not in Lincoln.

Ms. Mendez reported she was working on the Local Update of Census Addresses Operation (LUCA). Ms. Montes informed she was working on a grant to request funds to purchase and install the new walk in freeze for the Hondo Senior Center. Ms. Montes stated the Carrizozo Senior Center recently received a donation of exercise equipment form Marilyn Chewing. Ms. Montes reported she was continuing to work with Clara Farah and the Creative Aging Group on transportation options for seniors.

Punkin Schlarb, Finance Director stated the Finance Department had begun the budget process and planned to meet with each department to review budgets. Ms. Schlarb stated Rhonda Edwards and herself along with representation from the Treasurer's Office attended a meeting hosted by the State Auditor in Santa Fe.
