Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on April 16, 2019 in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

8. Forest, Land & Natural Resources Matters:

Smokey Bear Ranger District

George Douds, Acting Ranger reported moderate fire danger and fire restrictions on the Smokey Bear Ranger District. Acting Ranger Douds stated the district was fully staffed and ready for the fire season. Acting Ranger Douds stated the district started hanging MCH pouches to ward off the spruce beetle in the Ski Area. Acting Ranger Douds stated they kicked off the Smokey Bear North Project Environmental Analysis to look at vegetation and habitat improvement, as well as range and recreation projects on the north end of the District including the north slope of the Capitan Mountains. Acting Ranger Douds reported Supervisor Moseley and Ranger Canfield met with Butch Blazer to discuss reinvigorating a discussion on forest management and use of biomass. Acting Ranger Douds stated the tribe would facilitate this.

Acting Ranger Douds stated the district completed work to clear sediment from under the bridge at Rio Bonito with permission from Alamogordo and an Army Corp permit. Acting Ranger Douds stated the forest service dumped gravel in an area above South Fork Campground. Acting Ranger Douds stated this would keep the bridge from washing out in a high water event. Acting Ranger Douds reported representatives with the National Forest Foundation planned to meet with representatives from the ski area, area businesses, and the Village of Ruidoso on May 8 -10 to keep building a strategy for fundraising under the stewardship fund authority.

Extension Services

Melanie Gutierrez, Lincoln County Program Director/Extension Associate reported they attended a wildlife workshop in Ruidoso. Ms. Gutierrez stated the Village has a vulture problem and was working on getting information out to home owners. Ms. Gutierrez stated the 4-H groups started judging practice and the shooting sports program was underway with set classifications of archery, gun and rifle. Ms. Gutierrez stated they had received numerous calls from the public on bugs and weeds populating in the area. Ms. Gutierrez stated they would work with The Village of Ruidoso on grass and water management and the public was always invited to attend the meetings.

c. South Central Mountain RC & D

Rick Merrick, Community Forester reported on the potential use of bioenergy gathered from the forest by a company in the area who uses the organic substances to convert into biochar. Mr. Merrick gave an update on the CWPP grant and stated they grant should close by the end of May with the input from the survey.

d. Upper Hondo Soil & Water Conservation District

Ms. Taylor stated Laura Johnson, Program Director was unable to attend but had provided an Agenda for their April meeting.

e. New Mexico State Forestry

Frank Silva stated Smokey Bear days were coming and the Wildland Fallen Firefighters Memorial was available for the public to view. Mr. Silva stated House Bill 266 - the Forest and Watershed Restoration Act was passed by 2019 legislation. Mr. Silva stated a committee will distribute the funds. Mr. Silva stated the State had not hired a local fire manager but had three applicants apply and decided to do an additional interview.

f. LANRAC - Land and Natural Resources Advisory Committee

Robert Barber, Chair of LANRAC informed the public input on the Hale Lake 3500 acres was due May 6, 2019. Mr. Barber stated the Mountainair collaborative report would be available for final public comment in the next 45- 60 days.

Assessor's Annual Report

Walter Hill, Assessor presented the 2019 Lincoln County Assessor's evaluation. Mr. Hill reported the sales ratio study compared assessments to the market sales. Mr. Hill stated this report enables the assessor to evaluate the level of current assessment values to 2018 sales and was used to determine if the 3 % cap increase is needed to obtain market value. Mr. Hill stated the County did increase the residential values county wide by the 3 % allowable cap, and also reinspected and valued all properties sold in 2018. Mr. Hill stated the median ratio was now at 98.49% or 98% of market value.

Mr. Hill reported on the livestock values by district for Lincoln County from 2016 to 2019. Mr. Hill stated the values reflected a substantial downward trend in livestock values over a four year span. Mr. Hill explained these values are set by the New Mexico Livestock Board and are not a reflection of the Assessors valuation process.

Mr. Hill reported on the net new valuation report. Mr. Hill stated the spreadsheet was used to track only new construction values by district and was used primarily in the development of tax rates. Mr. Hill stated these values are reported to the State in the Assessors certification in June.

Mr. Hill reported on the contributory value report, which tracks all value by district. Mr. Hill stated the valuation changes were the result of building permits, the sale of property, the result of a protest, the 3 % limitation on increases in valuation of residential property, and the re-inspection of properties during the reappraisal process.

Mr. Hill stated the Assessor's office was currently in the process of obtaining quotes for aerial imagery. Mr. Hill stated this could help ensure all improvements to properties in the County were accounted for and assure tax payers properties were equitably assessed.

Commissioner Stewart and Commissioner Draper questioned the sales ratio data.

10. 9:30 A.M.: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS (Items are for discussion only – no action will be taken)

Commissioner Stewart stated he attended a NMC sponsored Multiline and Employee Comp Board meeting. Commissioner Stewart suggested we get a presentation from NMC before the conference in June.

Commissioner Stewart stated he would continue to attend meetings with Dona Ana officials to discuss the ongoing maintenance of the Joint Land Use Study. Commissioner Stewart stated the committee recently appointed a new coordinator.

Commissioner Allen stated she continues to attend the Greentree meetings. Commissioner Allen stated she recently joined the Juvenile Justice Board for personal interest. Commissioner Allen reported she was currently working with South Central Mountain RC & D to begin the process of introducing a Firewise Meeting in the Lincoln area.

Commissioner Draper reported he attend a School Safety meeting yesterday in Ruidoso at the convention center. Commissioner Draper stated the meetings have come full circle with a tour of all schools in Lincoln County including a tour of ENMU- Ruidoso Branch Community College as well as with the Mescalero schools. Commissioner Draper reported Carrizozo schools hired a school safety officer. Commissioner Draper also informed the committee had divided into sub committees.

Commissioner Draper stated he attended the Center of Protected Environment (COPE) candle light ceremony last Friday night in honor of domestic violence victims and their families. Commissioner Draper stated the Village of Ruidoso will have another presentation on their comprehensive plan in September. Commissioner Draper stated there will be another drug take back day event on Saturday April 27th.

Whitney Whittaker, Clerk informed the Lincoln County Clerk as well as the County Assessor and County Treasurer created a web link for the public to access "LiveWeb". Ms. Whittaker stated the Clerk's Index as well as certain Assessor and Treasurer information will be available online through our county website. Ms. Whittaker also stated the last day for a candidate to notify the County Clerk of intent to seek the position of New Mexico Counties Board Representative was April 30, 2019.

Beverly Calaway, Treasurer reported her office collected 71% of the taxes for the second half collection. Ms. Calaway stated a title examiner from the state had started researching the

delinquent properties in Lincoln County. Ms. Calaway stated they started with 260 properties and the number was down to 246 as of today. Ms. Calaway reported on the integration of "Liveweb". Ms. Calaway stated the Treasurer will only provide limited information but will still continue to have access to online payments. Ms. Calaway believes having information online will significantly cut down on the phone calls for their office.

Walter Hill, Assessor reported the protest period had started for his office and would will go until April 30, 2019. Mr. Hill stated his office also reported on the integration of "Liveweb" and was excited to have maps and other information available to the public online for our residents.

Sheriff Shepperd stated Governor Lujan Grisham invited County Commissioners from all 33 counties to participate in a conference call. Sheriff Shepperd stated they spoke about SB 8 Firearms Sale Background Check and the requirements. Sheriff Shepperd stated he would attend a NMC meeting on May 3, 2019 in Farmington. NM.

Ty Divelvliss expressed concern about the Lincoln County Detention Center and the way the facility is operated and how the employees are treated. Mr. Divelvliss stated he has worked in corrections over 30 years. Mr. Divelvliss stated there was no due process, no grieve time for employees who recently had a death in the family, and was a victim of verbal abuse. Mr. Divelvliss stated Warden Anderson displayed disrespect to Lincoln County.

Karyl Williams Capitan resident expressed support for Resolution 2018-39.

Jack Davis, resident of 102 Valle Loop in Alto expressed gratitude to the County of Lincoln for help resolving an issue with water drainage and road access which occurred after the Little Bear Fire

Wade West spoke on behalf of his fiancé who worked at the Lincoln County Detention Center. Mr. West did not appreciate the way his fiancé was treated while employed.

Cadence Divelvliss, daughter to Mr. and Mrs. Divelvliss informed of the long hours her parents had to work and stated they were never given time off to spend with their family.

Kim Divelvliss stated she had to resign due to the disrespect displayed by current supervisor Warden Anderson with LaSalle Corrections.

Scott Yokley stated he was harassed by Warden Anderson and filed a Complaint with LaSalle Corrections. Mr. Yokley stated he worked 13 days straight on 12-16 hour shifts.

Assessor's Annual Report Continue.

There was an in depth discussion regarding the ratios of sales and the 3% allowable cap.

11. Resolution 2018-39 - Supporting the Presidential Declaration of a National Emergency Concerning the Southern Boarder of the United States

Ms. Taylor reminded during the March 19, 2019 meeting the Commission considered Resolution 2018-39 supporting the Presidential Declaration of a National Emergency concerning the Southern Border of the United States.

Ms. Taylor stated after considerable discussion the item was tabled for clarification of language as to how border security, or lack thereof, impacts New Mexico Counties and the importance of Counties to be empowered to declare emergency action, when necessary.

Chair Stone recessed the Regular Meeting at 10:32 AM and reconvened at 10:43 AM

12. Pattern Development - Transitioning the World to Renewable Energy

Ms. Taylor stated the County continued to work with Pattern Development to bring wind energy to Lincoln County and New Mexico. Ms. Taylor stated the Mesa Canyons project was granted a Wind Energy Conversion Systems (WECS) permit by the County of Lincoln.

Crystal Coffman, Manager Project Development for Pattern Development gave a presentation on Pattern's commitments and community involvement. Ms. Coffman stated they were currently working with the community and reviewing environment changes. Ms. Coffman stated the Corona Wind Farms were located in an area with some of the highest wind resources in the state. Ms. Coffman stated the Corona area wind projects will have economic benefits including over two billion dollars of capital investments, one hundred full time jobs in operations and over six hundred construction jobs. Ms. Coffman stated the wind projects were expected to contribute revenue to Lincoln County and the local economy for at least thirty years through the payment in lieu of taxes.

Commission Stewart questioned the status of rerouting the transmission line.

Adam Cernea with Clark Environmental and Natural Resources informed the environmental report identified 70 plus protection measures in the area. Mr. Clark stated they were currently working with Fort Bliss and the White Sands Missile Range to incorporate a footprint of the area and correlate with current airspace.

Ms. Coffeman stated the Corona area wind projects submitted an Environmental report to the Public Regulation Commission with their application for location control approval. Ms. Coffman stated the report details a wide range of project commitments called "protection measures" that become conditions of the PRC approval. Ms. Coffman stated these measures address a wide range of issues ranging from water runoff to land use and biological resources. Ms. Coffman stated Pattern was also working with the Claunch-Pinto Soil and Water Conservation District to develop best practices relating to issues such as land use, erosion, storm water, and noxious weeds.

Mr. Clark stated groups were being created to review physical landscapes and consider creating individual bylaws. Mr. Clark stated Mesa Lands Community College located in Tucumcari was considering establishing a campus near Corona for training.

Commission Willard questioned the aerial interference of the towers and the lighting detection system.

Ms. Coffman stated the towers will be equipped with radars and lights programmed to blink when any aerial activity was detected.

13. Replacement Hospital Update

Jaynes Schedule Narrative- Summary of status

Mike McDonald, Hospital Project Manager gave a general overview with the continuation of dry wall, plumbing, electrical, fireproofing, and sewer construction. Mr. McDonald stated the estimated completion date was scheduled for November 22, 2019 and the estimated Phase II completion, including abatement and demolition activities, was set for July 23, 2020. Mr. McDonald stated there were some delays due to weather mostly rain or high winds. Mr. McDonald stated there were approximately 36 days during which construction was at a standstill.

Expenditure Summary

Ms. Taylor reviewed the summary of expenses paid through March 25, 2019 with year to date expenditures totaling \$6,930,009.53. Ms. Taylor stated Jaynes' pending pay application for work completed in March in the amount of \$1,226,598.00 brings the total to \$8,156,607.53.

Various Change Order Considerations

Ms. Taylor stated the total pricing being considered for the two construction change directives, outstanding items from Architects' supplemental Instructions (ASIs), and other outstanding cost items is \$445,234.27. Ms. Taylor also recommended an increase in the Owner's contingency by \$850,000 bringing the total to \$1.7 million

General Discussion regarding budget and additional construction costs.

Motion: Approve increase in Owners Contingency by \$850,000; approve Construction Change Directives 02 and 03; ASI's; and other outstanding pending change orders, Action: Approve, Moved by Commissioner Willard, Seconded by Commissioner Stewart.

Chair Stone recessed the Regular Meeting at 12:03 PM and reconvened at 1:02 PM

Lincoln County Juvenile Justice Board Update – The Honorable Daniel A. Bryant and Sergio Castro, CYFD

Ms. Taylor stated the Lincoln County Juvenile Justice Board works directly with State, County and Local governments as well as judicial entities and law enforcement agencies to identify critically needed, cost effective, proven "best practice" programs and services to address the needs of juvenile offenders within the County. Ms. Taylor stated the Board was formed in July 2004 by an agreement between Lincoln County and the New Mexico Children Youth and Families Department.

Judge Bryant introduced Sergio Castro, the Juvenile Probation Office Supervisor for the 12th Judicial District which encompasses Lincoln and Otero County. Judge Bryant stated Mr. Castro had served on the LCJJB since 2002.

Mr. Castro discussed the history of the LCJJB which began in 2002 when the group received funding to visit Fort Worth, Texas to observe new processes for dealing with juvenile offenders. Mr. Castro stated this visit resulted in a coalition to develop alternative programs to detention. Mr. Castro stated these programs had resulted in a significant reduction in the number of juveniles incarcerated and therefore a significant cost savings to Lincoln County. Mr. Castro stated they have seen a 79% decrease in juvenile detention costs to Lincoln county from the highest peak in fiscal year 2006-2007 of \$189,482 to the current calendar year 2018 of \$39,071.

12th Judicial District Judge Bryant, Chair of the Lincoln County Juvenile Justice Board stated the second annual South Central Mountain Children & Youth Summit was set for August 7, 2019 at the Inn of the Mountain Gods. Judge Bryant stated the summit would explore solutions to the challenges children, youth and their families face.

Motion: Recess the Board of County Commissioners and convene the Lincoln County Canvass Board, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen. Vote: Motion carried by unanimous vote (summary: Yes = 5).

Canvass Carrizozo All-Mail Ballot Election of April 9, 2019.

Whitney Whittaker, Clerk presented the 2019 Carrizozo Special School All-Mail Ballot Election results for Lincoln County for review and approval. Ms. Whittaker informed there were 1173 registered voters in the Carrizozo School District eligible to cast a ballot during the Special Election. Ms. Whittaker stated 438 voters returned their ballot representing a 37.6% return rate.

Ms. Whittaker stated final vote totals included two (2) hand tallied ballots. Ms. Whittaker stated four (4) ballots were rejected for either no signature or no ballot returned in the envelope. Ms. Whittaker presented reconciliation reports, rosters, and tabulator tapes for inspection.

15. Manager's Report

1. <u>HATS OFF, Farewell and Best Wishes</u> to Spencer Baldwin, Emergency Services Coordinator for the Lincoln County Office of Emergency Services, who has accepted an opportunity to begin a long-term career goal of piloting a helicopter. Mr. Baldwin was employed by the County on April 29, 2013, nearly precisely six years ago. He has been instrumental in developing by-laws for the Fire Departments, as well as Standard Operating Procedures. He responds to emergencies of all types, including assuming the key role of Incident Command, when necessary, in response to wildland and structural fires. In addition, Mr. Baldwin was instrumental in setting up and supporting the critical Emergency Reporting System. We will miss him!

- 2. <u>Lincoln County FY 19-20 Budget Preparation.</u> All County departments, including Volunteer Fire Departments, have been busy participating in FY 19-20 budget preparations. In addition, non-profit organizations which have been recipients of past county funding have received and returned their Budget Request forms. The Manager provided the schedule of critical dates. A preliminary Special Meeting for review and consideration by the Commissioners was scheduled for May 1st. The Manager provided the order of external agency presentations for the May 1st Budget Hearing and a copy of the draft Agenda.
- Potential Property Purchases and Building Renovation Projects. In recent months, the County has discussed several potential property purchases and building renovations:
 - Land on Cora Dutton Road for Road Department consideration: No longer on the market.
 - b. Purchase of Wells Fargo Bank Building: Manager has met with realtor several times to assess level of ADA compliance with parking, access to the building and restrooms; and with an architect to analyze the same. As stated, the architect's opinion, based on square footage of the main floor, and the assumption that the space would be occupied by employees and open to the public, is that two additional restrooms would have to be added. The estimated cost would be approximately \$45 \$65 thousand.
 - c. Renovate the mechanical room in the old Courthouse area that houses abandoned heating and cooling infrastructure to build ADA compliant restrooms. Architect's opinion is that each existing restroom could be renovated to be an ADA accessible single-occupancy restroom with one toilet and sink. The mechanical room could be renovated to hold two, single-occupancy restrooms each (men's and women's), with one toilet and sink. Costs are estimated to be similar to those outlined for the Wells Fargo Bank building.
 - d. Bring the Lincoln County Fairgrounds and Arena back for discussion and analysis. The County commissioned a Fairgrounds Master Plan in 2011, and a Magado Creek Crossing Study in 2012. There has been interest expressed in having the County reconsider the project, including scope and use. Once determined, there may be grants available for such projects, such as USDA. Both studies are available upon request.
- 4. <u>Invitation to</u>: The First, New Mexico Fallen Wildland Firefighter Memorial. To be held on April 25, 2019 at 1:00 p.m. at the Smokey Bear Historical Park in Capitan. Lincoln Volunteer Fire Department Chief Bennie Long and Smokey Bear's Hometown Association has worked tirelessly to obtain the donations for this special memorial. Please RSVP.
- 5. Governor Lujan Grisham's Invitation to Representatives from all 33 County Commission's to Participate in a Conference Call. Chairman Stone and Vice-Chair Draper participated in the call, during which no County was able to verbally participate. Each county submitted four questions to NMC President Rebecca Long and Steve Kopelman, who reviewed them and relayed the most common questions to the governor. Attorney General Balderas also participated in the call, cautioned the Counties of the risk of potential financial liability if laws were not enforced. The law enforcement officers throughout the state have since received correspondence from Attorney General Balderas regarding the obligation to uphold the mandates of Senate Bill 8, which makes it unlawful to sell a firearm without a background check. Attorney General Balderas reminds that effective July 1, 2019, law enforcement officers have a legal obligation to uphold the mandates of Senate Bill 8.
- 6. <u>Capital Outlay Projects.</u> The Manager provided a list of the Governor's Vetoed Projects, including \$300,000 for the construction of the Lincoln County Replacement Hospital; and the Capital Outlay Projects approved including the Chart for Lincoln County which includes action taken for all local governments in the County, state agencies operating in the County including the Office of the District Attorney, higher education institution, libraries, museums, acequias, historic sites and solid waste authority. The Governor's line-item vetoes impacted 8.9% of the total Capital Outlay requested by all entities in Lincoln County.

7. MM-DOT Notification of Change in Local Government Road Fund Program Funding for FY2019-2020. During its February 19th meeting, the Commission approved the recommended projects for Local government road funding and authorized the submission of letters of intent to the NM-DOT. The County applied for CAP, Coop and School Bus Program Funding. On April 8th, the County was notified that "funding levels have reverted back to previous levels and were cut from the levels of previous years. "Even though we think all projects were viable and are important to your communities, we are just not able to fund everyone's project." The Manager provided copy of the notification letter from NM-DOT and acceptance letter from County to NM-DOT, which was required to be returned no later than April 9, 2019. As illustrated, the County received no School Bus or Coop funding; and the District's CAP amount was reduced from \$282,750 to \$169,072. The County's share remains 25%, or \$56,357.53. District 2 Engineer Tim Parker provided further information informing additional DOT funding was allocated to US 285 and several roads in the area; and that the top priority roads designated by the legislature for District 2 were US285 (mile market 0 to 22), NM 128 (approximately 50 miles; and an interchange at US 285 and NM 31). 2.5 of those three projects reside in Eddy County; and .5 of NM 128 is in Lea County. Road Superintendent Honeycutt will address during his update to the Commission.

Departmental Head Updates

Jeff Honeycutt, Road Superintendent stated due to the cut in funding for the CAP, Coop, and School Bus Route Project he will go ahead with only one project and that is to repair Juniper Springs and wait until funding for Fort Lone Tree. Samantha Mendez, Director of planning and Project Management informed they filled the addressing position and they are expected to start at the beginning of May. Ms. Mendez stated she attended a training in Albuquerque on flood precautions. Ms. Mendez stated the Village of Ruidoso purchased property management short term rental software.

Renee Montes, Senior Services Director stated she will attend a training next week with non-metro. Ms. Montes stated they are in the process of hiring a Part time cook in Corona and driver for Ruidoso Downs.

Punkin Schlarb Finance Director informed they are ready to close fiscal year 18-19. Ms. Schlarb reported Triadic and Systems MD were here today looking at the server for the integration of "Liveweb."

Joe Kenmore, Office of Emergency Services Director stated the department is working with the forest service to get tower in Capitan. Mr. Kenmore informed he would assist with a driving course in Hondo. Mr. Kenmore stated he will continue to notify of any Red Flag warnings, and we had a few this month. Mr. Kenmore stated the Emergency Medical Service conference is this week and will be held at the Ruidoso Convention Center.

NMAC did open a claim as "record only".

Estrada, Ricardo – Tort Claim Notice received February 14, 2019 alleging that, while incarcerated at LCDC, the Claimant was physically attacked by a former employee of LCDC out of retaliation causing injuries to his small finger on his left hand and possibly a left foot fracture. TCN emailed to R. Martinez on February 15, 2019 and that same day, NMAC advised that there is no coverage for this matter as NMAC does not provide coverage on behalf of counties or their detention centers which are operated or administered by a private contractor.

Steward, Tynel – Tort Claim Notice received November 1, 2018 alleging that while incarcerated at Lincoln County Detention Center, the Claimant (i.) was attacked due to the negligence, reckless, and/or intentional actions of jailers and other county employees, (ii.) has not received adequate medical care, and (iii.) is being held in inhumane conditions of confinement, including, but not limited to, sewage gas, overcrowding, and sleeping conditions.

Montoya, Joseph – Tort Claim Notice received August 25, 2017 alleging great bodily harm during Claimant's incarceration at Lincoln County Detention Center.

Martin, Stephen Wayne – Tort Claim Notice received August 25, 2017 naming Clerk Rhonda Burrows. Additional document received September 15, 2017 from Mr. Martin referencing same cause.

Ryen, Kenneth Lloyd – Tort Claim Notice received October 18, 2017 alleging violation of Article II, Section 10 of the New Mexico Constitution: Plaintiff was allegedly held in custody at LCDC for 15 days, November 10-25, 2015, and alleging paperwork to hold Plaintiff did not contain a cause number.
