#### 8. Forest, Land & Natural Resources Matters:

#### a. Smokey Bear Ranger District

Jodi Canfield, District Ranger reported the Homestead fire burned 7 acres of private land and 39 acres of forest. Ranger Canfield stated Smokey Bear Ranger District was the first agency to respond to the fire. Ranger Canfield stated the District is hiring permanent fire positions and getting vehicles ready for the upcoming fire season. Ranger Canfield stated the BACA fuel reduction project was completed. Ranger Canfield reported the district was awarded funds for riparian restoration in the South Fork Bonito in correlation with Upper Hondo. Ranger Canfield stated they will begin to work this spring on getting the agreement signed and apply for the fiscal year 2019. Ranger Canfield informed the work will include treatment of invasive plants, planting appropriate tress and scrubs, and seeding native forbs and grasses.

Ranger Canfield stated the district received a grant to employee Ecoservants to design and implement a signed plan for Cedar Creek and Perk Canyon trail system. Ranger Canfield stated the Smokey Bear Collaborative Group is making progress with travel and recreation planning in the Hale Lake area. Ranger Canfield stated a meeting is scheduled for February 27, 2019 at the County Department of Emergency Services office.

# b. Lincoln County/NMSU Cooperative Extension Services

Ms. Taylor informed Melanie Gutierrez was unable to attend.

# c. South Central Mountain Resource and Conservation District Council

Ms. Taylor informed Rick Merrick was unable to attend.

# d. Upper Hondo Soll & Water Conservation District

Laura Johnson, Program Director discussed the Acequias Governance and Water Rights Workshop to be held on Monday February 25, 2019. Ms. Johnson stated the workshop is to empower acequia leader in their roles as local institutions. Ms. Johnson reported the Upper Hondo continued to work with the Smokey Bear Ranger District for species treatment in the South Fork Campground. Ms. Johnson stated the district will continue work on treatment in the Bonito area.

Ms. Johnson discussed various other cost share programs overseen by the Upper Hondo including vinegar treatment and other associated programs which benefit land, wildlife and livestock.

#### Consideration of Entering Into Continuing Disclosure Dissemination Agent Agreement – Accu-Disclosure, LLC: Mutual Securities Disclosure Services

Nita Taylor, manager stated each year in February and March the Treasurer has a responsibility to file audited financial information, normally obtained from the County formal Audit on the EMMA website. This year because the County's audit was not yet complete, Treasurer filed unaudited financials, which is an acceptable mythology, to be updated once the Audit was approved. Ms. Taylor the EMMA website is funded and operated by the Municipal Securities Rulemaking Board (MSRB) The EMMA website is funded and operated by the Municipal Securities Rulemaking Board (MSRB), the self-regulatory organization charged by Congress with promoting a fair and efficient municipal securities market. EMMA is designated by the U.S Securities and Exchange Commission as the official source for municipal securities data and disclosure documents. The

Tolls for investors, municipal entities and others. EMMA supports municipal market transparency, but is not a platform for buying or selling bonds.

While assisting the County with updating these files, a recommendation from Erik Harrigan of RBC Capital Markets, verified the information that had to be updated and filed and assisted the County in developing that for filing. He strongly the County enter into a consulting agreement with a dissemination agent to assist the County with its continuing disclosure obligations tied to its bond issues.

Loretta Garcia, president of Accu-Disclosure, LLC informed Lincoln County was out of compliance as of March 31, 2018 due to disclosure reports not properly filed the on the 2012 Gross Receipts Tax Refunding Revenue Bonds. Ms. Garcia stated the company is pleased to provide dissemination agent services in connection with the continuing disclosure obligations. Ms. Garcia stated in connection with securities that the issuer has issued, the Issuer has agreed to file certain annual financial information and provide notice of certain events as more fully described in a continuing disclosure undertaking. Ms. Garcia stated the filing is done pursuant to SEC Rule 15c2-12 as amended and requires the annual financial information and event notices to be filed with the Electronic Municipal Markets Access system (EMMA) maintained by the Municipal Securities Rulemaking Board. Ms. Garcia informed event notices are required to be filed on EMMA in a ten day period. Ms. Garcia stated the company is willing to come in at any time to help the County.

Ms. Taylor stated since CDBG is federally funded the grant recipients are required to use an RFP format prepared by the Local Government Division that has been endorsed by the Professional Technical Advisory Board. Ms. Taylor stated the County specific RFP No 18-19-007 for Design Professional Services has been submitted to LGD for its review and concurrence.

Ms. Taylor stated also to be submitted immediately is the Depository Authorized Signatories Designation form. Ms. Taylor stated this form has been populated with the identified County employees designated as authorize signatories for requesting payment to be deposited into the about the County's appropriate checking account.

# 15. Approval to Enter Into CES Contract for Design of Lincoln County Detention Center Expansion

Ms. Taylor reminded in March 2018 she provided an overview regarding expansion needs for the Lincoln County Detention Center. Ms. Taylor stated this project did not materialize in 2018 due to the numerous other ongoing projects in progress in Lincoln County. Ms. Taylor confirmed with the President of DSV Construction a CES company that his quote for these design services is still valid.

Ms. Taylor stated Lincoln County has had experience with SDV Construction through its provisioning of the White Oaks Fire Station Design, as well as construction services to include dirt work and slab placement for the White Oaks Project. Ms. Taylor stated SDV also provided design services to the Bonito Fire Department for its new Fire Station at Sun Valley.

#### Approval to Enter into CES Contract for the Purchase of a Metal Building for White Oaks Fire Station

Ms. Taylor informed the County has recently closed the two Capital Appropriation Grants, totaling \$45,000 it received during the past several years to prepare for the purchase and construction of a metal building that would expand the capability of White Oaks Fire Department to house its apparatus. Ms. Taylor stated the existing Station barely houses three of the six apparatus utilized by the fire team to respond to emergencies; and the expansion is necessary to house existing apparatus and meet the needs of the residents and property owners. Ms. Taylor informed the expansion would consist of purchasing and erecting a 40' by 60' three bay metal building.

Ms. Taylor stated the White Oaks Fire Department has received a Fire Marshal's Grant in the amount of \$100,000 that must be encumbered by May 15, 2019. Ms. Taylor stated this grant will cover the cost of the metal building quoted by Hobbs Iron & Metal, Inc, a CES Company. Ms. Taylor stated the Fire Marshal will also cover a portion of the construction.

Ms. Taylor stated Owner's Representative Jim Klein has been working with County Purchasing Agent Samora to develop an RFP for Abatement Services. Ms. Taylor informed the RFP will be finalized and will be provided to Attorney Morel for final review.

#### 17. Manager's Report

- HAT'S OFF: Emergency Services Director Joe Kenmore and Sheriff Shepperd each received a SALUTE from the Republican Party of Lincoln County during the Village of Ruidoso's February 12<sup>th</sup> Council Meeting. This SALUTE was to the entire Lincoln County Fire Services family and Sheriff's Department "FOR SERVICE TO OUR COMMUNITY".
- 2. <u>Joint Investigators Training Texas New Mexico.</u> New Mexico State University's Southwest Border Food Protection and Emergency Preparedness Center provided Joint Investigators Training for the NM Department of Agriculture on behalf of the New Mexico Livestock Board. It was attended by approximately 38 investigators from Texas, Arizona and New Mexico; including Undersheriff Wood, one of our Investigator's and OES Director Joe Kenmore. Topics covered included livestock theft, property thefts, Texas and New Mexico brand and inspection laws, as well as the development of case reports, intelligence sharing and joint investigations.
- 3. The Carrizozo Baseball Field. During the planning phases of the new expanded Courthouse, the County requested, and the Town of Carrizozo granted the vacation of a portion of Brick Street to accommodate the construction of the facility. In exchange, the Town of Carrizozo requested the County to grant to it the Carrizozo Baseball Field, which is located on property owned by the County. As this exchange has not been formalized, the Town of Carrizozo is requesting the County to formalize the attached Warranty Deed. I recommend this exchange be formalized by executing the Warranty Deed.
- 4. New Mexico Energy, Minerals and Natural Resources Department has distributed a Grant Award Agreement between the ENMERD and Lincoln County for the Nogal Volunteer Fire Department to purchase Personal Protection Equipment ("PPE") or Fire Fighting Equipment ("FFE"). The Grant is in the amount of \$13,410.63 and requires a Local Match of \$1,490.07. To get the process started, Finance Director signed on behalf of Manager earlier this month, and ENMRD has since returned the fully executed Agreement and Notice to Proceed at We are requesting Commission approval of accepting these grant funds with the approval of Agenda Item No. 23, Resolution 2018-31, Adjustments to the Budget; specifically to increase the Nogal Volunteer Fire Departments budget by \$13,410.63.
- 5. Status of Kubiak Melton & Associates' Agreed upon Procedures' Review of the Office of the State Auditor's ("OSA") work papers related to its fact-finding initiative generated by an anonymous complaint. KMA has completed its extensive review of not only the OSA's paper work, but also of the County's. They have scheduled a meeting with OSA this week, and intend to have their final report to the County in the near term.
- Coalition of Arizona / New Mexico Counties. Howard Hutchison, Executive Director, has announced the annual meeting to be held in Glenwood, NM at the Community Center on Saturday, March 23<sup>rd</sup> at 11:00 a.m.; and has requested a response regarding availability.
- 7. New Mexico Counties' new website is going LIVE, enabling its visitors to access an interactive map of all the counties. It will link to each county's website for easy access to the user. The Annual Conference will be held in Curry County (Clovis), beginning on Tuesday June 18th. I request the Commission to consider moving the June Commission meeting either

to June 11<sup>th</sup> or to June 25<sup>th</sup>, enabling elected officials and some employees to attend the Conference. With either date, there will be three full weeks between the two Commission meetings.

- 8. Visit from Local Government Division. We had a very good meeting with Scott Wright, Community Development Bureau Chief and David Buchen, the County's assigned Community Development Project Manager when they traveled through Lincoln County after visiting neighboring counties. We discussed and clarified key processes to be developed and followed as we begin to work on the CDBG grant and wrap up several Capital Outlay appropriations from the state. They were pleased with our quick start on the CDBG required activities and encouraged early and often communications. There has been no appointment yet of LGD's Division Director or Deputy Director.

Ms. Taylor introduced Karen De La Roche the new Chief at the Lincoln County Detention Center

Karen De La Roche, Chief Lincoln County Detention Center stated she had been in Corrections for over twenty years. Chief. De La Roche informed she worked with a private company and with Federal inmates. Chief. De La Roche stated she would like to change how we do business in the Lincoln County Detention Center by introducing classes, loading up the library services, and job fair. Chief. De La Roche stated most of the inmates are between the ages of 19-40 years of age. Chief De La Roche stated they will Fulfill days with positive activities and give the inmates tools to help them learn to be a successful.

Commissioner Stewart informed he attended a Meeting January 31, 2019 with Dona Ana Staff to discuss the continued efforts with the community develop director. Commissioner Stewart stated he might be required to participate in a presentation for the Dona Ana Commission.

Commissioner Draper stated he attended Lincoln County Day in Santa Fe. Commissioner Draper informed he attended a private meeting with Alicia Keys from NM counties. Commissioner Draper stated NM Counties would like to make arrangements and have a tour of Lincoln County. Commissioner Draper informed Mike Wood Undersheriff and himself attended a School Awareness Active Shooter Training class.

Beverly Calaway, Treasurer stated the Lincoln County Treasurer's office has collected 68% of property taxes and the office will be sending out reminder letters in March for the second half of the taxes.

LeeRoy Zamora, Chief Deputy Assessor informed the annual assessor evaluation will be in March or April and once completed a full report will be given to the Commissioners. Mr. Zamora also welcomed Raymond Monreal to the Assessor's office as the new Deeds/Title Clerk.

Robert Shepperd, Sheriff thanked Undersheriff Mike Wood for taking care of the office and daily duties while he was in Santa Fe for the Legislative session.

Sheriff Shepperd, speaking as Lincoln County's NMC Board Member. Sheriff Shepperd stated there were many bills on the NMC radar and he would keep the Commission informed on any major actions which would directly affect the County

Chair Stone stated he fully supported our Constitution of the United States.

Karyl Williams, May Ann Russ, Ron Andrews, Residents of Lincoln County stood in support of Lincoln County Resolutions 2018-35 and 2018-36 and the 2<sup>nd</sup> Amendment.

Charmaine O'Rourke, resident stated she was not in support of the highway 380 project and opposed the bill.

Cathleen Phillips, resident stated she support our 2<sup>nd</sup> amendment and read an Oath of Office all elected officials take before entering office.

Rick Simpson, Dana Terlecky, Johnny Parker supported the 2<sup>nd</sup> amendment.

Lisa Dolle, resident is concerned with domestic violence. Ms. Dolle stated she had no objection to using firearms, but concerned with domestic violence and having a firearm in the home. Ms. Dolle stated this state needs more support for mental health.

Richard Ford, Clark Taylor, Ronald Rader stood in support of our Constitution of the United States and the 2<sup>nd</sup> amendment.

Roe Olson, retired Police Officer from California stated gun laws do not work.

Charmaine O'Rourke, resident stated she was a gun owner, hunter, and sports shooter but believed that any state law should followed.

Jerry Tulley, Joe Islas, E.W. Gunkel stated they appreciate the county sheriff's office and support our right to bear arms.

Jackie Powell, former County Commissioner of Lincoln County stated the Commission has obligations to defend our residents. Ms. Powell stated we are on the verge of a border invasion and we need to keep all the rights we were granted. Ms. Powell stood in support of Resolutions.

Joe Dearing, Jeff Blue stood in support to County Resolution and Constitution of the United States.

Guy Hence resident of Alto for twenty years stated he hoped we do not follow a model of the State of California. Mr. Hence stands in support all the people here who have stood up for 2<sup>nd</sup> amendment and County Resolution. Mr. Hence stated this County does not have enough law enforcement officers to enforce the bill and this directly violates rights of citizen.

Jim McGee thanked the Sheriff's Office for their public service. Mr. McGee stated he supports the Resolution. Mr. McGee expressed his belief that domestic violence is usually done with the swing of the fist.

Art Gonzales, Kayla Clifton, Nathan Fox, Daniel Chavez, Floyd Goodloe, Rick Evans, Jim Grider, and Ray Seidel all stood in support for Lincoln County Resolutions.

Kathleen Philips Hellman opposed to the HB 55 Electoral College.

April Simpson, resident stated she was a victim and supports the right to bear arms. Ms. Simpson stated with that right she will not be a victim again.

Beverly Calaway, resident respectfully requested the County of Lincoln to pass Resolutions 2018-35 and 2018-36.

John Sugg, 12 Judicial District Attorney stated he believed in our Constitution and is willing to challenge these gun laws in the courts. District Attorney Sugg stated he will work with Sheriff Shepperd to help protect the freedoms of the citizens.

Robert Shepperd, Sheriff thanked everybody for attending the meeting. Sheriff Shepperd stated there are laws currently in place for domestic abuse and other offenses.

Lincoln County filed its Answer to the Complaint on April 20, 2018 asserting that any County liens are first and priority liens which should be ordered paid from the proceeds of the foreclosure sale. Judge Bryant is the presiding Judge. Stipulated Motion for Withdrawal and Substitution of Plaintiff's Counsel was filed May 15, 2018.

7. Brack Rains v. Lincoln County D-1226-CV-2018-00179 Complaint for Violation of New Mexico Whistleblower Protection Act filed June 6, 2018. The County was served July 10, 2018. Judge Bryant was recused from presiding over the case by Plaintiff and Judge Counts was assigned to preside over the case. County's Answer to the Complaint and Jury Demand (12 person) was filed August 9, 2018.

8. \*State of NM v. Matthew N. Corp M-30-MR-2018-00048 Violation of County Ordinance 2014-04 Contraband Ordinance. May 23, 2018 – The Defendant was charged with 1 count of possession of contraband. The Arraignment hearing scheduled to take place on June 6, 2018 was continued until July 11, 2018, at which time a Pre-Trial Hearing was scheduled for August 14, 2018, and was subsequently rescheduled to October 23, 2018. On October 23, 2018, the Pre-Trial Hearing was rescheduled for November 20, 2018. The November 20, 2018 Pre-Trial Hearing was rescheduled for December 4, 2018 and the 6 month rule was extended. The December 4, 2018 Pre-Trial Hearing was rescheduled for January 29, 2019 and the 6 month rule was extended once again for an additional 30 days and now runs on March 10, 2019. On December 10, 2018, Defendant filed a Motion for Dismissal and, on December 14, 2018, the County filed its Response to the Motion for Dismissal. A Hearing on the Motion for Dismissal is scheduled to take place on January 29, 2019 immediately prior to the Pre-Trial Hearing. On

January 29, 2019, Defendant's Motion for Dismissal was denied. The Pre-Trial Hearing took place thereafter, at which time, the case was resolved.

- 9. State of NM v. Kimberly Conner M-30-MR-2018-00043 Violation of County Ordinance 2008-08 Animal Control Ordinance. A Citation was filed May 14, 2018 charging the Defendant with 1 count of Dog Running at Large. An Arraignment took place June 6, 2018 at which time the Defendant pled "Not Guilty." A Pre Trial Hearing was scheduled for July 3, 2018 before Judge Vega, however a Stipulated Motion to Continue Defendant's Pre-Trial Hearing and Order to Continue Pre-Trial Hearing was filed June 29, 2018. Pre-Trial Hearing took place July 31, 2018 before Judge Vega at which time a Final Pre-Trial Hearing was scheduled for October 23, 2018 with a Jury Trial scheduled for October 24, 2018. On October 23, 2018, Judge Vega heard Defendant's Motion for a Continuance of the Final Pre-Trial Hearing and the October 24, 2018 Jury Trial. The Motion was granted and the Final Pre-Trial was rescheduled for December 11, 2018 with the Jury Trial to take place on January 7, 2019. On January 4, 2019 a Hearing before Judge Vega at which time the Jury Trial was vacated and a Bench Trial was scheduled for January 7, 2019. The Defendant failed to timely appear at the January 7, 2019 Bench Trial and a Bench Warrant was issued and subsequently served. A Pre-Trial Hearing is scheduled to take place on February 26, 2019 at 9:00 a.m.
- 10. \*State of NM v. Robert Salas M-30-MR-2018-00126 Violation of County Ordinance 2014-04 Contraband Ordinance. Complaint was filed August 20, 2018 by Lincoln County Sheriff's Deputy Samuel Hanna. Defendant is charged with 1 count of possession of contraband-Marijuana. The Defendant pled "Not Guilty" on August 23, 2018 to the charge. A Pre-Trial Hearing took place September 25, 2018 at which time a Final Pre-Trial Hearing was scheduled for December 11, 2018, with a Jury Trial scheduled for January 7, 2019 which Jury Trial has since been vacated. On December 12, 2018, Defendant filed a Motion for Dismissal and, on December 14, 2018, the County filed its Response to the Motion for Dismissal. A Hearing on the Motion for Dismissal is scheduled to take place on January 29, 2019 immediately prior to a Pre-Trial Hearing. On January 29, 2019, Defendant's Motion for Dismissal was denied. The Pre-Trial Hearing took place thereafter, at which time, no resolution was reached. The Final Pre-Trial is scheduled to take place on March 27, 2019.
