Minutes Tuesday, June 25, 2019

Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on June 25, 2019 in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

1. Call to Order

Chair Stone called the Regular Meeting of the Board of County Commissioners to order at 8:29 AM

2. Roll Call

Others present included Nita Taylor, County Manager; Alan Morel, County Attorney; and Whitney Whittaker, County Clerk.

The invocation was presented by Chair Stone.

8. Bonito Lake Restoration Project Update - Rob Richardson, Bohannan Huston

Rob Richardson, the City of Alamogordo's consultant reported on the current condition of the Bonito Lake Restoration Project. Mr. Richardson stated at this point any rain would cause additional delays due to the need to drain any runoff and then reset to avoid flood damage during the project. Mr. Richardson invited the County staff to attend Bohannan Huston meetings for any updates. Mr. Richardson also provided pictures illustrating progress on the project.

Forest, Land & Natural Resources Matters:

e. Smokey Bear Ranger District

Jodie Canfield, District Ranger stated the Bonito Campground set up operation was suspend due to spotted owl nesting in the area. Ranger Canfield stated plans to resume the project after July 1st utilizing heavy equipment to drain the lake.

Ranger Canfield stated 100 trees were found down due to high winds. Ranger Canfield stated the District was slowly working to clean up downed tree areas.

Ranger Canfield reported Lincoln County was currently in moderate fire danger, based on specific modeling efforts. Ranger Canfield reported on the status the Lone Mountain Fire near White Oaks. Ranger Canfield stated the fire was in a remote area and the local land owner had agreed to support management of the fire. Ranger Canfield stated a ten person fire crew from Colorado was heading the operation and recently did a drone fly over.

Ranger Canfield provided a presentation on the use of drone fly overs and informed utilizing drones rather than manned aircraft would reduce costs.

Aaron Baldridge from the Type 5 Management Team provided information on the Pine Lodge Fire. Mr. Baldridge stated Highway 246 had a soft closure allowing only local resident's access. Mr. Baldridge expressed his appreciation for all the support from the Lincoln County Emergency Management Team.

There was a general discussion regarding the Pine Lodge Fire and the directional pattern the fire was displaying.

Nick Smokovich, NM State Forester stated Lincoln County has had a significant number of fire starts but fire crews were able to contain prior to becoming extreme situations. Mr. Smokovich discussed prevention actions home owners could take around homes to reduce fire danger. Mr. Smokovich stated picking up pine needles, pinecones and mowing the lawn were good housekeeping preventative measures.

f. South Central Mountain RC & D

Rick Merrick, Community Forester reported on the Cost Share and Firewise programs. Mr. Merrick stated the Firewise program provides home inspections for fire risk assessment. Mr. Merrick stated the Air Curtain Incinerator was still with the Village of Capitan. Mr. Merrick stated he recently held a Firewise Community assessment meeting in Lincoln and thanked Commissioner Allen for setting it up and attending the meeting.

g. Upper Hondo Soil & Water Conservation District

Ms. Taylor informed a representative from the District was unable to attend.

h. Land And Natural Resources Advisory Committee

Robert Barber, Chair of LANRAC informed the committee continued to work with the Smokey Bear Collaborative Group on the draft of proposed action for the Hale Lake area. Mr. Barber stated the next Collaborative meeting was set for June 26, 2019.

11. 9:30 AM: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS

Commissioner Stewart stated he attended the summer conference for the New Mexico Counties in Clovis last week. Commissioner Stewart informed he attend the Workers' Comp Board meeting in addition to other workshops provided. Commissioner Stewart stated a program called Oragami was coming online which would allow the county to log in and monitor claims.

Commissioner Stewart informed House Bill 324 which was signed into law recognizes Post Traumatic Stress Disorder as a condition of employment of paid full time firefighters.

Commissioner Stewart reported on the joint Workers' Comp and Multi-line Board meeting held in Clovis. Commissioner Stewart stated given the healthy nature of New Mexico Counties (NMC) workers comp balances and performance, the Boards of Directors proposed combining the two boards. Commissioner Stewart stated he made the motion to combine the two boards through the Joint Powers Agreement (JPA) and Bylaws. Commissioner Stewart stated the motion passed unanimously and he signed the agreements on behalf of Lincoln County. Commissioner Stewart stated the JPA now goes to the NM Department of Finance and Administration for approval and NMC staff were working on the transition to the combined board under the new bylaws.

Commissioner Stewart also attended a transportation and roads workshop. Commissioner Stewart stated NMC's Brian Moore moderated a discussion on future transportation issues and how counties can work to improve their roads.

Commissioner Stewart stated he also attended through teleconference a meeting of the Joint Land Use Study Group with Fort Bliss, White Sands, and Holloman. Commissioner Stewart stated the implementation committee was reenergized after the loss of the original administrator and the designation of a new administrator by Dona Ana County. Commissioner Stewart stated he briefed the group on wind energy developments in Lincoln County and the Holloman representative thanked Lincoln County for including requirements for military coordination in our ordinance.

Commissioner Stewart reported White Sands Missile Range was coordinating a large ceremonial event for the Mescalero Apache on the Missile Range in the vicinity of Oscuro Peak during the end of July and the first part of August.

Commissioner Allen reported she heard Representative Jim Townsend on the radio discussing the Legislative budget. Commissioner Allen expressed concerns about the use of the budget and asked Manager Taylor to investigate further.

Commissioner Willard attended the recent SERPTO representing Lincoln County. Commissioner Willard also informed he would attend the 4-H Horse Camp in Las Cruces for four days.

Beverly Calaway, Treasurer stated 99 properties were scheduled for the 2019 Property Tax Sale set for July 18, 2019 at 10:00 AM in the County Commission Chambers.

Ms. Calaway presented a PILT payment chart showing a 12 year of history of payments and total acreage for Lincoln County.

Walter Hill, Assessor stated his state evaluation deadline was approaching fast.

Robert Shepperd, Sheriff discussed the implications of HB 407 regarding term limits for elected officials.

Lincoln County Health Profile – Presentation by SE Region Epidemiologist Francisco Porras

Francisco Porras from the NM Department of Health presented findings from the Lincoln County Health Profile. Mr. Porras discussed the percentage prevalence of various health issues in Lincoln County including obesity, diabetes, suicide and alcohol-related deaths. The majority of the study reflects an increase in rates from 2011 and 2012.

Laura Wilson, State Nurse with the New Mexico Department of Health stated two issues reflected in the study were an increase in alcohol and drug abuse and also an increase in mental health issues. Ms. Wilson discussed some resources for mental health issues and provide information on how to

refer individuals for mental health assistance. Ms. Wilson stated there were not currently a lot of resources to help assist in educating the children at an early age.

There was a general discussion regarding domestic violence and how to expand resources to help with the adverse health indicators.

Ms. Wilson stated Lincoln County was actively involved in the drug take back days, educating the public on opioid addiction and finding alternatives to pain management.

Todd Oberheu, Lincoln County Medical Center Executive Director stated alcohol abuse was one of the biggest and most difficult health indicators to treat as compared to other drugs.

Mr. Oberheu stated New Mexico has a lack of mental health services, although Lincoln County has the LCAP program which provides assistance to address some of the issues. Mr. Oberheu stated they receive about seventy requests per month through the LCAP program.

Chair Stone recessed the Regular Meeting at 10:53 AM and reconvened at 11:05 AM.

12. The Role of Local Elected Officials in Economic Development – Presentation by Susie Russell – Region 6 Representative for Community, Business & Rural Development Team, New Mexico Economic Development Department

Susie Russell, NM Economic Development Department Region 6 Representative presented information regarding the role of local elected officials in economic development. Ms. Russell stated there were ten things you should know as the result of a partnership between the National League of Cities Center for Research and Innovation and the International Economic Development Council (IEDC). Ms. Russell spoke about the local economic strengths and weaknesses, regional economic vision and goals, strategies to attain goals, connections between economic development and other city policies, regulatory environment, stakeholders and partners, the needs of your local business community, development message and staff.

Commissioner Stewart expressed frustration with the content of the information packet and stated the words "county" and "state" were never mentioned. Commissioner Stewart stated Lincoln County was unique in having a Solid Waste Authority; economic development through construction of a new hospital; and adoption of bond revenues for wind turbines.

Commissioner Willard questioned Lincoln County's economic development status as compared to other counties.

Chair Stone informed geographically Lincoln County was very rural. Chair Stone stated having economic development was important and noted at one time the Carrizozo School District was one of the largest school districts but due to the decline of development it is now one of the smallest.

14. Replacement Hospital Update

Nita Taylor, Manager informed Mike McDonald, Project Manager for the hospital construction project was not in attendance today but Thomas Garcia was present from Jaynes was here to answer any questions.

Thomas Garcia, Jaynes Corporation stated current hospital construction activities included erection of the exterior storefront curtain, HVAC ductwork and equipment, electrical gear/electoral wire pulls, mechanical and plumbing rough in, as well as drywall finishing.

Mr. Garcia informed major mile stones were reached with the installation of the underground fuel tank, the water tie in from the main, and the installation of the elevator.

Beverly Calaway, Treasurer reminded the loan documents indicated funding must be expended by March 2020.

Todd Oberheu, Chief Executive Officer for Lincoln County Medical Center stated they were working towards the budgeted donation of \$500,000, but cannot provide a hard number as of today.

Resolution 2018-57 Rights in Private Property Preservation – Stirling Spencer

Ms. Taylor stated a former County Commissioner and private land owner in Lincoln County requested the Commission consider and approve the subject resolution regarding private property preservation, including a request for the Legislature of the State of New Mexico to "reject and nullify" the enforcement of any acts in violation of the United States Constitution's Bill of Rights and the New Mexico Constitution Articles.

Kendal Wilson, local resident spoke about the need for the preservation of the rights of private property.

Motion: Adopt Resolution 2018-57, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen.

Commission Allen questioned if other counties were interested in discussing common subjects of interest. Commissioner Allen would like to form a group to discuss relevant information on the subjects the commission considers and associated resolutions.

General discussion on resolutions and the effects directly to counties.

Vote: Motion carried by unanimous vote (summary: Yes = 4).

 Discussion and Consideration of Extending an Invitation to the President of the United States to Visit New Mexico to Witness the Mexico / New Mexico Border Crisis

Ms. Taylor stated the Otero County Commission issued a letter to the President of the United States inviting him to visit New Mexico to view the border crisis. Ms. Taylor stated Otero County informed they had seen an increase in narcotics smuggling since the Border Patrol closed its checkpoints in Otero County after reassignment of staff to process migrants at the border. Ms. Taylor stated Otero County requested other New Mexico Counties join their effort in inviting the President to come to New Mexico to see firsthand the issues New Mexico counties and cities were struggling with.

Motion: Approve sending a letter of invitation to the President of the United States, Action: Approve, Moved by Commissioner Stewart, Seconded by Chair Stone.

Chair Stone Recessed the Regular Meeting 11:57 AM and reconvened at 12:59 PM

Chair Stone Recessed the Regular Meeting and convened the Public Hearing at 1:00 PM.

 1:00 PM: Public Hearing to consider Right to Work Ordinance 2018-01 Relating to Promotion of Economic Development and Commerce by Regulation of Certain Involuntary Payments Required by Employees in Lincoln County

Attorney Morel reminded Lincoln County adopted an Ordinance along with seven other counties related to Right to Work. Attorney Morel informed during the last legislative session new law was passed which placed the Lincoln County Right to Work Ordinance in violation of New Mexico State Law. Attorney Morel recommended rescinding the Ordinance to avoid law suits and noted if NM State Law changed the County could adopt another Ordinance.

Chair Stone requested public comment and receiving none adjourned the Public Hearing and reconvened the Regular Meeting at 1:04 PM.

Motion: Rescind the Right to Work Lincoln County Ordinance 2018-01, Action: Approve, Moved by Commissioner Allen, Seconded by Commissioner Willard.

Chair Stone questioned the proposed content of the letter of invitation to the President.

There was general discussion and consensus the draft letter should reflect input from the Lincoln County Commission.

Resolution 2018-60 Support of the Ratification of the United States Mexico-Canada Agreement (USMCA) and Letter of Support

Ms. Taylor reminded during the May 21, 2019 Regular Meeting the commission considered a request by the White House to participate in a conference call regarding the pending United States, Mexico and Canada Agreement (USMCA). Ms. Taylor stated the purpose of the call was to review additional information regarding the USMCA and to formally request Congress ratify the USMCA as soon as possible.

Motion: Adopt Resolution 2018- 60, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen.

Vote: Motion failed (summary: Yes = 0, No = 4, Abstain = 0).

17. Approval of Compensation Advisory Board's Recommendation to Change Pay Grade of Custodian

Ms. Taylor reminded during the May, 1, 2019 Budget Hearing the commission approved Manager's request to replace the cleaning contractor with a permanent, full time employee holding the title of Custodian. Ms. Taylor stated the Custodian position was currently a Grade 12. Ms. Taylor stated she had requested and received approval for a change to Grade 13 from the Compensation Advisory Board.

Motion: Approve reclassification of the Custodian position from a Grade 12 to a Grade 13, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen.

Vote: Motion carried by unanimous vote (summary: Yes = 4).

18. Solid Waste Update

Ms. Taylor stated the Solid Waste Department was extremely busy with day to day activities tied to the billing and collection for solid waste services in the county.

Ms. Taylor stated the Solid Waste Billing Clerk works closely with the Assessor's office to determine habitability. Once a premises was determined "uninhabitable" an exemption was approved and the property was no longer billed.

Brianna Herrera, Lincoln County Solid Waste Clerk explained the process involved to determine whether a property was uninhabitable.

Ms. Taylor stated the 300 Contiguous Acre exemption requires certification and attestation by the landowner that all solid waste on their property was disposed of by the landowner on the property. Ms. Taylor stated the County of Lincoln had received a number of complaints from residents regarding this exemption. Ms. Taylor stated understanding a number of the exemption holders also leased commercial dumpsters from Green Tree Solid Waste Authority and also disposed of some waste in County dumpsters and compactors.

Ms. Taylor stated the Solid Waste Department also still received periodic complaints from County residents about receiving bills from Lincoln County while also receiving and paying bills to Greentree Solid Waste Authority even after the County assumed solid waste collection services in January of 2016. Ms. Taylor stated in those circumstances the county bills continue to grow and eventually reach the unpaid level requiring filing of a property lien.

Commissioner Allen stated confusion arose among an elderly couple in Lincoln that owned or ran a Bed and Breakfast. Commissioner Allen stated the couple was double billed by both solid waste entities. Commissioner Allen stated the couple stopped paying the County due to a miscommunication. Commissioner Allen stated the couple believes they were paying a bill for solid waste but to the wrong entity and should not be billed for the past due amounts.

There was a general discussion regarding the billing process and the 300 acre exemption.

29. Manager's Report

- 1. Payment in Lieu of Taxes: Great news that Thursday the County received the annual PILT payment in the amount of \$1,811,096.00, exceeding the budgeted level of \$1,726,851. In addition, in July of last year, the County determined to Opt-In to the Kane County v. United States class action lawsuit to recover PILT underpayments for fiscal years 2015-2017. Earlier this week, all impacted counties were notified that the Court of Federal Claims Judgements officially became final on May 16 and process of getting claims paid from the Judgment Fund on May 29th. All counties were to reply with requested information; which Lincoln County did. The amounts of underpayment by County, with an explanation that the Class Counsel would ask for one-third of the amounts recovered. Based on those guidelines, the County may receive approximately \$46,000.
- 2. Fireworks Ban. Often this time of year, the County is in a state of high fire danger, coupled with drought conditions, and the Commission considers approving a resolution declaring a fire danger emergency. Without the factors of exceedingly high fire danger coupled with extreme drought, the conditions set for the in Ordinances 2003-06 and 2011-2 to declare a Fire Danger Emergency are not met.
- 3. American La France. The restoration of the American La France is progressing. Asset Inventory Clerk Toni Foligno and Joe Kenmore visit the restorer monthly to gauge progress. See Exhibit 6 for the current progress report. As the report states, the project has taken longer than expected to complete, and the Restorer estimates it will take until the latter part of August to complete the project. The Commission approved the project to be completed by June 30, 2019. I recommend we allow Restorer to complete the project. Joe Kenmore and Toni Foligno will be in attendance to respond to questions.
- 4. Pictometry. The Commission approved the Assessor to enter into an agreement with Pictometry for its Eagleview software. In verifying with State Procurement that the County could enter into the GSA Federal Contract for those services based on State Procurement Policy, we learned that it must first be converted into a Statewide Price Agreement. State Procurement is working on that, and anticipates completion of that task by mid-July.
- 5. Correctional Solutions Group's (CSG) proposal in response to RFP 18-19-008 Operations of the Lincoln County Detention Center the sole response received, was accepted by the Commission at its June 11th Special Meeting. Management. Members of CSG's leadership team, John Forren (CEO) and David Stanfield (COO) visited the County to meet with the Manager on June 17th and with LCDC employees on Wednesday, June 19th. Also accompanying them on this visit was Carlos Morales, who will be on-site to facilitate the transition.
- 6. Pine Lodge Fire. The Southwest Area Incident Management Team held an update meeting on June 24 at the Capitan Schools. They reported the location of the fire is 5 miles NW of Arabela and currently have 328 resources aiding in the efforts to contain it. The current size was reported to be 7,898 acres, and the total cost to date is approximately \$2.1 million. NM State Road 246 remains closed from Capitan to Roswell to public travelers; with only local residents allowed access to their homes or property.
- 7. Agreement between the County of Lincoln and the Lincoln County Deputy Sheriffs' Association. Manager and Sheriff have been in discussion with the Lincoln County Deputy Sheriffs' Association regarding the renewal / amending of the current agreement. The goal is to bring that to the Commission for approval it the July 16 meeting.

Departmental Head Updates

Joe Kenmore, Office of Emergency Services Director gave a brief update on the fires. Mr. Kenmore reported the spotted owl survey was complete

Chair Stone questioned the vehicle that was burned in the Lone Mountain Fire and if the Forest Service was conducting an investigation on the cause of fire.

Mr. Kenmore stated the cause of the fire was still under investigation.

Renee Montes, Senior Center Director stated she submitted the department's budget to the Non-Metro AAA and was waiting for contracts to come back for signatures. Ms. Montes reported they were wrapping up the 2018-2019 fiscal year end report.

Jeff Honeycutt, Road Superintendent stated the Lincoln County Road Department finished construction on a section of road from the intersection of Sequola Road and Alpine Village Road to Musketball Drive and Cedar Creek Drive.

Billie Jo Guevara, Human Resources Director stated the County still needs to fill the Road Department Operator II position and a cook position for the Ruidoso Downs Senior Center.

Little Best of the last

Ms. Guevara stated NM Finance Authority hires an outside agency to conduct an audit for payroll and reported no audit findings for Lincoln County. Ms. Guevara reminded insurance premiums will go up 5% to all employees.

Samantha Mendez, Director of Planning and Project Management stated a new subdivision was being created off Alpine Village Road. Ms. Mendez stated Jeff Honeycutt, Road Superintendent will oversee specifications of road construction to ensure they meet the subdivision ordinance standards.

20. Resolution 2018-55 Budget Adjustment FY 18-19

Ms. Taylor stated per statute counties may request adjustments to budgets to accommodate changes in financial operations during the fiscal year. Ms. Taylor stated Commission approved adjustments must also be submitted to the Department of Finance and Administration for approval.

21. Approval of Resolution 2018-56 Fee Schedule Amending Resolution 2017-31

Whitney Whittaker, Clerk informed the County Clerk, Treasurer, and the Sheriff's department are requesting approval of changes to the current Lincoln County Fee Schedule. Ms. Whittaker stated House Bill 293 effective July 1, 2019 removes the \$10.00 fee for in person non-commercial recordings. Ms. Whittaker stated the Clerks office would like to create a \$15.00 fee for electronic copies of probate files.

Beverly Calaway, Treasurer submitted a change to the \$100 fee for an Assessment and/or Property Tax List form an annual fee to a semi-annual fee.

Mike Wood, Undersheriff stated the Sheriff's office would like to add a statute mandated fee \$42.00 for Civil Service.

22. Resolution 2018-58 and Agreement to Participate in Local Government Road Fund Program, County Arterial Project, Administered by New Mexico Department of Transportation

Ms. Taylor stated during its February 19, 2019 Regular Meeting the Commission approved letters of intent to be submitted to the NM Department of Transportation for the 2019-2020 CAP, COOP, and School Bus Road Programs. Ms. Taylor stated the DOT informed they were cutting funding for both the COOP and School Bus Road Programs. Ms. Taylor stated additional funding was allocated to US 285, NM 128 and an interchange at US 285 and NM 31 which are located in Eddy and Lea County.

Ms. Taylor stated the Chief Deputy salary was set by the Lincoln County Personnel Policies and Procedures Ordinance at "a minimum of ninety-five percent of the Elected Official's salary".

Ms. Taylor stated in response to the discussion last year, Assessor Walter Hill relayed to the Commission, the matter in which the Assessor's affiliate discussed, the Assessors affiliate would be seeking legislation in the 2019 session to resolve the matter. Ms. Taylor stated no legislation was introduced during the 2019 NM Legislation Session to modify the Assessor's level of certificate pay. Ms. Taylor stated the County's Audit firm agrees that an elected official's salary, which in itself is mandated by law, cannot exceed that level.

General discussion on 2019 legislation regarding Assessors level of pay and current statute.

LeeRoy Zamora, Chief Deputy Assessor stated a discussion took place on the subject of Assessor's Incentive pay just prior to the Assessor's affiliate meeting in Clovis on Friday, June 21, 2019. This discussion was held between Affilate Chairwoman, Linda Gallegos, Affiliate Vice-Chairman, and Jesse Lucero.

Mr. Zamora stated during the initial discussion and as Assessor Hill mentioned earlier, Chairwoman Gallegos informed that her incentive pay of \$7,500 was also an agenda item that was brought before the Sandoval County Board of Commissioners. Mr. Zamora stated the board voted in favor of leaving her incentive pay at \$7,500.

Mr. Zamora stated during the 2019 summer affiliate meeting, this subject was discussed further. Mr. Zamora informed in the 2019 summer NMC Conference during the affiliate meeting it was stated by Chairwoman Gallegos that correcting the statute verbiage for Assessor's Incentive Pay from \$3,500 to \$7,500 remains a top legislative priority for the affiliate.
