#### Minutes Tuesday, May 21, 2019

Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on May 21, 2019 in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

#### 8. Forest, Land & Natural Resources Matters:

#### a. Smokey Bear Ranger District

Andrew Ellis, NEPA Planner for the Smokey Bear Ranger District reported no current fire restrictions on the District. Mr. Ellis stated district fire crews were prepping for possible pile burning and assisting the Sacramento District. Mr. Ellis stated the district conducted a field review for the Smokey Bear North Project Environmental Analysis. Mr. Ellis reported they submitted unfunded fuel reduction and watershed improvement projects to Nick Smokovich at the State's Forester's office for consideration for funding from a new state program developed under HB 266 Forest and Watershed Restoration Act.

Mr. Ellis stated the district completed work to clear sediment from under the bridge at Rio Bonito with permission from the City of Alamogordo and Army Corp permit. Mr. Ellis stated the district planned to hire two wilderness ranger interns for the summer. Mr. Ellis stated the Forest Plan Revision Assessment document was available on the Lincoln National Forest website. Mr. Ellis stated the Need for Change document, Final Assessment, and the Notice of Intent to begin the draft EIS are forthcoming this summer.

#### b. County Extension Services

Melanie Gutierrez, Lincoln County Program Director/Extension Associate reported all schools in the county attended the turf grass workshop at the Youth Getaway program. Ms. Gutierrez stated the Extension Services also attended Ag Day at the Carrizozo Schools. Ms. Gutierrez stated she would attend a two day Hemp Conference May 23 - 24, 2019 at the New Mexico Farm and Ranch Heritage Museum in Las Cruces.

Ms. Gutierrez stated they will begin tagging the fair animals for the 2019 Lincoln County Fair. Ms. Gutierrez stated she will go to the contestant's house and tag with the brand inspector rather than having the children haul the animals to a specific place.

#### c. South Central Mountain RC & D

Rick Merrick, Community Forester was unable to attend but provided copies of the April 25, 2019 Agenda and March 21, 2019 Minutes.

#### d. Upper Hondo Soil & Water Conservation District

Ms. Taylor stated no representative was able to attend this month but provided the Agenda for the April 25, 2019 Board Meeting.

#### e. LANRAC

Robert Barber, Chair of LANRAC stated the Smokey Bear Collaborative was still working with the Smokey Bear District on the Hale Lake area restoration project. Mr. Barber stated the Mountainair Collaborative learned the Cibola Forest Plan was scheduled for release around July 5, 2019 beginning a 90 day public comment period. Mr. Barber stated the planning for the Corona CFRP would be completed in June and the application initiated for the treatment areas sometime this summer.

### 9. EagleView/Pictometry Presentation Sponsored by Assessor Walter Hill - Brian

Walter Hill, Assessor stated he was seeking consideration and approval to proceed with the purchase of EagleView/Pictometry Flyover Software. Mr. Hill introduced Brian Garcia, Senior District Sales Manager for EagleView.

Brian Garcia, EagleView Senior District Sales Manager presented an overview of the software. Mr. Garcia informed Pictomety was a revolutionary digital imaging system and software program which maps each pixel of a digital image both oblique and nadir to actual geographic coordinates. Mr. Garcia stated the software allows all features in an image to be located and accurately measured. Mr. Garcia stated the software could measure distance, area, height, elevation, latitude, bearing and angle. Mr. Garcia stated the software was good for use in rural area where restricted access may present itself.

Commission Stewart questioned if this company had any correspondence with White Sands Missile Range in regard to airspace and restricted airspace.

#### 9:30 A.M.: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS (Items are for discussion only – no action will be taken)

Commissioner Stewart stated he continues to attend the Joint Land Use Study meetings. Commission Stewart stated he will attend his Induction ceremony in Holloman for his designation of Honorable Commander of 429<sup>th</sup> Tech Squadron. Commissioner Stewart stated the ceremony was set for May 31, 2019.

Commissioner Allen stated she continues to attend the Greentree Board meetings. Commissioner Allen stated Tim Roberts was promoted to the Director of Historic Sites for the State of New Mexico. Commissioner Allen also reported Mr. Roberts had informed of plans to film a movie in Fort Stanton.

Commissioner Allen stated she attended and was able to participate in a fundraiser for COPE that raised around \$34,000.

Commissioner Draper attended an event for the Juvenile Justice Board and stated it was well attended. Commissioner Draper reminded school was out and requested the public keep an eye out for children running around the area.

Beverly Calaway, Treasurer stated the tax property sale was set for July 19, 2019. Ms. Calaway stated red tagging of the properties and notice to the public were currently underway. Ms. Calaway reported her office had collected 81% of the property taxes as of April 30, 2019.

Walter Hill, Assessor stated he was happy with the outcome from the completion of the Assessor's Evaluation by the Property Tax Division. Mr. Hill expressed gratitude to Chief Deputy Lee Roy Zamora and GIS Mapper Rodney Zamora for all the help they provided with the evaluation. Mr. Hill stated he would like to push forward with the implementation of the Pictomety software and the funds would be expended from the Assessor's reappraisal budget.

Robert Shepperd, Sherriff stated the next NMC Board meeting will be in Clovis during the June annual meeting. Sherriff Shepperd stated discussion of House Bill 407 regarding the realinement of offices was on the agenda

Nita Taylor, Manager welcomed Hubert Quintana from the Southeastern New Mexico Economic Development District to the meeting.

Joe Kenmore, Office of Emergency Services Director attended a meeting with New Mexico Governor Michelle Lujan Grisham along with other local leaders in Las Cruces to discuss reimbursement for money expended to shelter and care for immigrants. Mr. Kenmore stated the meeting revolved around obtaining support for Dona Ana, Luna and Hidalgo Counties.

Karyl Williams, resident of Capitan supported Agenda Item Number 15, Resolution 2018-47 Opposing Importation of Illegal Immigrants and recommend adding the language "illegal aliens" in the Resolution.

Richard Ford, resident of Glencoe questioned if the illegals coming into the states were being vaccinated. Mr. Ford stated this County does not need the problem and supported adoption of Resolution 2018-47.

#### 11. Discussion of County Canvass Board-County Clerk

Whitney Whittaker, Clerk stated as per House Bill 407 which was effective upon signature of the Governor amending NMSA 1-13-1 states "the Board of County Commissioners may designate the Board of Registration to serve as the county canvassing board for the county." Ms. Whittaker stated the designation shall be made in the polling place resolution which was set for consideration next month.

#### 13. New Mexico Counties Insurance Authority Joint Powers Agreement and Bylaws

Mr. Taylor reminded Commissioner Stewart serves as Lincoln County's representative to the NMC Worker's Compensation and Multi-line Pool Boards. Ms. Taylor stated Commissioner Stewart was seeking direction on signing the Joint Powers Agreement in June at the annual NMC conference in Clovis. Ms. Taylor stated if supported by the Pool Board members, NMC would submit the Joint Powers Agreement to DFA for approval.

Commissioner Stewart expressed concerns about language within the articles of the agreement which envisions the Authority admitting non-county political subdivisions and local public bodies to the pools. Commissioner Stewart also questioned the language "suspends" in Article XVIII A.

Patrick Trujillo, NMC Loss Prevention Attorney presented the amendments to the Joint Powers Agreement and Bylaws which govern the Workers' Compensation Fund and the Multiline Pool.

Motion: Authorize Commissioner Stewart signing the agreement, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Draper.

General discussion on policies and bylaws of the JPA.

#### 14. Replacement Hospital Update

Ms. Taylor stated David Hughes, Assistant Superintendent, and Ernesto Rodriquez, Senior Project Superintendent were not available to present the summary of status.

Ms. Taylor stated the summary of expenses paid through April 16, 2019 with year to date expenditures was \$8,164,999.03. Ms. Taylor stated Jaynes' pending pay application for work completed in April in the amount of \$2,003,847.00 brings the total to \$10,168,846.

Attorney Morel informed he reviewed the AIA-contractor contract for construction after discussion during the May Regular Meeting. Attorney Morel stated Section 15.1.5 states the Contractor may request additional time.

16. White House Office of Intergovernmental Affairs & Public Liaison Request for Statements of Support for the United States-Mexico-Canada Agreement Signed on November 30, 2018 from New Mexico Public Officials and Businesses

Ms. Taylor stated on May 14, 2019 the White House Office of Intergovernmental Affairs and the White House Office of Public Liaison sent a broadly distributed invitation to state-wide and local officials to participate in a conference call regarding the United States Mexico Canada Agreement (USMCA).

Ms. Taylor stated the invitation contained links to additional information such as statement of support from New Mexico businesses and elected officials.

Ms. Taylor presented the revised Preliminary Fiscal Year 2019-2020 Budget based on the Commission's direction from the public hearing held on May 1, 2019.

Ms. Taylor stated after incorporating the Commission's actions during the preliminary budget hearing Lincoln County's projected ending balance over required reserve was \$4,912,326. Ms. Taylor stated during the public hearing the Board of County Commissioner's entertained requests from 17 external agencies totaling \$401,830. Ms. Taylor stated 16 requests were fully or partially approved totaling \$291,330 and full/partial funding was denied in the amount of \$110,500.

### 17. Approval of Lincoln Wind Projects' Site Permit Application for its Lincoln County Wind Energy Conversion System

Ms. Taylor stated the Lincoln Wind Projects WECS Site Permit Application was submitted to Lincoln County on April 16, 2019 to Planning Director Samantha Mendez as required by Ordinance 2017-04.

Samantha Mendez, Director of Planning stated she reviewed the WECS Application and found all requirements were met.

Motion: Approve the Lincoln Wind Projects WECS Site Permit Application, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen.

General Discussion regarding the total number of wind turbines situated in Lincoln County including the Mesa Canyon projects.

#### Presentation of Road Department 5-Year Plan – Jeff Honeycutt & David Roybal, Pettigrew & Associates

Jeff Honeycutt, Road Superintendent reported the Lincoln County Master Transportation Plan involved a study of existing road conditions in Lincoln County and identified six roads included in the study. Mr. Honeycutt stated field observations were made on May 13 and May 14, 2019. Mr. Honeycutt stated recommendations for roadway rehabilitation/maintenance shall be provided based on the calculated PCI and field observations. Mr. Honeycutt stated budgetary cost information was included for reference as well. Mr. Honeycutt stated the roads evaluated in this study were Santiago Circle Road, Sun Valley Road, Fort Stanton Road, Little Big Horn Road, Little Creek Road, and Gavilan Canyon Road.

David Roybal, Engineering Manager for Pettigrew and Associates reported the roads evaluated were two lane paved roads which mainly lie in residential areas minus Gavilan Canyon Road. Mr. Roybal stated 530 feet or approximately 1/10<sup>th</sup> of a mile was inspected for every one mile of road. Mr. Roybal stated field data was collected to record severity and extent of distress for flexible pavement. Mr. Roybal stated a total of eighteen locations were observed for a total of 18.84 miles cumulative length of roads. Mr. Roybal stated the locations for field evaluations were initially determined based on one mile intervals but later adjusted in the field due to safety concerns with existing sight distance.

#### Road Projects Submitted by Deadline Per HB 694: Creation of the Local Government Transportation Project Fund

Ms. Taylor stated long term Lincoln County partner Daniel Aguirre, Senior Vice President with Wilson and Co. Architects scheduled a "lunch and learn" with Lincoln County staff to discuss HB 694 which created the Local government Transportation Project Fund.

Ms. Taylor stated on April 30, 2019 the NM Department of Transportation Cabinet Secretary issued a "Call for Projects" to local and tribal governments who are eligible to apply for state funded grants. Ms. Taylor stated eligible projects include planning, design, and construction for highways, streets, roadways, crossings, bridges, etc. Ms. Taylor stated funding for qualified projects would cover 75%-95% of the project with the local or tribal government making up the match. Ms. Taylor informed the deadline to submit projects to SNMEDD was May 16, 2019.

Ms. Taylor informed Road Superintendent Jeff Honeycutt and Planning Director Samantha Mendez worked to identity the road/projects most suitable for these funds. Ms. Taylor stated they worked closely with Wilson and Co. to gather mapping data, determine the scope of work required for each project, and to prioritize the need for Lincoln County.

Ms. Taylor stated all submitted projects will be reviewed through a strict process listed in the Call for Projects. Ms. Taylor stated NMDOT's goal was to provide a list of potential projects to the State Transportation Commission (STC) by August 1, 2019.

Welcome to New Employees. Both the Emergency Services Department and the Road
Department hired new members to their teams in the last couple of weeks. Joining Joe
Kenmore at OES is Arron Griewahn, who has accepted the position of OES Coordinator;
as well as Dalton Lenzo, who has filled the department's temporary position, not only

during fire season, but also to help the Volunteer Fire Departments with their ISO rating requirements.

Joining Jeff Honeycutt and his road crew is Timothy Pearson, who holds the skills to fill an Operator II position.

Planning Director Samantha Mendez has advertised, interviewed and selected an individual to fill the Rural Addressing position. The hired applicant is from out-of-state and will report in early June.

Lincoln Volunteer Fire Department Chief Bennie Long and Smokey Bear's Hometown Association worked tirelessly to obtain the donations for this special memorial. The event was well attended.
- 4. <u>Bonito Lake Restoration Project</u>. Attached is the meeting Agenda for the Bonito Lake Restoration Project. These meetings are held on Thursday morning, conflicting with hospital meetings. Mr. Rob Richardson, with Bohannan Huston will join the Commission meeting in July to provide an update.

Department Head updates

Renee Montes, Senior Center Director will attend an ICIP training. Ms. Montes stated she will have to do an ICIP for every senior center. Ms. Montes stated they are in need of a handicap van and upgraded kitchen equipment in the Ruidoso Downs site. Ms. Montes is researching the placement of backup generators at each site. Ms. Montes stated this request will be in the senior centers capital outlay request.

Joe Kenmore, Office of Emergency Services Director introduced Arron Greiwahn, who accepted the OES Coordinator position and Dalton Lenzo, who has filled the OES Temporary position.

Mr. Kenmore stated the EMS conference in April held in Ruidoso was a great place to see new equipment and get the latest training.

Mr. Kenmore gave an update on the Poncho fire burning in the southeast corner of Poncho Creek Ranch. Mr. Kenmore stated it burned about a day or day and half before any department responded. Mr. Kenmore stated the past weekend was the motorcycle rally, and things went very smoothly over weekend for the event.

Solid Waste Lien filed on December 16, 2016 for non-payment of solid waste services and potential ad valorem taxes due and owing. The County's Answer to Complaint for Foreclosure was filed September 1, 2017. The U.S. Dept. of Agriculture filed its Answer to Complaint February 2, 2018 requesting the Court's findings that its Claim of Lien is a first and priority lien. Certificate as to the State of the Record and Nonappearance entered by the court on March 28, 2018 noting the nonappearance of Defendants Roy Padilla and Rita Padilla.
