Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on March 17, 2020 in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

Beverly Calaway, Treasurer reminded all funds held by the Treasurer were fully vested and collateralized at 102%.

Ms. Calaway stated the Santa Fe County Treasurer has request the Taxation and Revenue Department Property Tax Director to extend the deadline of the 2nd half property taxes, due to COVID-19. Ms. Calaway stated she had no knowledge of any other County Treasurer requesting any similar extension.

Ms. Calaway stated the Lincoln County Treasurer will not request to extend the deadline of collections. Ms. Calaway stated due to COVID-19 her staff have been provided personal protective equipment. Ms. Calaway stated her office will monitor the situation and make appropriate changes when needed.

Ms. Taylor informed Shannon Dictson was unable to attend the meeting due to New Mexico Governor's Stay at home Order.

Approval of Proclamation Recognizing April 7, 2020 as National Service Recognition Day

Ms. Taylor discussed this year's annual day of recognition for National Service is April 7, 2020. Ms. Taylor stated this date was set aside to encourage residents to recognize the significance of our national services in the county.

15. Manager's Report

Office of the State Auditor Notification to Seek Proposals for Auditor. Each year the County receives notification from the OSA reminding all agencies, including local governments, of the requirements to start the process of obtaining an Independent Public Auditor. Public bodies that fall under the tiered system, which counties do, will be able to submit a draft contract for OSA approval through the OSA-Connect Portal. Per the Audit Rule, an IPA is able to conduct an audit for a local government for six years maximum without taking a two year break. Kubiak, Melton and Associates ("KMA") has conducted the County's audit for FYs 17, 18 and 19. I recommend contracting with them again for FY20.

Motion: Enter into a contract with Kubiak, Melton and Associates for fiscal year 2020, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen.

- 2. NM Supreme Court Mental Health Summit; Lincoln County Team. Upon request to Judge Bryant for him to attend the Commission meeting following the Mental Health Summit, he confirmed he would do that. We discussed whether he was able to find another County Manager to participate on his Lincoln County Team. He needs, and is lacking, a First Responder on his Lincoln County Team, rather than a County Manager, and I propose to have Joe Kenmore participate in that initiative. As it is a three day summit, the minimal costs will include two nights lodging and meals.
- 3. Bill Fulginiti, New Mexico Municipal League President and Long Time Leader, Friend and Participant of Local Government passed away on February 26, 2020.
- 4. La France Update. While Toni Foligno, Inventory Assets Clerk and Joe Kenmore, Emergency Services Director have routinely scheduled meetings with Ray Seidel, there are a number of months they have been unable to schedule or conduct an inspection. Although in March, Mr. Seidel responded by telephone that beginning in April, he and others will work the first week of each month for several months to bring it to condition to have painted; and predicted that progress would go quickly after that. We are not confident that will happen, as there has not been substantial progress on the restoration work since April 2019. We recommend seeking other alternative measures to restore the vehicle and bring that back for Commission consideration.
- 5. Disclosure Summary due March 31, 2020. The County has contracted with Loretta Garcia of Accu-Disclosure to prepare the final Disclosure Summary for the County's outstanding public debt. Per Ms. Garcia, "the summary includes a list of the bonds outstanding, the tables required to be updated annually, the due dates and actual filing dates and the links to all the documents that have been posted to EMMA on the County's behalf for the past five years. The County is in material compliance with its disclosure obligations." Ms. Garcia reminded that private placement

debt financed through the NMFA, or a banking institution is now required to be posted on EMMA within 10 business days. The County granted permission for her to work with bond counsel or directly with NMFA or bank for the proper documentation, and make the required EMMA posting.

- 6. Pattern Timeline. Pattern has released an updated timeline for the DURAN MESA LLC / TECOLOTE WIND LLC / RED CLOUD WIND LLC PROJECT. The current activities, March 17th hearing commences at page 6. The timeline calls for finalizing PILT negotiations on April 1, 2020 and finalizing the closing documents at the April 21st Commission meeting.
- 7. Purchase of Replacement Network Server for Lincoln County Government. During the FY19-20 budget cycle, Finance requested, and the Commission approved, the replacement of the existing Network Server, which was installed seven years ago.
- 8. Capital Outlay Projects HB349. Governor Lujan Grisham passed HB349 on March 11, 2010. All four of the County's requested projects were funded, as summarized below. See Exhibit 6 for a summary of all requests by all entities in the County. Seven of the requests were line-item vetoed, with all targeted to have been allocated out of the General Fund. The remainder of approved requests will be funded by Severance Tax Bonds.

Commissioner Allen suggested sending a thank you note to the Governor.

- 9. County Labor Relations Attorney Dina Holcomb notified that the State Board chose to revoke approval of the County's Local Labor Board on the basis that our Board, which had not been firmly established, had not yet met to adopt the Open Meetings Act Resolution. That delay of the full establishment of the County's Board was tied to the third appointed member being a Public Employee, not meeting the criteria of state law. It is most likely that this action was taken by the State Board due to anticipated passage of the changes to the Public Employee Bargaining Act defined by SB110, which would essentially eliminate all local boards.
- 10. COVID 19 has been declared a public health emergency not only by the President of the United States, but also by The State of New Mexico, and many other states, municipalities and counties across the country. Released by Governor Lujan Grisham on Sunday, March 15th is a directive to all state agencies to accelerate remote-work initiatives in the wake of the COVID-19 public health emergency and to temporarily adjust and in some cases suspend certain functions of government to minimize public health risks.

The Governor has encouraged local governments to follow suit and implement telework policies for as many employees as possible; and take other steps to limit person-to-person contact in order to emphasize social distancing.

Mandated school closures have posed a hardship on families unable to obtain childcare. Counties are addressing that circumstance in several ways:

- Grant administrative leave on a case-by-case basis to an employee who cannot find child care;
- Authorize vacation or sick leave to care for children at home due to school closures. If sick leave, waive the requirement for certification by a physician for an absence greater than three days;

- Approve leave or make accommodations for remote work from home, if feasible;
- d. If unable to utilize remote work and the leave balances are exhausted, employee may apply for Emergency Administrative Leave. The County reserves the right to recoup this time from the final paycheck of employees who terminate before they rebuild their accrued sick time.

Motion: Direct Manager to waive the requirement for certification by a physician for an absence greater than three days, Action: Approve, Moved by Chair Draper, Seconded by Commissioner Stewart.

There was a general discussion regarding New Mexico Governor's stay at home order and how it would affect the operations of the County of Lincoln.

Chair Draper rescinded his motion, Commissioner Stewart rescinded his second.

Ms. Taylor reminded during its January 28, 2020 meeting the Commission was briefed by Alex Fuller, Rural Addressing Technician, on the initial compliance requirements tied to the revised Lodger's Tax Ordinance. Ms. Taylor informed the County identified 148 unregistered listings and was able to get 48 of those registered by the January Commission meeting.

Alex Fuller, Rural Addressing Technician reported as of March 9, 2020, the County had registered 108 listing out of the 148 from the original list. Mr. Fuller stated the County of Lincoln had 65 total Lodgers registered encompassing 241 individual cabins. Mr. Fuller stated a second list of 35 additional unregistered lodgings had been compiled and letters were sent to the residents. Mr. Fuller stated 7 of the 35 replied and are now registered.

Mr. Fuller stated Host Compliance identified, as of January of this year, 651 listings and 377 unique properties in the unincorporated areas of the County and found that the median nightly rate was \$215. Mr. Fuller stated the Lodgers tax collected could be \$796,068.

Eric Brown, Host compliance joined by teleconference and provided a short presentation on their Address ID services.

There was a general discussion regarding the Host Compliance Service Agreement.

Motion: Enter into a Service Agreement with Host Compliance for one year, Action: Approve, Moved by Commissioner Allen, Seconded by Commissioner Willard.

Vote: Motion carried by unanimous vote (summary: Yes = 4).

11. 9:30 A.M.: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS (Items are for discussion only – no action will be taken)

Commissioner Stewart informed he will attend a Joint Land Use Study meeting on April 1, 2020.

Commissioner Allen stated will attend a Greentree meeting this week. Commissioner Allen informed the Solid waste issue with Mr. Spiri was resolved.

Commissioner Willard stated he will attend the Southeastern New Mexico Economic Development District meeting.

Whitney Whittaker, Clerk informed the County Clerk's office will take all the necessary steps in order to keep the staff safe during the COVID- 19 issue. Ms. Whittaker stated the 2020 Presidential Election was June 2, 2020 and we will have to keep the office operational due to the federal restrictions on elections.

Beverly Calaway, Treasurer stated the 2nd half of the property taxes notices were mailed out. Ms. Calaway stated there was an issue of fraudulent activity or scam the County caught prior to any payments being sent. Ms. Calaway stated the scam could have cost the County a large amount of money, but was glad it was caught early.

Robert Shepperd, Sheriff stated they will not shut down any operations due to COVID-19 but prepare the deputies and staff with proper protective equipment. Sheriff Shepperd stated the Court facility staff will take precautionary actions to prevent the spread of the virus but will not shut down operations.

Walter Hill, Assessor stated the 2020 Notices of Valuation will be mailed on April 1, 2020, with the statutorily mandated 30-day protest period ending on April 30, 2020. Mr. Hill stated correspondence will be handled strictly by email, phone, fax or postal mail.

Chair Draper informed he will host a webinar with community members, municipalities, and other elected officials at 1:30 PM by invitation only to discuss the COVID-19 crisis.

Robert Shepperd, Fair Board Member informed there was no events scheduled at this time to rent the fair building.

Chair Draper stressed the importance of the census and the impact it will have to the County.

Approval of Proclamation Commemorating the Carrizozo Woman's Club's 100
Years of Community Service on April 20, 2020; and Declaring April 20 as Carrizozo
Woman's Club Day

Ms. Taylor stated the Proclamation commemorating the Carrizozo Woman's Club's 100 years of community service on April 20, 2020 and declaring April 20th as Carrizozo Woman's Club Day in Lincoln County. Ms. Taylor informed the proclamation détailed the services provided by the Carrizozo Woman's Club over time to individuals and families in need and defined the fundamental principles of the Carrizozo Woman's Club.

Motion: Adopt the Lincoln County Commission Proclamation Commemorating the Carrizozo Woman's Club 100 year of community service, Action: Approve, Moved by Commissioner Stewart, Seconded by Commissioner Allen.

Replacement Hospital Update

Ms. Taylor informed Ernesto Rodriquez, Lead Project Superintendent was not able to attend the meeting. Ms. Taylor stated the most recent change order was to add emergency power to the imaging equipment and the project was out of the design stage and was being priced out by Jaynes. Ms. Taylor informed the actual construction cannot start until after the Temporary Certificate of Occupancy is awarded; but it was critical the equipment was ordered as early as possible. Ms. Taylor stated they requested a 20% variance of \$100,000 due to the circumstances the costs are higher for this change order.

Ms. Taylor stated the most recent pay application submitted by Jaynes was dated March 5, 2020 in the amount of \$868,734.77 bringing their total invoiced amount to date to \$25,780,075.88. Ms. Taylor stated based on their contractual sum, the balance left on their portion of this project is \$2,620,888.12.

There was a general discussion regarding Bobby George, Lead Architect from Dekker Perich Sabatini and whether the equipment should have been listed in the list of projected construction expenses.

Motion: Approve up to \$160,000 for change order, Action: Approve, Moved by

Commissioner Allen, Seconded by Commissioner Stewart. Vote: Motion carried by unanimous vote (summary: Yes = 4).

Yes: Chair Draper, Commissioner Stewart, Commissioner Allen, Commissioner Willard.

Chair Draper informed Village of Ruidoso set up a daycare at the Horton Complex with lunch and afternoon snack for the employees at the Lincoln County Medical Center.

20. Lincoln County Detention Center Update

Ms. Taylor stated significant progress had been made in arriving at an agreement on methods to reduce transports between the Detention Center and the County Courts by utilizing video arraignments.

Ms. Taylor stated the major concern was the transportation of an inmate from Lincoln County to another county within the same day.

Ms. Taylor stated the Detention Center had posed two suggestions for the County of Lincoln to consider; obtain assistance from the Sheriff's office for transportation and establish a single point of contact in the Sheriff's office to work with the Detention Center on numerous matters. Chair Draper recesses the regular meeting at 10:33 AM and reconvened at 10:43 AM

21. Approval of Cost of Care Agreement

Ms. Taylor stated the County's current agreement with the County of Bernalillo for housing of Lincoln County Juveniles would expire on June 30, 2020. Ms. Taylor stated the cost of the housing is \$225 per day, or any fraction of a day, per detainee. Ms. Taylor stated detainees that required enhanced supervision based on high suicide risk, mental health acuity or other high-risk behavior, to include hospital details requiring one on one staffing, will be charged a daily rate of \$300 per day.

Ms. Taylor stated the City of Ruidoso Downs, by email correspondence from Carol Virden, Village Clerk/Administrator, had no issues with the renovations.

20. Lincoln County Detention Center Update- continued

Robert Shepperd, Sheriff stated it would be less expensive to hire another officer in order to help the Detention Center with transportation. Sheriff Shepperd stated the Legislation this year approved a new Judge for the 12th Judicial District Court and their office will have to accommodate for those hearings.

Joe Kenmore, Office of Emergency Service stated LCDC has been checking temperatures and monitoring signs of the flu within the facility.

Solid Waste Update

Ms. Taylor stated the compactor move from Buckhorn to the Glencoe Fire Station will advance now that the weather is suitable to pour concrete. Ms. Taylor stated the County departments overseeing the project are the Road Department, Planning and Project Management, and Emergency Services

Ms. Taylor informed prior to issuing the RFP in September, 2016 to pick up slash piles for Lincoln County, substantial field work had been done by the Planning Department to identify the number and location of the slash piles. Ms. Taylor stated the Planning Department identified 4,800 cubic yards of slash located in 375 piles within the geographic boundaries of Lincoln County. Ms. Taylor stated an estimated 91 square mile area encompassed the following subdivisions; Cedar Creek, Alpine Village, Alto Crest, Ranch Ruidoso Valley Estates, Ranches of Sonterra, Loma Grande and Angus.

Ms. Taylor sated the modification for solid waste collection ordinance has been heard through several commission meetings regarding the billing of multiple habitable premises, used primarily for either a private or business purpose; and whether their property owner should be able to file for an exemption if the premises were not being used not generating trash.

There was a general discussion regarding the waiver of the Solid Waste Collection Fee.

Crystal Coffman, Business Development Manager for Pattern Energy joined through teleconference. Ms. Coffman provided a presentation on the status of their wind energy activities in Lincoln County and surrounding counties. Ms. Coffman stated the first project to be implemented in the County would be Red Cloud Wind. Ms. Coffman presented a side by side comparison of the Mesa Canyons Wind project for 1,000 MW with the Red Cloud Wind project for 80 megawatts and pointed out the difference in the Commission approved PILT of \$2,800 per megawatt for Mesa Canyons and \$2,100 per megawatt for Red Cloud. Ms. Coffman explained the reason for the reduce PILT payment was Pattern had a loss of 20% on their federal Production Tax Credit. Ms. Coffman stated 100% of the megawatts in Lincoln County for Red Cloud are entirely within the Corona School District.

Commissioner Stewart questioned the calculations of the PILT.

Ms. Coffman stated economic status was based upon an 80% PTC valuation.

Ms. Coffman stated she would be happy to provide impacts. Ms. Coffman informed the offer was also made to all three counties.

Commission Willard asked if other counties had agreed to project proposal.

Ms. Coffman stated Guadalupe County Commission will meet in April and Torrance County will meet next week.

Attorney Morel questioned why the proposal wasn't brought to the Commission earlier.

Ms. Coffman stated development is always changing.

Commission Willard proposed \$2,400 per megawatt for PILT payment.

Attorney Morel raised concern about adopting items in the ordinance not yet agreed on.

Don Monnheimer, legal counsel for Pattern Energy joined telephonically stated the bond ordinance itself is complete, we just need to put the PILT payment in. Mr. Monnheimer stated the IRB lease can be completed after the ordinance is adopted.

Attorney Morel questioned if the ordinance cannot reflect an agreed upon PILT price for the future, how does it benefit the Commission if they cannot change it in the future.

Mr. Monnheimer stated to move on a schedule that coordinates.

Eduardo Duffy, Sutin Thayer and Browne bond counsel to Lincoln County proposed a continuation of the public hearing to a date certain.

Chair Draper requested public comment and having none adjourned the Public Hearing and reconvened the Regular Meeting at 1:34 PM.

Eduardo Duffy, Sutin Thayer and Browne bond counsel to Lincoln County questioned if the Tecolote Wind LLC was an operational project or a place holder.

Ms. Coffman stated it was a place holder in order to change the name if needed when selling the energy.

Commissioner Allen questioned why another industrial bond for the same project.

Ms. Coffman stated when Pattern first started the project it had a bond already associated.

Commissioner Stewart question the relationship between Pattern, Sun Zia and NMR.

Ms. Coffman stated 3,000 megawatts of wind farms that are to be located in Lincoln, Guadalupe and Torrance, Pattern is the sole owner. Ms. Coffman stated there are two available transition lines; Western Spirit and second one which is owned by NMR – Southwest Power Group. Ms. Coffman stated they own 100% of the Sun Zia transmission line. Ms. Coffman stated Pattern was awarded megawatts on the Sun Zia line as anchor tenants.

Chair Draper requested public comment and having none adjourned the Public Hearing and reconvened the Regular Meeting at 2:32 PM.
