# Minutes Tuesday August 17, 2021

Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on August 17, 2021, in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

#### 8. Forest, Land & Natural Resources Matters:

Smokey Bear Ranger District

Camille Howes, Smokey Bear District Ranger spoke on distributing Fire Fighter Teams across the nation to deal with the PL5 (planning level 5) maximum level of wildland fire activity. District Ranger Howes stated there were no active fires in Lincoln County.

b. Lincoln County / NMSU Extension Services

Melanie Gutierrez, County Program Director stated the Lincoln County Fair sales of livestock valued at \$190,600.00 plus \$44,000.00 in add-ons for a grand total of \$234,600.00; Ms. Gutierrez stated that was one of the highest sales ever recorded. Melanie Gutierrez spoke on the State Fair preparations and school outreach enrichment projects.

Manager Pearson stated he attended the Lincoln County Fair, and it was very well attended by the public.

Melody Gaines, Family & Consumer Science/4H Agent expressed the appreciation and support from community.

c. State Forestry - EMNRD

Robert Barber, Chair of LANRAC spoke on the Lincoln Nation Forest Plan being posted, the Forest Service accepting public comment until November 5, 2021, and future public meetings. Robert Barber stated the draft of the final decision for the Cibola National Forest will be posted for public comment within the next 60 days. Robert Barber spoke on meeting with Fish and Wildlife to regarding final draft and public comment to be scheduled in the fall.

Commissioner Proctor questioned the status of the grant regarding the restoration of the Lincoln National Forest in Otero County.

Robert Barber stated the project was on schedule despite weather and slowdowns from Covid. Manager Pearson spoke on the draft EIS (Environmental Impact Statement) and appreciation of Robert Barbers' updates and efforts for the county.

d. South Central Mountain RC & D

Robert Barber stated the district is looking at hiring a new community forester to oversee the WUI's, and grants.

e. Upper Hondo Soil & Water Conservation District Commissioner Willard questioned the reports and was looking forward to future updates.

Mr. Crain stated if Lincoln County accepts this request, it would be such a big relief to us as an organization.

Manager Pearson stated being a fiscal agent will require the County of Lincoln to provide some administrative work and fiscal oversight. Manager Pearson stated additional personnel might be needed to perform the duties and responsibilities in taking on the task of being a fiscal agent for Healing America's Heroes.

Eddy Crain Presented on Healing Americas Heroes Organization and request for the County of Lincoln to become a fiscal agent.

# 9:30 A.M.: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS (Items are for discussion only – no action will be taken)

Commissioner Allen reported on Old Lincoln Days 80th year.

Commissioner Proctor stated he attended the Interstate Stream Commission meeting along with others via Zoom on July 21, 2021. Commissioner Proctor stated he attended the Lincoln County Fair.

Whitney Whittaker, Lincoln County Clerk stated Regular Election Candidate Filing day to be September 24,2021 from 9:00 am to 5:00 pm.

Walter Hill, Lincoln County Assessor stated they were currently working on protest and in the process of hiring.

Beverly Calaway, Lincoln County Treasurer stated the previous Thursday night the Capitan School Board held a special meeting to discuss the consideration and approval of an amended resolution for Capital Improvement Tax Ballot Question which would have appeared on the Nov 2, 2021, Local Election. Treasurer Calaway stated after weeks of discussion regarding the resolution, the Capitan School Board voted unanimously to remove the 2021 tax year from the resolution. Treasurer Calaway stated the 2021 property tax will follow the regular billing cycle scheduled for Oct 20, 2021 and distribution to all Lincoln County Entities will proceed per state statute. Treasurer Calaway stated the Lincoln County bills will be mailed Nov 1, 2021, become due Nov 10, 2021 and become delinquent after Dec 10, 2021. Treasurer Calaway shared her appreciation for the Commissioners and Capitan School Boards time and efforts. Treasurer Calaway stated she received two letters, one from the DFA confirming Capitan's School District

Mil Leavy Resolution and from the Property Tax Division confirming to proceed with regular scheduled procedures.

Geraldine Martinez Undersheriff stated there were no current updates.

Manager Pearson stated there was communication with Robert Barber through the Zoom chat regarding Soto Road and that Robert Barber would work with Judy Brock regarding updates.

### 10. Healing America's Heroes Presentation- continued

Eddy Crain continued presentation on Healing Americas Heroes.

#### 11. AOC / Ruidoso Magistrate Court Update - Judge Daniel A. Bryant

Honorable Judge, Daniel Bryant stated they will be looking at a completion date for the Ruidoso Magistrate Court and determining a date for later in month regarding a public hearing. Judge Bryant spoke on the increase of the cost of steel due to the Covid pandemic and instead using a more traditional wood structure for the project. Judge Bryant spoke on the design and placement to increase parking spaces through layout.

Tim Dodge Village of Ruidoso spoke on working with the AOC.

Jason Clack Administrative Offices of the Courts spoke on working with the Village of Ruidoso in adjusting the site plan for multiple benefits. Mr. Clack spoke on funding for the project. Allan Morel County Attorney inquired on when remodeling and accommodations would be needed.

Mr. Clack stated due to the facilities being a county owned the architectural teams would need to get together to coordinate a site plan. Mr. Clack stated the facility in Ruidoso may be completed first but could work on both simultaneously.

# 13. Lincoln County Detention Center Update - Warden, Scott Colvin

Scott Colvin, Warden Lincoln County Detention Center stated the detection center booked 120 and released 106 for July 2021 and booked 65 and released 70 in August 2021. Warden Colvin stated the current count had been 79 with 66 county inmates and 13 federal inmates. Warden Colvin stated in July 2021 there were 3 minor uses of force with no major injury with 2 of them being breaking up inmate altercations. Warden Colvin stated there had been 3 inmates on suicide watch. Warden Colvin reported 4-unit searches conducted with 1 positive Covid inmate and 0 staff for July 2021 and 1 positive Covid inmate and 1 staff resulting in testing for all staff for August 2021. Warden Colvin reported 1 inmate on suicide watch and 1 minor use of force for the month of August 2021 with 1 unit search and 1 fire resulting in 0 injuries. Warden Colvin stated the first Covid 19 Vaccine clinic was held on August 6, 2021, with 18 inmates and 2 staff members receiving the vaccine. Warden Colvin spoke on appreciation for book donations and preparing the GED program for startup. Warden Colvin provided an update on the life skills program. Warden Colvin spoke on reviewing and selecting vocational programs. Warden Colvin spoke on the RISE program.

Commissioner Willard inquired on the American rescue funds and the body scanner.

Manager Pearson spoke on the capital outlay for the detention center equipment provided by the State of New Mexico and selecting a body scanner which may include a temperature scanner.

Commissioner Proctor expressed appreciation of a tour of the facility provided by Warden Colvin.

# 14. Lincoln County Medical Center Update - Todd Oberheu

Todd Oberheu, Hospital Chief Executive LCMC poke on the increase in Covid cases within Lincoln County. Mr. Oberheu stated all 6 ICU beds were full of 3 being COVID cases at a total of 9 Covid Patients, with a total hospital capacity of 50%. Mr. Oberheu stated on average there were 8 to 9 positive cases through the testing facilities daily. Mr. Oberheu stated they were holding a final Pfizer vaccine pod and would start offering doses only from clinics. Mr. Oberheu stated they are willing to come to any of the clinics if at least 6 doses can be scheduled. Mr. Oberheu stated the Moderna vaccine is available in all the clinics except for Hondo and Corona. Mr. Oberheu stated they are unable to get the Johnson and Johnson vaccine at this time due to shortage.

Mr. Oberheu stated since July 2021 82% of positive cases at the hospital were not vaccinated. Mr. Oberheu stated since June 2021 84% of positive case were not vaccinated. Mr. Oberheu stated hospital is operating well with staffing being the main concern.

Brief discussion regarding staffing and hours of operation in Corona and Hondo.

# 15. Manager's Report

Manager Pearson presented:

1) Rain / Floods and an Email Complimenting the Road Department

In late July, I received an email from Matthew Midgett (please see attachment). Matt sent pictures of the water running near Cherry Creek Road after a significant rainfall. He wanted to send his thanks for the responsiveness of both Jeff Honeycutt and David Munro to his maintenance request.

2) O-Bar-O Road Update

The Road Department started working on the lower part of O-Bar-O road. The questionable private property signs have been removed from this section of the road. The signs are still posted, in the County ROW, along the last 1.5 miles of the road.

3) NMSU Extension Office Installs 4H Signs

Melanie Gutierrez and Melody Gaines have been installing the new 4H signs around the county. There is a welcoming sign on every major highway entering Lincoln County.

4) Visit to White Oaks Communication Tower - Carrizo Mountain

On August 6, 2021, Joe Kenmore and I visited the White Oaks communication tower on Carrizo peak. Joe performed routine maintenance while explaining the communications set up. Most of the equipment you see in the picture was abandoned by the previous owners of the tower site. Previous County Manager, Tom Stewart, secured this tower site to help with emergency communications.

5) Paving Ft Stanton Road

On July 26, 2021, all hands were participating in the paving of Ft Stanton Road. The Sheriff and many deputies helped with traffic control while Renegade Construction started paving the Ft Stanton / highway 48 intersection. Road Department, Sheriff Department - Thank you!!

# Approval to Combine Planning and Solid Waste Departments – Creating a Department of Public Works

Manager Pearson stated On September 7, 2020, the Lincoln County Planning Department had five employees in five positions:

- Director of Planning \$44,000 / year \$72,000 w/benefits
- GIS Specialist \$44,000 / year \$72,000 w/benefits
- Addressing Technician \$35,000 / year \$55,000 w/benefits
- Ordinance Administrator \$39,000 / year \$59,000 w/benefits
- Indigent Coordinator \$44,000 / year \$72,000 w/ benefits

Manager Pearson stated the GIS Specialist employee took another position within the county. Manager Pearson stated GIS was combined / absorbed into the Road Department's Administrative Assistant position (Savings of over \$50,000 / year).

Manager Pearson stated the Addressing Technician has been vacant since October of 2020. Manager Pearson stated the county kept this position with the idea of having a Solid Waste / Ordinance Code Enforcement.

Manager Pearson stated the Director of Planning resigned in May of this year. Manager Pearson stated this vacancy allowed the Manager's office to review the duties and workload of the position.

Manager Pearson stated the Solid Waste Director position has not been filled since the creation of the position in May of 2021. Manager Pearson stated this position pays \$44,000 / year - \$72,000 with benefits.

Manager Pearson stated I am proposing to combine the Planning and Solid Waste Departments, creating a Public Works Department.

Manager Pearson stated the Department would have one director that is a non-classified employee. Manager Pearson stated a yearly contract would guide the terms of employment. Manager Pearson stated the job description is written to attract qualified and experienced applicants in the field of Public Works. Manager Pearson stated if hired at the high end of the pay scale (\$85,000 / year - \$108,000 w/benefits), the County would still save \$30,000 - \$40,000 per year in salary and benefits by combining the two positions.

Manager Pearson recommended the approval to combine the Planning and Solid Waste departments to create a Department of Public Works.

Commissioner Crunk spoke on the need and benefits of having the Department of Public Works position.

Commissioner Proctor spoke on the workload and benefits of the Department of Public Works position.

Motion: Approve the Public Work position, Action: Approve, Moved by Commissioner Willard, Seconded by Commissioner Allen.

Vote: Motion carried by unanimous roll call vote (summary: Yes = 5).

Manager Pearson stated Julie Anne Leonard canceled presentation

# 18. Approval to Demolish the Glencoe Canyon Trading Post Building

Manager Pearson stated he met with Joe Kenmore yesterday and went extensively through the building. Manager Pearson stated he took some pictures and e-mailed them. Manager Pearson spoke on the condition of the building. Manager Pearson spoke on the alternative of selling the building and it not being a viable option due to layout. Manager Pearson spoke on the multiple issues, not being up to code, and estimate of \$300,000 to fully repair. Manager Pearson spoke on the \$27,000 estimate and that it may cost more due to size and shutting off utilities and a more accurate estimate may be \$40,000 to \$50,000. Manager Pearson spoke the general estimate repair and use the building as an extension of the fire station being approximately \$350.000. Manager Pearson recommended demolishing the building.

Joe Kenmore spoke on the building last having a meeting 2 years prior.

Motion: Approve the demolition of the Glencoe Canyon Trading Post Building, Action: Approve, Moved by Commissioner Willard, Seconded by Commissioner Allen.

# 19. Off-Highway Vehicle NMSA Statue Discussion - County Commissioner, Jon Crunk

Commissioner Crunk lead a brief discussion on OHV (Off Highway Vehicle) uses in Lincoln County, statues, and recommendations for passing an ordinance

# 20. Sun Valley Fire Station Update - County Manager, Ira Pearson

Manager Pearson spoke on the acquired loan and the future fire funds to pay for the building. Manager Pearson stated the original contract sum was \$1,120,000 for the fires station. Manager Pearson stated as of June 25, 2021, a certified copy from Roper's Construction was received. Manager Pearson stated the previous payout with the architect at the time was \$46,789 in June 2020. Manager Pearson stated to finish the original 1.2 million dollars the was \$120,000 left to

complete the original contract. Manager Pearson stated Pettigrew had been asked to complete a site plan, fix the driveway access, retaining wall, and parking area. Manager Pearson stated Roper Construction submitted \$284,379.40 as the addition cost to complete the work proposed by the architect. Manager Pearson stated the additional work is \$284,379.40 and the original contract has \$120,000 to complete the original contract. Manager Pearson spoke with Rick Hall, Joe Kenmore, and Pettigrew and all agreed that the cost was reasonable for the project. Manager Pearson stated Joe Kenmore recommended applying for a fire grant to complete the project. Manager Pearson stated he recommended completing the project and working with Roper Construction to finalize the project.

There was a brief discussion on the initial project.

Manager Pearson spoke on the interior remodeling requested through WIC for the Department of Health

Margie Blatnik, Southeast Project Manager WIC spoke on the interior renovation request and it being solely for the WIC area. Ms. Blatnik spoke on the operations workflow and remodeling request.

# 23. NMDOT - County Road Superintendent, Jeff Honeycutt:

 Approval to Submit a Completed Application for the New Mexico Department of Transportation Federal Fiscal Year 2023+ Transportation Alternatives Program (TAP) for Magado Creek Pedestrian Bridge and Trail

Jeff Honeycutt, County Road Superintendent stated the County match for the TAP application is at a 14.56% match of \$65,174.05, and the Federal match is at \$382,449.95 for the Magado Creek Pedestrian Bridge and Trail at a total project cost of \$447,624. Mr. Honeycutt stated an asphalt trail would be placed behind the arena along with the bridge. Mr. Honeycutt stated a meeting was held with State of New Mexico and Wilson & CO and had turned in the PFF which will be evaluated and voted on in the upcoming meeting on September 8, 2021.

#### 25. Cannabis Ordinance Review and Discussion

Attorney Morel spoke on creating a written memorandum regarding zoom meetings held to discuss the statues and ordinances the counties of New Mexico can and cannot implement. Attorney Morel spoke on the differences of counties who have zoning and do not have zoning regarding regulation through state law. Attorney Morel stated a consolidated ordinance with other counties has been created to review. Attorney Morel recommended scheduling a public hearing for adopting the proposed ordinance.

Chair Stewart spoke on sections 5.1 and 5.2 regarding proximity of residence and simplification.

Commissioner Proctor spoke on the clarification and working with the Sherriff's Office.

Motion: Place the Cannabis Ordinance Review and Discussion on Public Hearing, Action: Approve, Moved by Commissioner Allen, Seconded by Commissioner Proctor.

There was a brief discussion on growth and consumption regulation.

# 26. Approval of Sale and Issuance of Quitclaim Deed of Vacated Soto Road to the JoAnn Hall Family Trust and MP Chavez and Corina Chaves

Manager Pearson stated In December of 2008, the Board of County Commissioners vacated Soto Road located in the Valley East Estates off Gavilan Canyon Road. Manager Pearson stated Soto Road had never been established and the Hall Family Trust had it vacated. Manager Pearson stated that currently the trust still owns the property and a portion by the Chavez's. Manager Pearson stated property is currently attempting to be purchased from the trust but a deed cannot be issued as it was never sold by the county. Manager Pearson stated the plat dedicates the property to Lincoln County and Lincoln County does own it. Manager Pearson stated through the Assessor the true assessed value for the Halls Trust is approximately \$7,000 dollars and MP Chavez is approximately \$3,600. Manager Pearson stated through Assessor Hills note regarding the property not being buildable, a very small tract of land, and only useable by the owners the market value is not feasible in the appraisal. Manager Pearson stated Mr. Hills estimate would be approximately \$1,000 an acre calculating the Halls Trust portion to \$269 and the Chavez portion to \$138.

Attorney Morel stated the County must process the road through the Road Review Committee which had been completed in 2008. Attorney Morel stated fair market value now must be received for the property provided by the Assessor. Attorney Morel spoke on getting the two legal descriptions to complete the Quitclaim Deeds.

Manager Pearson Spoke on the owners providing the two legal descriptions.

Attorney Morel stated the Hall Family Trust tract was .269 acres at \$269 and the Chavez Tract .138 acres at \$138 requiring the two separate legal descriptions.

# New or Updated Matters since last report \*

- Board of County Commissioners of Lincoln County v. Roger Romero D-1226-CV-2018-00055 Complaint for Foreclosure. Complaint was filed February 20, 2018. Defendant Roger Romero filed an Answer to the Complaint asserting a Counterclaim to be filed in the U.S. District Court on April 2, 2018. A Judicial Inquiry Hearing took place September 4, 2018. A Disposition Order for Lack of Prosecution was entered on August 25, 2020. An Order Reinstating Case was entered on October 19, 2020.
- 2. Roger Romero v. State of New Mexico D-1226-CV-2018-00113 (Underlying Cases are: Board of County Commissioners of Lincoln County v. Roger Romero, D-1226-CV-2018-00055, and State of N.M. v. Roger Romero M-30-MR-2016-00142) A Petition for Writ of Habeas Corpus was filed requesting that the Judgment & Sentence entered by Judge Vega in Cause No. M-30-MR-2016-00142 be vacated and set aside. George Romero's Answer to Complaint and Counterclaim was filed April 30, 2018 in Cause No. D-1226-CV-2018-00055. On February 26, 2019, an Order Setting Aside Conviction was entered by Judge Counts.

On March 25, 2019, a Notice of Appeal was filed with the N.M. Supreme Court, Case No. S-1-SC-37602 On January 8, 2021, the Supreme Court entered its Dispositional Order of Transfer transferring the case to the Court of Appeals for consideration and review. The case is still pending.

On January 28, 2021, a Dispositional Order was entered transferring the case to the NM Court of Appeals for consideration and review. Case No. A-1-CA-39446 The case is still pending.

- 3. Romero, et al. v. Stone, et al, Cause No. D-1226-CV-2019-00271 Request for Appointment of Guardian Ad Litem for Plaintiffs and Complaint for Violation of Civil and Constitutional Rights, Negligence, Prima Facie Tort and Wrongful Taking was filed on October 9, 2019 along with a Jury Demand. Lisa B. Riley is the presiding Judge. On May 7, 2021 Defendants filed their Motion to Dismiss in Lieu of an Answer. The case is still pending. A Hearing on Defendants' Motion to Dismiss is scheduled to take place on August 26, 2021 @ 2:00 p.m.
- 4. Brd. of County Commissioners of Lincoln County v. Amerisourcebergen Drug Corp., et. al U.S. Dist. Court Case No. 2:19-cv-00462 Complaint for Public Nuisance, Violations of Racketeer Influenced and Corrupt Organizations Act (RICO)... filed on May 20, 2019 by Attorneys Robles, Rail & Anaya, P.C., et. al. After receiving no oppositions to the transfer of the case, on June 17, 2019, the case was transferred to the Northern District of Ohio noting that as of December 5, 2017, 1,534 cases have been transferred to Ohio for further proceedings. The case is still pending.
- 5. <u>City of Albuquerque, et al vs. John Monoforte & N.M. Taxation & Revenue Department, Cause No. D-202-CV-2018-08036</u> Judge Franchini is the presiding judge. Lincoln County has entered into an Agreement for joining in the litigation to recover amounts representing unauthorized reductions in violation of New Mexico Statutes. On November 14, 2019, Lincoln County joined in the litigation. Mediation took place on April 28, 2021 before retired Judge William Bustamante at which time, settlement did not occur. The case is still pending.
- 6. Greentree Solid Waste Authority v. Lincoln County, Cause No. D-1226-CV-2014-00095 Compromise and Settlement Agreement and Release executed on December 17, 2015.

  7. Richard Ford v. Terry A. Colwell, II, et al, Cause No. D-1226-CV-2020-00104 Complaint for criminal trespass, theft, misappropriation of monies and violations of civil rights was filed by
- for criminal trespass, theft, misappropriation of monies and violations of civil rights was filed by Gary C. Mitchell on May 11, 2020. Lincoln County was served on May 29, 2020. On June 26, 2020, the case was removed to the U.S. District Court and, on March 30, 2021, the case was remanded back to the 12th Judicial District Court for further proceedings. The case is still pending.
- 8. Alto Lakes Golf & Country Club v. Smile 4 U, et al, Cause No. D-1226-CV-2020-00184
  Complaint to Foreclose Lien was filed on September 1, 2020 and an Amended Complaint to

Foreclose Lien was filed to add the County of Lincoln as a Defendant. The County filed its Answer to the Complaint on October 23, 2020. On October 26, 2020, an Entry of Default as to Defendant Smile 4 U was entered. The case is still pending.

- Jacob Scott v. Lincoln County Board of Commissioners, Brack Rains and Unknown Defendants, Cause No. D-1226-CV-2021-00001 Complaint for Negligence and Negligence Per Se and Deprivation of Constitutional Rights was filed on January 1, 2021. Lincoln County has yet to be served with the Complaint.
- 10. <u>State of New Mexico v. Ohlin Skeen, Cause No. D-1226-CR-2020-00038</u> Criminal Complaint alleging aggravated battery, false imprisonment, interference with communications, etc. Lincoln County has filed a Motion for Reconsideration of the Court's Order to House the Defendant at Otero County Detention Center. The case is still pending.
- 11. <u>Lincoln County, ex rel, Greentree Solid Waste Authority and May Mansfield vs. Sierra Contracting, Inc. et al, Cause No. D-1226-CV-2020-00081</u> Complaint Under Fraud Against Taxpayers Act was filed by Zach Cook and Victor Marshall on March 31, 2020. On September 17, 2020, Plaintiffs filed their Notice that Qui Tam Plaintiffs are proceeding with this action. The case is still pending.
