Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on August 16, 2022, in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

This meeting was conducted on a platform for video and audio.

1. Call to Order

Chair Stewart called the Regular Meeting of the Board of County Commissioners to order at 8:30 AM.

8. Presentation – Turning Food Waste to Energy – Russ Guillete

Manager Pearson stated Mr. Russ Guillete could not attend but will provide an update at a later date.

9. Forest, Land & Natural Resources Matters:

Smokey Bear Ranger District

Jennifer Thomas, acting District Ranger, stated she is looking forward to working with the County of Lincoln.

b. Lincoln County / NMSU Extension Services

Melanie Gutierrez, NMSU Extension Services stated success in the 2022 Lincoln County Fair. Ms. Gutierrez provided statistics of the animals and participation. Ms. Gutierrez thanked all the sponsors and community members with their involvement.

c. South Central Mountain RC & D

Laura Doth, Coordinator stated they have begun to seed the area of the burn scares. Ms. Doth stated they waited to seed until after monsoon season.

Ms. Doth informed of a new opportunity Community Wildfire Defense Grants. Ms. Doth indicated the grants are intended to help at-risk local communities and Tribe's plan and reduce the risk against wildfire. Ms. Doth stated there are two primary project types for which the grant provides funding; the development and revision of Community Wildfire Protection Plans and the implementation of projects described in a Community Wildfire Protection Plan that is less than ten years old.

Commissioner Crunk entered the meeting via Zoom at 8:44 AM

d. Upper Hondo Soil & Water Conservation District

Robert Barber, Board of Supervisors reported they will begin to work in Nogal with EWP due to flooding. Mr. Barber stated the EWP in the Hondo Valley came across issues and they are currently working with the engineers for solutions. Mr. Barber reported the district has a signed an agreement with the county for weed treatment Mr. Barber stated the vinegar concentration stronger this year from a 12% to 15% dilution.

e. LANRAC

Robert Barber, Board Member stated the U.S. Fish and Wildlife Service announced the opening of a public comment period on the Draft Environmental Assessment for the Designation of Critical Habitat for the Peñasco least chipmunk. Mr. Barber stated a 30-day public comment period will allow the public the opportunity to review and comment on the Environmental Assessment (EA), which includes a description of the proposed action and anticipated impacts.

15. Region IX Funding Presentation – Bryan Dooley

Bryan Dooley, Region IX director informed New Mexico Early Childhood Education and Care Department announced that it has awarded funding to qualifying entities around the state of New Mexico. Mr. Dooley stated this funding will help stabilize childcare businesses impacted by the COVID-19 pandemic by improving enrollment and retaining childcare professionals, and more importantly increase access to quality childcare for New Mexico families. Mr. Dooley stated they are finalizing the proposal for COVID Fiscal Recovery Funds and would like to get it under consideration with the County Commission. Mr. Dooley is proposing a new centralized location in Mechem for the new facility. Mr. Dooley stated the four locations we had are being relocated and finding adequate space has been an issue.

Mr. Dooley stated Region IX has invested \$500,000 towards the childcare facility.

Commissioner Proctor questioned the location of Region IX and who all they serve in the State of New Mexico.

Mr. Dooley stated Region 9 Education Cooperative has provided direct services to children and families and support services in the surrounding area. Mr. Dooley sated the service area includes Capitan, Carrizozo, Cloudcroft, Corona, Ruidoso, Hondo, and Tularosa school districts and communities.

13. Lincoln County Medical Center Update - Todd Oberheu

Todd Oberheu, Hospital Chief Executive provided an update on the facility. Mr. Oberheu stated Dr. Yildiz from General Surgery will soon be replaced by Dr. Rosales. Mr. Oberheu stated oncology is going well with Dr. Agbemadzo coming twice a month. Mr. Oberheu stated space is becoming an issue but that is a good issue to have and will discuss at a later date. Mr. Oberheu stated Presbyterian recently hired Scott Crawford at the Capitan Clinic. Mr. Obergue stated Mr. Crawford was apart of the nurse practioner program and is glad to have him aboard.

Mr. Oberheu stated the Hondo clinic was now open 3 days a week; Monday, Tuesday, and Wednesday, Mr. Oberheu stated they are averaging around 12 patients a day.

Chair Stewart asked about the Mil Levy outreach.

Mr. Oberheu stated a lot of the outreach will be in conjunction with the 50-year anniversary with Presbyterian through social media and some news outlets.

Commissioner Willard question the number of Covid patients.

Mr. Oberheu stated this last month he has seen a rise in Covid patients, but the severity of the illness is not as bad, but still a concern. Mr. Oberheu stated there is currently no monkeypox reported in the county.

Commissioner Willard questioned the parking lot.

Mr. Oberheu stated there was a mis design that has resulted in flooding in the handicap area. Mr. Oberheu stated they are working with DTS and Jaynes to determine the best solution, but in the meantime, there is a sub pump that will drain when necessary.

10. 9:30 A.M.: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS (Items are for discussion only – no action will be taken

Commissioner Allen stated she will continue to attend Greentree meetings.

Commissioner Willard attending a meeting with the County Manager, the Village of Ruidoso, and Senator Ben Lujan regarding the flooding and FEMA.

Commissioner Proctor reported he attended a meeting on Forest Road July 21, 2022, at 1:00PM. Commissioner Proctor stated Camille Howes, Smokey Bear District Ranger did an outstanding job orchestrating the meeting in concern to bridges and roads with regards to emergency services.

Commissioner Proctor stated he attended the 2022 Lincoln County Fair.

Commissioner Crunk stated continued efforts to seek 2 or 3 business owners to be appointed to the New Mexico Department of Workforce Solutions. Commissioner Crunk stated there are a lot of programs that would benefit county wide.

Commissioner Crunk stated the received a visit from FEMA encouraging people to sign to help protect property from floods.

LeeRoy Zamora, Chief Deputy Assessor provided an update on the reappraisal program. Mr. Zamora stated the County shall physically visit, inspect, verify, and gather physical data. Mr. Zamora stated employees are at the 3rd week of inspections and estimates the physical phase completion to be another few months. Mr. Zamora stated once complete will provide an update to the commission.

Beverly Calaway, Lincoln County Treasurer reported on delinquent home verification. Treasurer Calaway stated the physical process of id the properties can be difficult due to the mobilization of the structures.

Treasurer Calaway reported a healthy balance with reference to page one of the general fund balance. Treasurer Calaway referenced page thirteen of the financial report, stating an error with the interest rate on local government investment pool. Treasurer Calaway stated they are currently negotiating with the banks for a higher interest rate. Treasurer Calaway stated cash held was \$32,732,167.75 as of July 31, 2022.

Treasurer Calaway referenced page 20 of the tax schedule maintenance report. Treasurer Calaway reported 96.75% of the property tax collections. Treasurer Calaway stated they will be getting the tax rate September 1st and once checked will then schedule a special meeting to certify the tax rates.

Michael Wood Lincoln County Sheriff reported some statistics for the month. Sheriff Wood reported 304 calls for service, 23 arrests, 11 traffic investigations and 186 civil papers. Sheriff Wood stated the 2022 Summer New Mexico Sheriffs' Association conference will be held at the Ruidoso Convention Center & MCM Elegante Lodge Hotel, Ruidoso, New Mexico.

Manager Pearson referenced the 3 nominations for local businesses and could make an agenda item for next meeting.

Commissioner Crunk stated the zoom quality was poor.

Whitney Whittaker, Lincoln County Clerk reported our historical clerk of 20 years, Karen Mills retired. Clerk Whittaker stated she is going to be missed, and the office will be hiring for the position in the future. Clerk Whittaker stated she would like to add and change the current job description to add more duties. Clerk Whittaker stated she will approach the commission for approval when complete.

David Vandenberg, resident stated we are facing some serious times. Mr. Vandenberg stated statistics and data are available to show that things are falling apart. Mr. Vandenberg stated these things are happening due to poor leadership.

Tracie Johnson, Enchanted Forest resident wanted to thank Lincoln County for assistance regarding a well.

Keith Kull, The Ranches spoke to events happening at the Lincoln County Fair.

Ted Bridgman, The Ranches spoke to events at the Lincoln County Fair regarding business transactions and stated he emailed extension office. Mr. Bridgman discuss a timeline of events that went on at the county fair this year.

Mark Fischer spoke to the 3.6 billion wind farm project and asked why support.

Gaylon Farrington, Legacy Estates wanted an update regarding the Concrete Batch Plant.

James Townsend, State Representative spoke tow SB 105 and stated will provide public comment during public hearing.

David Fresquez, Landowner in Arabela stated he didn't get letter for road closure EO40 in enough time to make appropriate accommodations. Mr. Fresquez discuss the inconvenience of the road closure by no access for cattle and no detour available as well as the maintenance of the current road.

Alan Fresquez, Landowner in Arabela stated the road needs caliche and continued maintenance.

Chair Stewart recessed public comment and convened the regular meeting at 10:02AM.

Chair Stewart recessed the regular meeting and convened the public hearing at 10:03AM.

11. 10:00 A.M.: PUBLIC HEARINGS:

a. Authorizing the Issuance and Sale of Lincoln County, New Mexico Taxable Industrial Revenue Bonds (Pattern SC Holdings LLC Project), Series 2022A, in an Aggregate Principal Amount not to Exceed \$3,600,000,000 (The "Bonds"); to Provide Funds to Finance the Acquisition, Construction, Equipping and Installation of Wind Energy Facilities to be Constructed in One or More Phases for the Purpose of Generating Electricity and Located Within the County but Outside the Boundaries of any Incorporated Municipality; Authorizing the Execution and Delivery of an Indenture, a Lease Agreement, a Bond Purchase Agreement, a Sublease Agreement, the Bonds, and Other Documents in Connection with the Issuance of the Bonds; Making Certain Determinations and Findings Relating to the Bonds; Ratifying Certain Actions Taken Previously; and Repealing all Actions Inconsistent with this Ordinance

Attorney Morel informed the public hearing would take place as advertised today but is requesting no action from the commission until further information is retained from Pattern.

Jeremy Turner, Pattern Energy provided a PowerPoint presentation. Mr. Turner stated over \$3.5 billion been invested in New Mexico, they have a set up headquarters out of Albuquerque with field offices in Curry County and Corona. Mr. Turner stated they are responsible for over 60 permanent jobs in the development of the wind facility operation. Mr. Turner stated Pattern Energy had successfully developed and financed over 1,600MW of wind and transmission projects in New Mexico.

Mr. Turner explained for consideration the Lincoln County Mesa Canyons Wind IRB. Mr. Turner stated this is not to exceed \$3.6 billion and is approximately 1225 MW with a total anticipated Payments in Lieu of Taxes (PILT) based on 1225 MW + agreed upon \$110 million over 30 years to the County and Schools.

Mr. Turner reminded about the Industrial Revenue Bond Distributions for the school districts. Mr. Turner stated an aggregate amount equal to the amount received by the county multiplied by the percentage determined by dividing the average of the operating, capital improvement and bond mills imposed by the school districts in the county and state debt service mills as of the date of issuance of the bonds by the average of the mills imposed by all entities levying taxes on property in the county as of such date. Mr. Turner stated this is shared among the school districts located with the county equally, they are not to be less than the amount due to the school districts in the tax year immediately preceding the issuance of the bonds from the property included in a project,

had such project not been created. Mr. Turner stated then the County receives remaining amount, likely 60-65%.

Commissioner Allen stated the energy is purchased by California and not used in New Mexico.

Commissioner Proctor questioned how many fulltime employees in Lincoln County.

Mr. Turner stated they have 7 full time employees in Lincoln currently.

Commissioner Proctor questioned the State Land Office Leases with Pattern Energy.

Mr. Turner stated the land is multi-use with two (2) areas that are outstanding, but the lands are available for grazing. Mr. Turner stated the revenues flow to state.

Mr. Fischer, resident, and candidate for County Commission District 5 spoke in opposition to the IRB. Mr. Fischer questioned the overall interaction and functionality with the County. Mr. Fischer spoke to the regulations regarding the endangered species and the number of restrictions imposed on us and would like to see figures and research studies pertaining to the wind farms.

Representative James Townsend expressed his concern with the IRB bond. Representative Townsend stated the IRB rule was developed to promote employment and it was a way to get around the anti-donation clause. Representative Townsend stated the farms have brought great jobs to New Mexico, but they have also been a huge benefit for Pattern. Representative Townsend suggested an evaluation of the PILT. Representative Townsend stated nobody should take the first bid on anything. Representative Townsend stated the wind farms are more incredulous, arguing that the expected benefits would not justify the cost in the loss of tax revenues.

Gary Popplewell, Lincoln County resident stated he was a project engineer for a major corporation. Mr. Popplewell stated these wind turbines usually end up becoming permanent fixtures due to the amount of material use at the beginning construction. Mr. Popplewell questioned the tax rates and how they would be identified. Mr. Popplewell quoted the Constitution "We the People of the United States, in Order to form a more perfect Union, establish Justice, ensure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity."

Mr. Popplewell questioned the maintenance of the roads from the heavy machinery use.

Francesca Herrera Public Works Director questioned the disposal when the product becomes unusable.

Through general discussion the disposition of turbines was stated to be built into the ordinance agreement.

Chair Stewart adjourned the public hearing at 10:35AM and convened the Regular Meeting.

Motion: Approve the readvertising of public hearing for next month's meeting, Action: Adjourn, Moved by Commissioner Allen, Seconded by Commissioner Willard.

Chair Stewart recessed the regular meeting until 10:41AM and convened the public hearing at 10:41 AM

b. Public Hearing on an Application for a Telecommunications Tower- Applicant Seeks to Amend the Previously Approved Conditional Special Use Permit and a Variance for Setback and Other Items from the Lincoln County Wireless Regulations as Stated in Ordinance 2012-03 An Ordinance Regulating Wireless Communications Facilities

Manager Pearson stated applicant is proposing to build a new 125' Monopole Tower with antennas, radios and low-profile mounts that are not in a stealth configuration and are requesting an amendment for a future 10' extension to a revised height of 135'

Kevin Winner, Gravity Pad, stated they are finalizing the fall zone easement. Mr. Winner stated the adjacent landowners have agreed to the reduction from the fall zone impacts.

Robert A. Naumann, Center for Municipal Solutions stated based on the previous information provided and the revised application materials received CMS recommends the following conditions of approval:

- As a condition of approval for the reduced setback (20'), applicant shall provide an executed easement as submitted (150') to the County / CMS for review and approval prior to the commencement of construction.
- Applicant shall not utilize the pad and pier foundation as provided in the structural analysis but may use a pad and pier design if it is submitted to the County / CMS for review and approval prior to the commencement of construction.
- County approves the reduced future capacity loading as documented in the structural analysis.

Chair Stewart adjourned the public hearing and reconvened the Regular Meeting at 10:51 AM.

12. Lincoln County Detention Center Update - Warden, Scott Colvin

Scott Colvin, Warden provided statistics on monthly arrests, daily population, and releases for the year of 2022. Warden Colvin stated the General Information System project will be online soon and it is looking forward to integration and benefits from the software. Warden Colvin stated soon after the completion of the General Information Project they will begin to integrate the Electronic Landing System. Warden Colvin stated this system will upgrade the security in the facility.

14. Manager's Report

- Gavilan Canyon Flooding July and August rains have been devastating to the Gavilan Canyon area. On August 9th, 1.5" of rain fell causing infrastructure damage to: Private property, County of Lincoln roads and property, Village of Ruidoso roads and property, PNM lines, Zia Gas distribution lines.
- Senator Ben Ray Lujan Visit on August 15, 2022, Senator Ben Ray Lujan visited Lincoln County. Commissioner Willard and Ira will provide update.
- ROV Route Update NM Game and Fish has notified me that the ROV route has been successful. Residents and tourists are learning the route and are complying with the law.
- 4) McBride Fire Update Several residents have received letters from law firms regarding the McBride fire. The letter is stating that PNM could possibly be responsible for the fire.
- 5) FEMA Insurance Rating Meeting on July 26th, representatives from FEMA visited Lincoln County. Cynthia McKenzie stated that Lincoln County was nominated to participate in a Flood Insurance Rating Program (Hazard Mitigation). This program allows the county residents to benefit from mitigation efforts by receiving lower insurance premiums. Commissioner Crunk and I will be researching the benefits to homeowners if we follow this program.
- 6) Bonito Creek Clean up Meeting on July 21, 2022, Camille Howes organized a meeting to view the amount of debris in the Bonito creek area. Most of the debris

is from the Little Bear fire. A tentative plan was discussed, and action items were given to individuals. Most of the property is owned by the City of Alamogordo.

- 7) Enchanted Forest Update Statewide Drilling (well company from Alamogordo) inspected the main well in the Enchanted Forest subdivision. Water was located at 500 feet. Th well is 1250 feet deep. The pump and motor need to be replaced. The entire well casing needs to be descaled and cleaned.

a. Gavilan Canyon Turn Lane Update

Jeffery Honeycutt, Road Superintendent Renegade construction won the bid and construction on Gavilan, will begin on Monday, August 22, 2022. Superintendent Honeycutt stated Gavilan will be closed with the following detours at Warrior Drive and Barney Luck. Superintendent Honeycutt stated NMDOT will also have a project starting on the same day for highway 48. Superintendent Honeycutt suggested a contract to reinstall culverts.

 Superintendent Honeycutt stated due to the rain hitting the burn scares on Gavilan there has been a lot of clean up in the area. Superintendent Honeycutt reported approximately 200 dumb trucks of debris removal.

19. Discussion and Direction Regarding the Feasibility of Pooling Resources, and to Participate with the State and Other Counties and Municipalities to Support the Development of A Regional Treatment System to Help Those Suffering From Opioid Use Disorder Within New Mexico

Attorney Morel stated that State and local leaders can invest in evidence-based programs to combat opioid use disorder (OUD) when they understand how to prevent overdose deaths, provide treatment, and ensure that communities have the resources they need most effectively. Attorney Morel stated the County would get \$188,000 a year for a total of 8 years.

Attorney Morel stated the deadline to decide the route is September 2, 2022.

Manager Pearson stated under the agreement the county would be responsible for all accounting.

Manager Pearson informed the Board of Directors of the New Mexico Finance Authority ("NMFA") met on June 23, 2022, to approve the final terms, structure and conditions of Colonias

Infrastructure Funding in the amount of \$1,000,000 to the Lincoln County ("County") for its Water Infrastructure Project. Manager Pearson stated this action is a result of the Colonias Infrastructure Board recommendations approved on May 24, 2022, where the approved funding structure consists of a 10% loan in the amount of \$100,000, and a 90% grant in the amount of \$900,000. Manager Pearson explained the loan component is a 20-year term at interest rate of 0% and the loan and grant are to be used by the County for the construction including a new subsurface stormwater drainage system, and roadway improvements.
