Minutes of the Regular Meeting of the Lincoln County Commission held at 8:30 AM on July 19, 2022, in the County Commission Chambers, Lincoln County Courthouse, in Carrizozo, New Mexico.

#### 9. Forest, Land & Natural Resources Matters:

a. Smokey Bear Ranger District

Camille Howes, Forest Service, introduced Jennifer Thomas who would be the temporary fill in until her position was filled. Ms. Howes spoke on the debris from the Little Bear fire 10 years ago which was washing down into the Bonito River. Ms. Howes presented Certificates of Appreciation to Nick Herrera, Jeff Honeycutt, Joe Kenmore and Ira Pearson.

# 8. Approval of Children, Youth and Families Continuum of Graduated Sanctions Agreement # 21-690-3200-20839 (LCJJB)

Judge Bryant gave a brief history of the formulation of the Juvenile Justice Boards throughout the State. Judge Bryant spoke of the savings incurred by the decrease in juvenile incarcerations due to the program's success. Judge Bryant explained the breakdown in communication over the last three years and the fixes planned for the near future.

Chief Judge Angie Schneider, Vice-Chair of the Juvenile Justice Advisory Committee, shared her support for the program and was looking forward to the positive changes expected to take place as the program progresses with the new leadership at the State level.

Melanie Gutierrez, extension agent, informed on the many activities which had taken place over the last month.

Laura Doth gave an update on the flood mitigation efforts after the fires.

d. Upper Hondo Soil & Water Conservation District

Robert Barber spoke about the waddles and grass seed needed and planned for the area for both flood mitigation and other needs. Mr. Barber explained they found a solution to the problem they had with the extreme price of the vinegar, so they were able to order some from Dallas at a much cheaper price and at a higher quality.

# 10. 9:30 A.M.: PUBLIC COMMENT AND OTHER BUSINESS FROM COUNTY OFFICIALS (Items are for discussion only – no action will be taken)

Commissioner Allen continues to attend the Greentree meetings.

Commissioner Willard attended the Ruidoso Hondo Valley Chamber of Commerce Banquet last month and shared the plaque which was received for the reduction of about 24,000 kWh as a result of the transition from the old hospital to the new hospital and other energy efficiency measures which were taken.

Commissioner Crunk spoke of the lack of insurance and un-insurability of properties in the area.

Whitney Whittaker, Lincoln County Clerk, stated there were two Independent Candidates that signed up for the General Election. One signed up to run for House District 56 and the other signed up to run for County Commissioner District 5.

Walter Hill, Lincoln County Assessor, commended his staff for completion of the protest period.

Beverly Calaway, Lincoln County Treasurer, recognized the budget team and their hard work and dedication. Treasurer Calaway stated they had already received 96% of the projected collections even without the delinquent tax sale. Treasurer Calaway informed the cash held by the Treasurer was \$33,767,162.20.

Michael Wood, Lincoln County Sheriff, shared statistics from his office over the last 30 days.

Jim Spiri, Lincoln County Resident, spoke about his discontentment with some youth in the area and hoped something positive would come out of the CYFD/LCJJB agreement.

Galen Farrington, Lincoln County Resident, spoke of his opposition to the concrete batch plant which is planned for the Alto area.

David Vandenberg, Lincoln County Resident, expressed his concerns for the residents and youth of Lincoln County and shared his hope for more community involvement in the many different areas of need.

Chair Stewart recessed the Board of County Commissioners and convened the Public Hearing at 9:56 AM.

#### 11. 10:00 AM PUBLIC HEARINGS:

a. Variance of Ordinance 2006-6: Lincoln County Outdoor Advertising Regulation Ordinance an Ordinance Establishing Restrictions and Prohibitions to Promote Safety of Travelers Along Certain Highways, to Prevent Visual Pollution of Those Highways Through Regulation of Outdoor Advertising, to Protect the Investment in Public Highways and Private Property Values; Defining Areas to be Regulated; Making Restrictions on Signs and Billboards; Requiring a Permit Prior to Construction or Alteration; Providing for Exceptions; Prohibiting Abandoned and Dangerous Signs; Providing for Removal of Non-Compliant Billboards, and Establishing Penalties for Violations; Providing for Ordinances in Conflict Herewith and for the Severability of Parts Hereof; Providing an Effective Date;

and Repealing Ordinance 2004-10 Requested by BW Gas and Convenience LLC (DBA Allsup's) and Clovis Sign Service, Inc.

Manager Pearson explained the request for a variance in the height restriction of the new Allsup's sign.

Derrick Fowler, Clovis Sign Service, explained the need for a taller sign to allow for customers to pull into the convenience store in a safer manner.

Commissioner Allen stated she did not feel a taller sign would be seen any sooner than the sign which is currently there. Commissioner Allen expressed her concerns since it was a scenic area.

Commissioner Crunk shared his thought of placing billboards further down the highway to make drivers aware of the upcoming store sooner than a taller sign would be able to.

Attorney Morel explained the purpose and content of the ordinance.

Marvin Green, Regional Manager of Allsup's stated his concern of accidents if the sign was not allowed to be raised.

Commissioner Willard expressed his support for the sign variance and questioned other signs in the area which were taller than the ordinance allowed.

Commissioner Proctor reiterated the previous statements that a sign further down the road before the turnoff would be more beneficial than one taller at the site.

Gary Popplewell, resident of Ruidoso, would like to hear from the Sheriff as far as safety.

Sheriff Wood stated he agreed with the previous comments that a sign in either direction further down the road would be more beneficial in allowing people to slow down and be ready to stop.

Chair Stewart adjourned the Public Hearing and reconvened the Board of County Commissioners at 10:20 AM.

Chair Stewart deferred to the Commissioner in the District and shared his concern of the Hondo Valley being very historic and scenic.

**Motion:** Adopt the variance based on safety issues for that location due to the visibility and the traffic response to the visibility to make it a safer intersection, **Action:** Approve, **Moved by** Commissioner Crunk, **Seconded by** Commissioner Willard.

Commissioner Allen questioned the safety concerns and the advantage of the taller sign compared to the current sign.

Marvin Green, Regional Manager of Allsup's, stated his biggest concern is safety and he believed a taller sign would be a benefit.

Derrick Fowler, Clovis Sign Service, stated his belief that it was more important at night to have the taller sign than during the day.

Don Eldred, District Manager of Allsup's, agreed the concern was more for the traffic going East than the West bound traffic. Mr. Eldred stated he did receive comments at the store pretty regularly from people headed East.

\*BUDGET ADOPTION HEARING IMMEDIATELY FOLLOWING ITEM a.\*

 Consideration of Adoption of the Final Budget, Fiscal Year 2022-2023 by Resolution 2023-03 Chair Stewart recessed the Board of County Commissioners and convened the Public Hearing at 10:30 AM.

Manager Pearson explained a few things which were discussed during the preliminary budget and were to be brought back at the final budget meeting to include Elected Officials salaries, employee salaries and modified work schedules.

Chair Stewart was ecstatic and commented he had been doing this since 1998 and this was the best budget he had ever seen.

Treasurer Calaway added a hats off to the Commissioners for their fiscally responsible natures and attention to the budget as a whole.

The Commission was provided breakdowns of different salary percentages of 2%, 4%, and 6% for employees and 6% for elected officials.

Commissioner Proctor stated he believed the employees needed to be taken care of but with some precautions since the price of things was increasing so drastically.

Chair Stewart mentioned with the 6% for employees last year and a 4% this year it would take them to the current consumer price index and 6% this year would take them over.

Commissioner Allen recommended 4% for both employees and elected officials so elected officials did not receive a larger raise then the employees.

Treasurer Calaway reminded the Elected Officials are locked into their salary for 4 years and will not receive an increase, so she recommended considering a 6% raise for the Elected Officials.

Chair Stewart commented he liked the thought of 4% for both employees and Elected Officials, however Commissioner Willard stated he liked the thought of 6% for both employees and Elected Officials because they didn't want to lose any of the employees.

Manager Pearson stated the current personnel policy allowed Elected Officials and Department Heads to allow flexible schedules as needed which would be a beneficial recruiting and retaining tool for employees.

Chair Stewart applauded the ability to come together and allow flexible schedules as long as the County Offices remained open five days a week, however he stated it may be time to start looking at schedules and holidays to see if maybe the County could go to a 4-day work week in the future to help with hiring and retaining employees.

Assessor Hill stated he felt a 6% for both employees and elected officials would be beneficial for hiring and retaining employees. Assessor Hill stated his office would benefit from flexible schedules during times of reappraisals when they had to be out in the field and lose time traveling.

Chair Stewart mentioned they need to be open with the public about the possibility of going to a four-day work week and consider that option for the future.

Chair Stewart adjourned the Public Hearing and reconvened the Board of County Commissioners at 10:54 AM.

Motion: Approve a 6% employee increase and a 6% Elected Official increase, Action: Approve, Moved by Commissioner Willard, Seconded by Commissioner Crunk.

Chair Stewart clarified the raise for the employees would take effect on the next full pay period and the raise for the Elected Officials would only affect the newly appointed officials.

Mr. Honeycutt explained the Schedule A road agreement with the Lincoln National Forest Service and the maintenance of various roads.

Attorney Morel stated his office would work directly with the Road Superintendent and the Forest Service to bring specific documentation for each of the roads back to the Commission.

 Approval to Award a Contractor for the Right Turn Lane Project on Gavilan Canyon and Highway 48.

Mr. Honeycutt informed the low bidder for the project was Renegade Construction which came in under the budgeted amount.

Robert Barber, Chair of the Road Review Committee, explained vacating the portion of road has no effect on access to public land or to any other private land.

### 14. Lincoln County Detention Center Update – Warden Scott Colvin

Scott Colvin, Lincoln County Detention Center Warden, explained there was a slight up-tick in incarcerations post COVID. Warden Colvin stated he had been the Warden of the Detention Center for two years and was planning on many more good years ahead with the help of the Commission and the County. Warden Colvin updated on the various training programs being held for the detention center employees. Warden Colvin also spoke on the RISE program and the recidivism in the County Detention Center.

#### 15. Lincoln County Medical Center Update - Todd Oberheu

Todd Oberheu was unavailable for the meeting.

### 16. Workforce Innovation and Occupational Act (WIOA)

Eastern Area Workforce Development Board Presentation

Beth Elias, Executive Director of the Eastern Area Workforce Development Board, informed the Commission on the roles and responsibilities of the Board within the Eastern area of New Mexico under the guidance of the Chief Elected Officials.

 Consideration and Approval of Eastern Area Grant Agreement – Program Year 2022

Ms. Elias informed the Commission they had an opportunity to provide input based on community need as to how the dollars were to be allocated.

Chair Stewart authorized Commissioner Crunk to sign the agreement.

### 23. Enchanted Forest Water System Update - Tracie Johnson

Tracie Johnson, Enchanted Forest, stated she and Jonelle Ingram had been working tirelessly and were finally able to get approval for a Mutual Domestic Water Association. Ms. Johnson informed they were on the list for 2 ICIP Grants however they would not be available until 2024. Ms. Johnson spoke on the requirements from the New Mexico Environment Department and the Office of the State Engineer regarding the supplemental application to Jack Johnson's well.

Manager Pearson explained the ARPA use of funds with a focus on improving and fixing the system.

**Motion:** Authorize the repair of the well up to \$32,000 as an emergency with the use of ARPA funds, **Action:** Approve, **Moved by** Commissioner Willard, **Seconded by** Commissioner Proctor.

Vote: Motion carried by unanimous roll call vote (summary: Yes = 5).

Yes: Chair Stewart, Commissioner Allen, Commissioner Willard, Commissioner Crunk, Commissioner Proctor.

Chair Stewart recessed the Board of County Commissioners at 12:10 PM and reconvened at 12:45PM.

#### 17. Manager's Report

- 1) Update Buckhorn Compactor on July 6, 2022, Sierra Contracting notified the County of Lincoln that the Buckhorn compactor has been moved to the new site.
- 2) Update Trading Post Building Has Been Demolished on June 30, 2022, we received notice that the Trading Post on Highway 70 had been demolished. All debris had been removed and the site was level.
- 3) ROV Route Update The signage for the new ROV route has been installed. NM Game and Fish and Village of Ruidoso have been notified.
- 4) Fire Debris Cleanup Update Brian Samson (OES Office) has been a tremendous help in coordinating the cleanup efforts from the McBride and Nogal fires. FEMA will reimburse 100% of the costs associated with the cleanup (until August 2).
- 5) Construction Continues on the Sun Valley Fire Station As supplies become available, Roper construction is nearing the completion of the Sun Valley Fire Station. We anticipate substantial completion near the end of August.
- 6) Municipal League City Manager's Meeting on June 23rd, I was invited to speak at the City Manager's meeting in Ruidoso. About 30 attendees listened to the fire response from both the County and the VOR. The Municipal League has asked that the VOR and County attend their annual conference to speak about counties and cities working together to better their communities September 1, 2022
- 7) Enchanted Forest Update on June 24th I visited Roosevelt County to meet with their County manager and department directors. I learned that they had recently completed building a new "road shop" for \$625K. This building is similar to what is needed when Lincoln County moves the Road Department to the Capitan Fairgrounds area.

#### 18. Public Works Department:

a. Approval for Management Authority to Correct and Adjust Solid Waste Accounts

Manager Pearson explained the authority would only be to correct mistakes in billing, not to issue or authorize credits.

**Motion:** Approve managements authority to correct and adjust solid waste accounts, **Action:** Approve, **Moved by** Commissioner Allen, **Seconded by** Chair Stewart.

Joe Kenmore, Office of Emergency Services Director, spoke on the purpose of the grant and the use of the new building.

Manager Pearson explained the building would be very beneficial during emergency situations as a general place for everyone to be. Manager Pearson stated the grant was a 100% reimbursement grant.

# 20. Discussion and Direction Regarding Business Licenses in Lincoln County – County Attorney, Alan Morel

Attorney Morel explained the reasoning behind business licenses and stated the fee was set at a maximum of \$35 by statute. Attorney Morel stated there would be an exemption for agricultural businesses.

Manager Pearson explained he was more interested in contact information of the businesses within the County to allow for follow-up on different benefits available to them and as a general way to know what businesses are out there and he stated he was not interested in regulating the businesses or collecting the business license fees.

#### 21. Consolidated Dispatch Update - County Attorney, Alan Morel

Attorney Morel stated the consolidated dispatch would be at the new Horton Complex. There was a lengthy discussion surrounding the consolidated dispatch and if there was a need for a joint power's agreement or a simple agreement.

Mr. Kenmore stated he was in agreement as long as he had a seat on the board and had some say.

#### 22. Consideration of Resolution 2023-07 a Resolution Calling on the New Mexico Legislature to Enhance the Faith of the Voting Public in Election Outcomes Through Improved Election Process

Whitney Whittaker, Lincoln County Clerk, stated agrees there is a need for a resolution however the resolution as written is not good for Lincoln County.

# 24. Discussion and Direction Regarding a Lincoln County "Red Flag" Ordinance – Commissioner Elaine Allen

There was a lengthy discussion on red flag ordinances and their need or use. Attorney Morel stated he would need to do more research on the legality of the ordinance as presented.
