## ADMINISTRATIVE REPORTS

Mayor Johnson reported that Trick or Treating hours for Machesney Park will be on Saturday, October 31 from 4-7 p.m. Because Halloween falls on the weekend this year, the adjustment in the hours will allow for two additional hours of daylight which will contribute to the safety of our Machesney Park families and children. If you do not want to participate, please turn off your lights and close your door.

Attorney Tom Green had no report this evening.

Village Administrator James Richter II reported the Illinois Municipal League filed suit seeking clarification to the Governor's order for schools and government offices to be closed on Election Day this year. Last week, a Sangamon County Circuit Court Judge handed down a decision that gives each municipality the independent discretion to determine if their offices will close on November 3.

As you know, Machesney Park Village Hall is a polling place and there will be potentially hundreds of people in and out of Village Hall to vote in the Board Room, so we will be closing the Village Office on Election Day to ensure the safety of our employees. We are not imposing subsequent closures on future election days at this time; and of course, a deep-cleaning of this facility will be completed after the election.

Finance and HR Manager Michelle Johannsen had no report this evening.

Public Works Superintendent Chad Hunter had no report this evening.

Village Engineer Chris Dopkins reported that the Hawksview Improvements are coming along nicely. All of the curb and gutter is in, driveways are paved and they just wrapped up restoration. Weather permitting this week, the roadways will be shaped and compacted for paving. Paving is currently scheduled for next week. This project is ahead of schedule. Regarding the Resurfacing Project, the paving wrapped up last Thursday evening, pavement markings are going down today and tomorrow. Shouldering will commence thereafter and that project will be pretty much wrapped up as well. Both of these projects are being completed ahead of schedule.

**Public Safety Supervisor, Lt. Tammie Stanley** had no report this evening, but expressed her gratitude for the condolences for the officers who passed away recently.
