REGULAR MEETING-MAY 1, 2018

The St. Martin Parish Council met in Regular Session convened at 5:05 p.m., Tuesday, May 1, 2018, Carroll J. Fuselier Meeting Room, St. Martin Parish Annex Building, 301 West Port Street, St. Martinville, Louisiana.

The meeting was called to order by Chairman Jason Willis.

RESOLUTION NO. 18-051-RS

A Resolution acknowledging and approving the application for a Cultural District known as "Cecilia et Les Alentours" in the community of Cecilia, Louisiana, and to provide for such other matters in connection therewith.

WHEREAS, Act Number 298 of the 2007 Regular Session of the Louisiana Legislature authorizes local governing authorities, such as the St. Martin Parish Government, to create Cultural Districts as a mechanism for community revitalization through the creation of centers for cultural activities; and

WHEREAS, the Louisiana Department of Culture, Recreation, and Tourism, Office of Cultural Development, is authorized to develop standard criteria for Cultural Districts and to determine whether a proposed Cultural District satisfies those criteria; and

WHEREAS, the Louisiana Department of Culture, Recreation, and Tourism, Office of Cultural Development, has promulgated administrative rules which set forth the procedure for local governing authorities to submit applications to designate and certify a specific geographical area as a Cultural District; and

WHEREAS, the following geographical area situated wholly within St. Martin Parish, Louisiana, may meet the criteria for the creation of a Cultural District, the area being comprised, generally, as follows: the most northern portion of the boundary at Huron Road East, crossing Bayou Portage, up to and including the Levee Road and Bayou Amy; on the eastern boundary going south on Levee Road along Bayou Amy to the area known as Grand Anse; the southern boundary includes the southern part of Louisiana Highway 678, continuing westward towards Cecilia, and includes a portion of Louisiana Highway 328; and the western boundary being slightly west of Teche Elementary School on Louisiana Highway 31, and also includes Harold Stoutes Road and a portion of Declouet Road, up to Louisiana Highway 31, including historic First Bethlehem Church and a popular live oak tree; and

WHEREAS, within the boundaries of a state certified Cultural District, several tax incentives may be available, including, but not limited to, a sales tax exemption on the sale of certain original works of art, individual income tax credits for eligible expenses incurred during the rehabilitation of certain owner/occupied residential or owner/occupied mixed use structures, and income and corporate franchise tax credits for eligible expenses incurred during the rehabilitation of certain historic structures; and

WHEREAS, the Cultural District boundaries referenced herein embrace an area in which the St. Martin Parish Government has expended and/or has committed to expend funds in excess of One Million and No/100 (\$1,000,000.00) Dollars for improvements to parks and recreational facilities; and

WHEREAS, the aforesaid boundaries of the subject Cultural District also include a multi-use facility which the St. Martin Parish Government intends to acquire, said structure containing in excess of six thousand (6,000) square feet; and

WHEREAS, only a local governing authority is authorized to submit an application for the designation and certification of a Cultural District; and

WHEREAS, a "local governing authority" is defined by LAC 25:I Section 1101 as "the governing authority of the parish in which the Cultural District is located"; and

WHEREAS, the St. Martin Parish Government is the "local governing authority" of St. Martin Parish, Louisiana; and

WHEREAS, the proposed Cultural District, "Cecilia et Les Alentours", is situated entirely within the Parish of St. Martin:

BE IT, THEREFORE, RESOLVED that the St. Martin Parish Government does hereby support and endorse the submission of an application to the Louisiana Department of Culture, Recreation, and Tourism, Office of Cultural Development, to designate "Cecilia et Les Alentours" as a state certified Cultural District.

BE IT FURTHER RESOLVED that Laura Berard Huval and Paula Calais Ohlmeyer are hereby authorized to submit, on behalf of the St. Martin Parish Government, all supporting documents, reports, and other forms mandated for the creation, administration, and reporting deemed necessary and proper to effect the creation of a Cultural District within the geographical boundaries specified herein.

BE IT FURTHER RESOLVED that all administrative employees of the St. Martin Parish Government shall, as directed by the Parish President, cooperate with efforts to compile the necessary information and data required for the said application, as well as all subsequent reporting necessary for the administration of the said Cultural District.

BE IT FURTHER RESOLVED that all citizens and businesses within St. Martin Parish, Louisiana, including, but not limited to, the community known as Cecilia, Louisiana, are encouraged to support and promote the activities consistent with the purposes of the Cultural District to be known as "Cecilia et Les Alentours".

BE IT FURTHER RESOLVED that the Parish President be authorized, directed, and empowered to execute any and all documents necessary for the creation and administration of the proposed Cultural District, "Cecilia et Les Alentours", and to adopt any and all other additional steps deemed proper and feasible in his uncontrolled discretion to effectuate the above and foregoing resolution.

MARTIN PARISH GOVERNMENT (formerly the St. Martin Parish Police Jury) by virtue of an act recorded in Book 622, Page 486, under Entry Number 147741 of the Conveyance Records of St. Martin Parish, Louisiana, be and is hereby formally abandoned.

BE IT FURTHER ORDAINED that the ST. MARTIN PARISH GOVERNMENT has determined that the owner of the property which fronts on that portion of Cecilia Loop has requested its abandonment.

BE IT FURTHER ORDAINED that the ST. MARTIN PARISH GOVERNMENT declares and reserves the right to revoke the abandonment, *ab initio*, in the event any sort of proceedings are instituted against it or any of its agents, employees, Parish Council members, Parish President, or any insurer of any of the foregoing, wherein such proceedings seek compensation and/or damages in accordance with Article I, §4 of the Louisiana Constitution and/or La. R.S. 13:5111. This right of revocation shall be applicable for a period of three (3) years from the effective date of this ordinance.

BE IT FURTHER ORDAINED that the Parish President be and is hereby authorized to execute any and all documents necessary to effect the terms and provisions of this decree.



AIR QUALITY AWARENESS MONTH IN ST. MARTIN PARISH, LOUISIANA

WHEREAS, poor outdoor air quality can threaten the health of our citizens; and WHEREAS, it is estimated that one out of every three people in the United States is at a higher risk of experiencing problems from ground-level ozone, a contributor to poor air quality; and WHEREAS, children, people with lung disease, older adults, and people with heart disease

tend to be more vulnerable to outdoor pollution, and it would be beneficial for people to learn more about the effects air quality may have on their health if they fall into one of these sensitive groups; and

WHEREAS, utilizing the Air Quality Index is simple and free of cost; and WHEREAS, knowledge of the Air Quality Index can help protect our communities health; and

WHEREAS, the special election is not scheduled until November 6, 2018, with the general election, if necessary, being scheduled for December 8, 2018; and

WHEREAS, the current Parish President has determined that the Public Works Department is in dire need of a Director; and

WHEREAS, pursuant to the Home Rule Charter of St. Martin Parish, a director serves at the pleasure of the Parish President; and

WHEREAS, the ability of the Parish President to recruit and appoint a Director is severely diminished and impaired by the uncertainty of the Parish Presidency; and

WHEREAS, the qualifying criteria for the Director of Public Works dictated by the Home Rule Charter limit the census of potential candidates; and

WHEREAS, no satisfactory candidate for the Director of Public Works has emerged; and WHEREAS, the absence of a Public Works Director has resulted in undue hardships for the current Public Works Supervisors and the personnel under their supervision; and

WHEREAS, the Parish President has concluded that it would be beneficial to retain the services of an individual to assist the Parish President and the supervisors in the Public Works Department; and

SUMMARY NO. 1232-OR (Introduced by Dean LeBlanc, District 8)

An Ordinance to authorize the St. Martin Parish Government to purchase from First Baptist Church of Cecilia all of its interests in that certain parcel of land, with all improvements, located in Section 60, Township 8 South, Range 6 East, in the community of Cecilia, Louisiana.

SUMMARY NO. 1233-OR (Introduced by Byron Fuselier, District 1)

An Ordinance to authorize the St. Martin Parish Government to purchase from West Vermilion Properties, L.L.C. all of its interests in that certain parcel of land, with all improvements, located in Section 1, Township 11 South, Range 6 East of St. Martin Parish, Louisiana.

Prior to adjournment, Parish President Chester Cedars briefed the Council Members on the following on-going projects and other pertinent happenings in the Parish:

FOUR-MILE BAYOU ROAD IMPROVEMENTS - Parish President Chester Cedars mentioned the issue with this project is the bridge on this road cannot handle the load of the equipment that is needed for the improvements. Parish President Chester Cedars is working with property owners to find other means of getting this project completed.

<u>WATER WORKS DISTRICT #5 - Parish President Chester Cedars stated Ordinance Summary Number 1225-OR has been introduced and will be voted on at the June 5th meeting. Parish President Chester Cedars stated this is an extremely important matter, and believes will set the stage for other decisions vetting in the near future.</u>

Numbers 1226-OR, 1227-OR, and 1228-OR) were introduced at tonight's meeting, and will be voted on at the June 5th meeting. The third ordinance, 1228-OR, re-defines the meaning of "nuisance" to make it more specific. Numbers 1226-OR and 1227-OR have been discussed and, respectively, expand the definition of littering, grant jurisdiction to the Justice of the Peace system for enforcement of littering violations, and establish an administrative process for handling blighted and condemned properties. Parish President Chester Cedars added he is excited about these steps to address valid concerns.

MILLAGE RATES - Parish President Chester Cedars mentioned Ordinance Summary Number 1230-OR is for the adoption of millage rates for the year 2018. The rates are the same as we set last year. Parish President Chester Cedars stated he gave this matter much thought and considered the prospect of rolling some of the millages forward. However, after conferring with Sean Hundley, Director of Finance, and the St. Martin Parish Assessor, Parish President Chester Cedars could not justify in good conscience disturbing the rates by either a roll forward or a roll backward. The assessor anticipates a reduction in property valuation of only 3% maximum. This will have an insignificant impact on our collections and rendered either a roll forward or roll backward improvident.

<u>ANNUAL REPORT - Parish President Chester Cedars stated last year, the Parish published and mailed an "annual report" at a cost of over \$13,000.00. The amount budgeted this year for a similar report is \$15,000.00. Parish President Chester Cedars reviewed the report and concluded that it adds nothing beyond the information St. Martin Parish Government shares with the public daily on our website and which we disseminate regularly through our social media outlets. Parish President Chester Cedars found that such an expenditure would be imprudent.</u>

GOMESA FUNDS - Parish President Chester Cedars stated he learned Friday afternoon that the Parish has received \$616,852.85 from the Gulf of Mexico Energy Security Act. Last year this time, the Trump Administration released a draft FY 2018 budget which called for a repeal of GOMESA funds. Pressure from several fronts convinced the President to change his position. Currently, Parish President Chester Cedars is researching what restrictions, if any, we have on the use of this money. Previously, working with Duplantis Engineering, former Parish President Guy Cormier drafted a preliminary plan for the use of GOMESA funds which are designed to be spent on coastal restoration, a term which is somewhat amorphous under the Act.

<u>PERMIT OFFICE UPGRADES</u> - Parish President Chester Cedars mentioned he has negotiated the purchase of property at 420 East Bridge Street in St. Martinville. It is a two-story structure. Mr. Rodney Richard and members of St. Martin Parish Government have examined the structure and postulate that it is indeed a great purchase. Parish President Chester Cedars mentioned at least two departments will be relocated at this location along with providing additional storage space.

<u>CECILIA CULTURAL DISTRICT</u> - Parish President Chester explained the formation of such a district could yield many dividends for our ENTIRE parish. Parish President Chester Cedars stated he has been assured that the creation of the district will not impose any restrictions on property use (except when an owner wishes grants, etc). Parish President Chester Cedars exclaimed he personally endorses the creation of the district.

<u>MAY COMMITTEE MEETING</u> - Parish President Chester Cedars mentioned he has requested that Michelle Brignac appear at the May committee meeting to give an update of what is happening at the Animal Shelter. Parish President Chester Cedars has also requested Ms. Brignac to present an overview of the entire Animal Protection and Welfare program which we sponsor.

<u>PUBLIC WORKS</u> - Parish President Chester Cedars stated personnel in public works do an admirable job considering the number of work orders which St. Martin Parish Government receives, and the number of miles of roads and drainage laterals St. Martin Parish Government are called upon to maintain. Parish President Chester Cedars added that since October 2014, St. Martin Parish Government has been without a Public Works Director. Parish President Chester Cedars stated he has made the decision to retain Dean Dore' to offer assistance in the public works arena. This position will be a part-time engagement and terminable at will.

A motion was made by Dean LeBlanc and seconded by Chris Tauzin that the St. Martin Parish Council does hereby adjourn. Motion was unanimously approved.
