AN ORDINANCE AWARDING A FRANCHISE TO THE SUCCESSFUL RESPONDENT TO REQUEST FOR PROPOSALS AND SUBSEQUENT NEGOTIATIONS FOR ST. MARTIN PARISH'S MANDATED WASTE DISPOSAL PROGRAM, AND OTHERWISE PROVIDING WITH RESPECT THERETO.

WHEREAS, the St. Martin Parish Government has previously solicited formal Request for Proposals relative to mandated waste disposal services of St. Martin Parish, Louisiana; and

WHEREAS, La. R.S. 33:4169.1 authorizes parish governments to award franchises to waste disposal providers; and

WHEREAS, by virtue of a bid process initiated through the aforementioned formal Request for Proposals, a respondent has submitted what has been deemed to be the most acceptable response/proposal, all pursuant to the evaluation criteria set forth in the aforementioned request for

proposals and negotiations:

BE IT, THEREFORE, ORDAINED that Waste Connections Bayou, Inc. be declared the successful respondent/offeror relative to the Parish's mandated waste disposal program.

BE IT FURTHER ORDAINED that the aforesaid successful respondent be awarded a contract for a period of ten (10) years for residential and commercial waste disposal services for the unincorporated areas of St. Martin Parish, Louisiana.

BE IT FURTHER ORDAINED that the Parish President, Chester R. Cedars, be and is hereby authorized, empowered, and directed to negotiate a contract for the Parish's mandated waste disposal services under the terms and conditions specified in the Request for Proposals and under such additional terms and conditions as he may deem necessary and fit in his uncontrolled discretion.

BE IT FURTHER ORDAINED that the provisions of this ordinance are hereby declared to be severable, and if any provision, word, phrase, or clause of this ordinance, or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect the validity of the remaining portions thereof.

BE IT FURTHER ORDAINED that this ordinance shall become effective immediately upon approval of the St. Martin Parish Council and the signature of the Parish President, all in accordance with the dictates of the Home Rule Charter of St. Martin Parish, Louisiana.

Parish President Chester Cedars felt constrained to give an update on the "rate increases" for which Pelican Waste & Debris, LLC has billed St. Martin Parish residents:

- St. Martin Parish Government's first notice of the proposed rate increase was transmitted to my office on August 16, 2021;
- Immediately, President Cedars instructed our Parish Attorney to contact Pelican
 Waste & Debris' attorney advising that St. Martin Parish does not agree to and/or
 approve of any such increase;
- The increase is deemed by the Parish to be improvident on three (3) separate bases:
 - On June 24, 2021, there was a lengthy meeting among Pelican Waste & Debris, their attorney, President Cedars, St. Martin Parish Government staff, and Parish Attorney Allan Durand where the parties discussed, and supposedly agreed upon, the terms of an "exit plan" at which time no mention was ever made about a rate increase;
 - 2. The CPI computations do not appear to be accurate; and
 - 3. Under no circumstances is an increase retroactively to July 1, 2021, proper.

Upon receipt of the notice, at Parish President Chester Cedars' instruction, Parish Attorney Allan Durand contacted Pelican Waste & Debris' attorney of the Parish's objections to the increase (as previously stated), and by electronic mail dated August 24, 2021, President Cedars personally informed Pelican Waste & Debris of his position on this matter.

On September 2, 2021, residents began receiving the increased billings, and a windstorm of calls to the St. Martin Parish Government office commenced. Executive Secretary Lesley Thibodeaux and Clerk of the Council Brooke Gillespie have assiduously addressed those calls which often total in excess of fifty (50) per day, not counting social media submissions. The tasks have been burdensome and taxing as one might surmise.

Not only has the rate increase ignited the ire of the public, but the continued issues with service have also prompted countless complaints. Routes continue to be missed and recently the mixing of recyclables and regular household waste have been the object of many issues presented by the public. Bulky waste collections have disappeared. Finally, it is necessary to observe that all of these problems predate Hurricane Ida.

Parish President Chester Cedars reminded that Pelican Waste & Debris did increase waste disposal fees in other parishes and municipalities. Finally, President Cedars noted he wants to work with Pelican Waste & Debris, but also protect the citizens of St. Martin Parish.

AN ORDINANCE TO PROVIDE REDUCED WEIGHT REGULATIONS FOR MOTOR VEHICLES ON **BORDELON ROAD**, LOCATED IN DISTRICTS 5 & 8, OFF OF LOUISIANA HIGHWAY 347 (GRAND POINT HIGHWAY) AND LOUISIANA HIGHWAY 328 (ANSE BROUSSARD HIGHWAY), SECTION 65, TOWNSHIP 8 SOUTH, RANGE 6 EAST, ST. MARTIN PARISH, LOUISIANA, AND TO PROVIDE FOR THE PENALTY FOR THE VIOLATION OF THIS ORDINANCE.

SECTION I. BE IT ORDAINED by the St. Martin Parish Council that it shall be unlawful for any person, firm, partnership, corporation, and/or person acting for and in behalf of any firm, partnership or corporation to travel upon the following road in vehicles carrying a load in excess of the following weight limit:

BORDELON ROAD WEIGHT LIMIT - FIFTEEN (15) TONS

AN ORDINANCE TO AUTHORIZE THE ST. MARTIN PARISH GOVERNMENT TO SELL BY PUBLIC DISPOSITION ALL OF ITS INTERESTS IN THE PROPERTY LOCATED ON ST. ANN STREET, ST. MARTINVILLE, LOUISIANA, AND DEPICTED AS LOT 4 OF BLOCK L OF AMEAL SUBDIVISION ON A PLAT OF SURVEY RECORDED IN THE CONVEYANCE RECORDS OF ST. MARTIN PARISH, LOUISIANA, IN BOOK 304, PAGE 334, UNDER ENTRY NO. 99469, ALL IN ACCORDANCE WITH LA. R.S. 47:2201, ET SEQ.

WHEREAS, on or about June 8, 2005, the following described property was adjudicated to the St. Martin Parish Government in accordance with La.R.S. 47:2196:

That certain lot or parcel of ground situated on the west side of the Bayou Teche in the First Ward of St. Martin Parish, Louisiana, in the City of St. Martinville, measuring 30 feet front on St. Ann Street by a depth between parallel lines of 100 feet, and bounded now or formerly as follows: north by St. Ann Street; south by property of C. Emile Ledoux; east by Lot 3 of Block "L" of the "Ameal Subdivision" hereinafter referred to; and west by Lot 5 of Block L of the said Ameal Subdivision. WHEREAS, the property in question serves no useful purpose for the public, in general, and the St. Martin Parish Government, in particular; and

WHEREAS, the St. Martin Parish Government has determined that the said property has little or no value to the Parish; and

WHEREAS, Tiran Charles, who resides at 1034 Point Claire Road, St. Martinville, Louisiana, 70582, has expressed an interest in acquiring the said property, and the Parish Counsel has acquired competent evidence that for greater than twelve (12) months he has performed significant upkeep to the property which is adjacent to other property owned by him; and

WHEREAS, the said Tiran Charles has agreed to remediate the said property as regards its blighted and neglected condition; and

WHEREAS, the sale of the subject property to Tiran Charles will be of significant benefit to both the St. Martin Parish Government and the general public; and

WHEREAS, by virtue of La. R.S. 47:2202(B) St. Martin Parish Government is authorized to sell the property to Tiran Charles without public bid at its fair market value of \$2,500, which St. Martin Parish Government has determined to be fair and reasonable; and

WHEREAS, the St. Martin Parish has received no other offers to purchase the property since its acquisition by tax sale in 2005:

BE IT, THEREFORE, ORDAINED that, on behalf of the St. Martin Parish Government, Parish President Chester R. Cedars be authorized, empowered, and directed to initiate the steps necessary to sell the following described property which has been adjudicated to the Parish, the disposition thereof to be confected in accordance with La. R.S. 47:2202(B), et seq:

That certain lot or parcel of ground situated on the west side of the Bayou Teche in the First Ward of St. Martin Parish, Louisiana, in the City of St. Martinville, measuring 30 feet front on St. Ann Street by a depth between parallel lines of 100 feet, and bounded now or formerly as follows: north by St. Ann Street; south by property of C. Emile Ledoux; east by Lot 3 of Block "L" of the "Ameal Subdivision"

hereinafter referred to; and west by Lot 5 of Block L of the said Ameal Subdivision. The above described lot is more particularly described as Lot 4 of Block L of said Ameal Subdivision per plat of survey by C.K. - B. All structures situated on the property shall be sold without warranty of fitness, expressed and/or implied, including those set forth in Articles 2520, et seq, of the Louisiana Civil Code;
- C. All notices mandated by La.R.S. 47:2706 and La.R.S. 47:2207 shall be the sole and exclusive obligation of vendor;
- D. The provisions specified in La.R.S. 47:2207(B) shall be incorporated in the sales instrument; and
- E. All mineral rights shall be reserved in favor of the St. Martin Parish Government.

WHEREAS, the St. Martin Parish Government previously advertised for bids for the Bayou Estates Flood Wall Project; and

WHEREAS, pursuant to the foregoing, however, only one bid was received which was more than \$4,400.000.00 over the amount available for the project; and

WHEREAS, on the advice of the engineer for the project, Mo Saleh of the firm of Professional Engineering and Environmental Consultants, Inc., the said bid was rejected on December 3, 2019, by the St. Martin Parish Council; and

WHEREAS, the St. Martin Parish Council on December 3, 2019, authorized the rebidding of the project, dividing it into four separate segments, contracts, or phases; and

WHEREAS, after due advertisement therefor, sealed bids were opened on March, 19, 2020; and

WHEREAS, the low bid on each of the segments, contracts, or phases was as follows:

Contract B-Pump Station: Circle, LLC

WHEREAS, the total of the bids received was \$5,734,233.60; and

WHEREAS, the low bid on each phase, contract, or segment exceeded the amount budgeted therefor; and

WHEREAS, the total of all of the low bids was in excess of the \$4,500,000 budgeted for the entire project; and

WHEREAS, the estimated cost of the segment, phase, or contract which received no bid is \$1,000,000.00; and

WHEREAS, Mo Saleh of Professional Engineering and Environmental Consultants, Inc., the engineering firm retained by St. Martin Parish Government relative to the said project, recommended that all bids be rejected; and

WHEREAS, Mo Saleh of Professional Engineering and Environmental Consultants, Inc., the engineering firm retained by St. Martin Parish Government relative to the said project, has stated that: "In order to have a complete functional project, all four contracts must be constructed"; and

WHEREAS, the time limitations set forth in the Public Bid Law of the State of Louisiana were suspended by Executive Orders 32 JBE 2020, 41 JBE 2020, and/or 52 JBE 2020; and

WHEREAS, by virtue of Resolution Number 20-045-RS, the St. Martin Parish Council authorized the rejection of all bids and further authorized the Parish President to terminate all prior contracts related to the said project; and

WHEREAS, the Parish President on July 28, 2020, terminated the services of Mo Saleh of Professional Engineering and Environmental Consultants, Inc.; and

WHEREAS, at the request of the Parish President, the firm of Sellers & Associates, Inc. reviewed all plans and specifications related to the Bayou Estates Flood Wall Project and opined that the project can be completed, with modifications, for an approximate construction cost of \$6,193,897.30 which included constructions costs, engineering fees, and administration expenses; and

WHEREAS, by Resolution Number 20-078-RS adopted on October 6, 2020, the St. Martin Parish Council approved a budget for the said project in the amount of \$6,193,897.30, with the contribution from St. Martin Parish funds set at a maximum of \$1,364,950.00; and

WHEREAS, Sellers & Associates, Inc. recently completed the preparation of all modifications to the plans previously prepared by Mo Saleh and scheduled September 1, 2021, as the date for advertising for bids for the project; and

WHEREAS, prior to bidding the project, Sellers & Associates, Inc. was compelled by law to prepare an updated budget/cost estimate to accommodate several constructions issues which surfaced during its modification/revisions of the said plans; and

WHEREAS, the initial cost estimate warranted further review because of the effect on the current construction market conditions associated with the COVID-19 Pandemic, inclusive of supply shortages and rising prices of materials; and

WHEREAS, the final budget/cost estimate prepared by Sellers & Associates, Inc. was \$8,043,999.46; and

WHEREAS, the current cost estimate would require a local match by St. Martin Parish to be \$3,215,051.94; and

WHEREAS, should the project be advertised for bids and should the lowest responsive and responsible bid be within the cost estimate prepared by Sellers & Associates, Inc., the Public Bid Law of the State of Louisiana would not allow for the rejection of said bid, thus mandating the Parish to contribute a match even though it would be in excess of the financial parameters set forth in Resolution Number 20-078-RS:

BE IT, THEREFORE, RESOLVED that the total budget for the project and the contribution of the St. Martin Parish Government as fixed by Resolution Number 20-078-RS be and is hereby maintained.

Parish President Chester Cedars stated the Bayou Estates Flood Wall Project is a twelve-year old endeavor. After an arduous journey which included regulatory quagmires, contentious public hearings, and unfounded allegations of wrongdoings, this project was finally let for bids which were received on November 5, 2019. Unfortunately, only one (1) bid was submitted despite the fact that sixteen (16) contractors secured the plans for the project and twelve (12) potential bidders attended the mandatory bid conference several weeks prior to bid opening. The sole bid which was received

was \$9.4 million, almost twice the amount budgeted and available for this project at that time.

Contractors who obtained plans and/or attended the bid conference were supposedly contacted by the engineer, and they articulated various and sundry reasons why they chose not to even bid. Mo Saleh, the engineer for the project, opined that based upon his discourse with contractors, the many different construction fields embraced by the project rendered it too complex for one contractor, thus resulting in only one bid and its inflated amount. At such, Mr. Saleh recommended rebidding the project in four (4) separate "segments." Mr. Saleh postulated that this would encourage additional contractors to submit bids in amounts far less than the \$9.4 million bid. Therefore, a schedule was prepared which called for the letting of bids as suggested in December 2019, with a bid opening in January 2020.

Consequently, at the December 5, 2019, meeting, the St. Martin Parish Council formally rejected the bid presented and confirmed/affirmed the decision to rebid. The second round of bids were received on March 19, 2020. As previously noted, the bids were in four (4) segments. One segment (Drainage system revisions) received no bids. The low bids on the other three (3) segments totaled \$5,734,233.60. This amount alone was \$1.2 million over budget, not considering the segment which received no bid. A rejection of the bids was obviously warranted. In preparation for the adoption of that action, however, the following steps were taken.

On April 24, 2020, a telephonic conference was conducted among Mo Saleh, James Blanchard (the project manager for Saleh's firm), Heath Babineaux, Kasey Courville, Richard Minvielle, and Parish President Chester Cedars to discuss the status of the project and what our options might be. Two basic facts were deemed evident: 1) the project could not be undertaken without all phases or segments being completed; and 2) the prospect of this project (as designed) ever receiving bids within budget was slim to none. Consequently, President Cedars requested and received from Mo Saleh his recommendation that all bids be rejected on a budgetary basis and because the project would not meet its flood control objectives without completion of all four segments.

On June 2, 2020, the Council adopted Resolution Number 20-045-RS, which rejected the second round of bids and further allowed St. Martin Parish Government to explore other alternative plans/projects and to dismiss the services of Mo Saleh. The steps adopted in connection therewith were: 1) the formal rejection of the bids; 2) termination of the engineer's contract; 3) having Sellers and Associates, together with Kasey Courville, confer with the various contractors who bid and who

did not bid to vet their concerns; 4) meet with CDBG personnel to explain what we were doing; and 5) explore alternatives to complete the wall without having to obtain any new permits (Sellers & Associates had cultivated some ideas in this respect).

The steps referenced above were completed and included the formal dismissal of Mo Saleh on July 28, 2020. Furthermore, Sellers and Associates were formally retained and after much evaluation and analysis determined that, with modifications to the original plans, the total cost of the project would approximate \$6,193,897.30. Of that amount, the costs share or local match from the Parish would increase to \$1,364,950.00, almost one million dollars greater than the original budgets.

At that juncture, Parish President Chester Cedars recommend that we proceed one last time to bid this project with Sellers and Associates at the helm and in accordance with their modifications to the original plans. President Cedars' position was bolstered by the fact that every year we spend over \$200,000.00 in fighting high water issues in the affected area.

On October 6, 2020, the Council adopted Resolution Number 20-078-RS authorizing the retention of Sellers & Associates and approving (increasing) the budget for this project at \$6,193,897.30, "with the sum being financed via CDBG-DRU, HMGP funds, and such other awards/sources including any which may be available from the Louisiana Watershed Initiative." The Resolution further declared that "Under no circumstances shall the contribution of the St. Martin Parish Government exceed 1,364,950.00." Immediately, Sellers & Associates commenced the chore of re-drafting the plans and specifications for the flood wall project and obtaining the necessary approval of modifications from the appropriate and necessary regulatory agencies. Moreover, it was further necessary to obtain "extensions" on the deadlines associated with the CDBG-DRU and HMGP awards since they were related/associated with the 2008 and 2011 weather events of Hurricane Ike and Hurricane Gustav, respectively. Indeed, the following deadlines were established with the clear understanding that they would not, and indeed could not, be extended under any circumstances:

Bidding and Contract Award:

September 2021

Construction Completed:

September 2022

Final Closeout:

December 2022

As late as July of this year, Sellers & Associates and St. Martin Parish Government were diligently pursing additional rights-of-way which became necessary as issues evolved with the re-

drafting of the original plans of Mo Saleh. Our efforts were obstructed by recalcitrant property owners, several of whom refused to cooperate, thus resulting in additional plan revisions.

Finally, the project was scheduled to be advertised for bidding beginning on September 1, 2021. However, Pan American, an engineering firm required by OCD for the State to review and approve all plans prior to bidding advised that a final budget needed to be prepared. With the increased market demands for materials such as steel, the first budgetary projection of Sellers & Associates had increased to \$8,043,999.46. The local match of Parish Government would be \$3,215,051.94. Despite this development, our intention was to nonetheless bid the project on one last occasion – we simply had gone too far to take any other action.

Nonetheless, on the advice of Pan American, communicated on August 27, 2021, our Office researched the Louisiana Bid Law and these restraints were disclosed. First, La. R.S. 38:2212(H) mandates that any public entity must estimate the probable cost of the public work before advertising for bids. If funds that meet or exceed the estimate have not been authorized/committed by the public entity, then any subsequent bid process would be legally proscribed. Stated differently, the public bid law stipulates that whenever a public entity advertises for bids, it essentially certifies that funds in the amount of the budgeted/estimated sum are available and authorized.

Furthermore, La. R.S. 38:2214 declares that if a project proceeds to bid, and if the lowest responsible and responsive bid received is within the estimated amount, then the public entity must accept that bid and cannot simply "reject all bids." Rather, it is not just cause to reject all bids because of the amount of a bid so long as the low bid is within the estimated budget. The Louisiana Supreme reinforced that principle in the case of *New Orleans Rosenbush Claims Services, Inc. v. City of New Orleans*, 653 So.2d 538 (La. 1995). Note again that Resolution Number 20-078-RS established a budget for the Bayou Estates Flood Wall of \$6,193,897.30, with an authorized local match of \$1,364.950.00.

Therefore, if St. Martin Parish Government proceeds with the bid process under these circumstances, and should the low bid EXCEED \$8,043,999.46, then the Parish could reject all bids without any legal issues. This scenario may well occur given the even greater construction issues which have been enhanced by the COVID-19 Pandemic and, most recently, by Hurricane Ida. On the other hand, should the low bid fall within the budgeted/estimated amount, the Parish could be responsible for up to \$3,215,051.19 because of the dictates of La. R.S. 38:2212(H). Noteworthy is the fact that Sellers & Associates opine that it is unlikely that the low bid would be within the 6-

million-dollar parameters set by Resolution Number 20-078-RS. No elaboration is warranted about the imprudence of proceeding with a bid process under the current scenario which would place over \$2 million of public money at peril.

Parish President Chester Cedars noted that there are alternatives available to address the high-water issues which can be explored and likely financed within the \$1.3 million dollar figure set forth as a local match in Resolution Number 20-078-RS. Included in this "Plan B" approach is the purchase and installation of a pumping system within strategic parts of Bayou Estates Subdivision, an alternative which has been vetted by Sellers & Associates. Moreover, there remains the potential for such alternatives being financed through the previous CDBG-DRU and/or HMGP awards, provided they can be completed within the October 2022 sunset period.

An Ordinance reducing the speed limit to 35 mph on Ches Broussard Road, located in District 7.

Prior to adjournment, Parish President Chester Cedars briefed the Council Members on a few matters not requiring Council action. President Cedars stated St. Martin Parish was very fortunate in regards to Hurricane Ida. At the National Weather Service update at 10:00 A.M. on Saturday, August 28, 2021, Morgan City was in the eye. Hurricane Ida shifted east with each update. After the hurricane passed, Director of Public Works Kasey Courville and Parish President Chester Cedars went to Lower St. Martin, along with six (6) Public Works employees. By 3:00 Monday afternoon, all streets were cleared. St. Martin Parish distributed 9,141 bags of sand for this event.

A motion was made by Daniel Richard, Jr. seconded by David Poirier that the St. Martin Parish Council does hereby adjourn. Motion was unanimously approved.
