Clerk of the Council Brooke Gillespie read the Special Business Item: RULE TO SHOW CAUSE to address nuisance property located at 1401 Breaux Bridge Sr High School Road, Breaux Bridge. Property owned by James Boyd.

Property owner James Boyd was present to discuss the condition of 1401 Breaux Bridge Sr High School Road, Breaux Bridge. Compliance Officer Ronald Solarie stated a complaint was made in reference to abandoned trailers and vehicles on the property. Mr. Boyd mentioned he is getting prices to have the trailers moved, and the cars have already been moved to the back of the property. Mr. Boyd requested six (6) months' time to have the property cleaned. Ms. Alta Porter noted there are snakes, possums, and rodents coming from the property. The nuisance is a safety concern, especially with children. After hearing testimony from Mr. Ronald Solarie and upon reviewing the photographs taken by Mr. Solarie (*on-file*), the Council found that under Section 24-105 of the St. Martin Parish Code of Ordinances, the condition of the property renders it a "Nuisance" as a result of the abandoned vehicles and dilapidated structure on the premises.

#### **ORDINANCE NO. 22-04-1351-OR**

AN ORDINANCE TO AUTHORIZE THE ST. MARTIN PARISH GOVERNMENT TO LEASE TO LAFAYETTE GENERAL HEALTH SYSTEM, INC. AND/OR ST. MARTIN HOSPITAL, INC. THE CECILIA RURAL HEALTH CLINIC FACILITY, FORMERLY KNOWN AS THE TECHNOLOGY CENTER, LOCATED AT 2460-A CECILIA HIGH SCHOOL HIGHWAY, BREAUX BRIDGE, LOUISIANA, ALL FOR THE EXPRESS PURPOSES OF OPERATING A RURAL HEALTH CLINIC.

WHEREAS, for several years the building formerly occupied as a technology center at 2460-A Cecilia High School Highway has remained vacant; and

WHEREAS, the area in which the said building is located is part of the First Hospital Service District of the Parishes of St. Landry and St. Martin, Louisiana (the "HSD"); and

WHEREAS, an ad valorem tax was collected for numerous years on behalf of the HSD, the subject tax have been levied again the property owners in the communities within the geographical boundaries of the District which includes the site of the subject building; and

WHEREAS, the HSD was created for the primary purpose of funding the operations of St. Luke Hospital in Arnaudville, Louisiana; and

WHEREAS, St. Luke Hospital closed in approximately 2008; however, the property owners in the district continued to pay the ad valorem tax; and

WHEREAS, by Ordinance Number 17-02-1168-OR adopted on February 7, 2017, the HSD was abolished; and

WHEREAS, on February 14, 2017, St. Martin and St. Landry Parishes entered into an Intergovernmental Agreement (Cooperative Endeavor Agreement) which, among other matters, divided the assets of the HSD whereby St. Martin Parish received a substantial sum of cash; and

WHEREAS, St. Martin Parish Government now desires to use the proceeds received from the division of the assets of the abolished HSD to renovate the aforementioned building to accommodate its use as a health care facility; and

WHEREAS, St. Martin Hospital, Inc and/or its parent enterprise, Lafayette General Health System, Inc., have agreed to supervise, plan, and direct the renovation of said building and to thereafter lease same from St. Martin Parish Government; and

WHEREAS, in its current state, the property in question serves no useful purpose for the public, in general, and the St. Martin Parish Government, in particular; and

WHEREAS, the St. Martin Parish Government has determined that the said property currently has little or no value to the Parish; and

WHEREAS, the renovation of the subject property and it subsequent lease to St. Martin Hospital, Inc. and/or Lafayette General Health Systems, Inc. will be of significant benefit to both the St. Martin Parish Government and the general public; and

WHEREAS, the use of Parish funds to renovate the facility will be less than the amount received by the Parish in the aforedescribed intergovernmental agreement with St. Landry Parish; and

WHEREAS, the St. Martin Parish Government has received no other offers or proposals relative to the vacant premises:

BE IT, THEREFORE, ORDAINED that, on behalf of the St. Martin Parish Government, Parish President Chester R. Cedars be authorized, empowered, and directed to initiate the steps necessary to enter into all contracts necessary to renovate the vacant building located at 2460-A Cecilia High School Highway so as to accommodate its use as a healthcare facility/clinic, the cost therefor to be paid from the proceeds received from the Intergovernmental Agreement entered into with St. Landry Parish relative to the abolition of the former First Hospital Service District of the Parishes of St. Landry and St. Martin, State of Louisiana.

BE IT FURTHER ORDAINED that Parish President Chester R. Cedars be and is hereby authorized and directed, on behalf of St. Martin Parish Government, to enter into a lease and/or operating agreement with St. Martin Hospital, Inc. and/or its parent, Lafayette General Health System, Inc., whereby the latter will lease the renovated facility and operate same as a rural health clinic. The monthly lease payment shall be no less than \$3,730.00 per month and the term of the agreement shall be at least five years.

BE IT FURTHER ORDAINED that all prior acts and documents executed by the Parish President be and are hereby confirmed and/ratified in connection with the subject matter of this edict.

BE IT FURTHER ORDAINED that Parish President Chester R. Cedars be further authorized to incorporate in the aforesaid lease agreement such other terms, conditions, and provisions as he deems necessary and proper.

BE IT FURTHER ORDAINED that Parish President Chester R. Cedars be authorized, directed, and empowered to adopt any and all other steps necessary to effectuate the terms, provisions, and conditions of this ordinance.

BE IT FURTHER ORDAINED that this ordinance shall become effective immediately upon approval of the St. Martin Parish Council and the signature of the Parish President.

A RESOLUTION REQUESTING THAT THE PARISHES THAT WERE OMITTED FROM THE DIRECT FUNDING ALLOCATION BY THE UNITED STATES TREASURY FOR THE "EMERGENCY RENTAL ASSISTANCE PROGRAM" OF THE AMERICAN RECOVERY PROGRAM ACT BE AWARDED A PROPORTIONATE DIRECT FUNDING ALLOCATION SO AS TO ESCAPE THE NUMEROUS COMPLICATIONS AND DELAYS ASSOCIATED WITH THE RECEIPT OF BENEFITS VIA THE LOUISIANA HOUSING CORPORATION WHICH ADMINISTERS THE PROGRAM FOR THE SAID PARISHES.

WHEREAS, countless Louisiana families, households, and business have been significantly impacted by the economic disaster introduced by the COVID-19 Pandemic; and

WHEREAS, the continued loss of local financial stability due to mass evictions, increased homelessness, and foreclosures experienced by rental property owners and landlords gravely endangers Louisiana's culture, quality of life, and economy; and

WHEREAS, the Emergency Rental Assistance Program ("ERAP" and "ERAP-2") of the American Recovery Program Act provides rental assistance to qualified citizens of the State of Louisiana; and

WHEREAS the ERAP and ERAP-2 benefit both lessors and lessees; and

WHEREAS, the administration of the ERAP and ERAP-2 in fifty-seven parishes in the state, including St. Martin Parish, is through the Louisiana Housing Corporation, while the remaining parishes have receive direct allocations which are administered locally; and

WHEREAS, the citizens and qualified applicants for benefits in those parishes which did not receive direct allocations have experienced significant difficulty in applying for and receiving benefits via the Louisiana Housing Corporation; and

WHEREAS, those parishes which have received direct allocations of ERAP and ERAP-2 allocations have more effectively, timely, and efficiently administered the distribution of benefits; and

WHEREAS, the St. Martin Parish Council and the St. Martin Parish President postulates that each parish which so chooses should have the opportunity to determine whether it should receive direct allocations fo such funding, and thus administer locally the distribution of the ERAP and ERAP-2 benefits; and

WHEREAS, there are numerous qualified and accountable organization which can effectively, timely, and efficiently administer the said ERAP and ERAP-2 programs through collaboration and partnerships with parishes without compromise to achieving the objectives of the programs:

BE IT THEREFORE RESOLVED that the St. Martin Parish Council and St. Martin Parish President do hereby advocate for every parish in the State of Louisiana to be afforded an opportunity to elect to receive direct allocation of funds from the Emergency Rental Assistance Program of the American Recovery Program Act, and to administer the said program locally.

WHEREAS, St. Martin Parish Government is an approved affiliate of the Keep Louisiana Beautiful which operates under the auspices of the Lt. Governor of the State of Louisiana; and

WHEREAS, over the last several years there has been an informal advisory board appointed by the governing authority of St. Martin Parish relative to the Parish's activities associated with its Keep Louisiana Beautiful program; and

WHEREAS, the said board was created by virtue of Resolution Numbers 03-110-RS and 03-157-RS, adopted respectively on August 5, 2003, and November 4, 2003; and

WHEREAS, the aforesaid defacto board has been inactive for several years; and

WHEREAS, the initial creation of the aforementioned board was for the sole and exclusive purposes of the administration of Cooperative Endeavor Agreement 587859 confected between St. Martin Parish Government and the La. Department of Environmental Quality; and

WHEREAS, the Parish President now seeks to re-instate and/or reactivate the board and the Keep St. Martin Beautiful program and the aforementioned advisory board; and

WHEREAS, Article VI, Section 15 of the Louisiana Constitution provides that the governing authority of a local governmental subdivision has general powers over any agency created by it; and

WHEREAS, La. R.S. 33:1415 provides in pertinent part that in any case where the governing authority has created or established a board or entity having or serving any governmental fuction, such governing authority has the authority to abolish same:

NOW, THEREFORE, BE IT RESOLVED that the ST. MARTIN PARISH COUNCIL does hereby abolish any prior boards which may have been established for the purpose of litter control and/or abatement such as but not limited to that board which was appointed and established by virtue of Resolutions Number 03-110-RS and 03-157-RS; and

BE IT FURTHER RESOLVED that acting pursuant to Article VI, Section 15 of the Louisiana Constitution and Sections 8-05 and 8-06 of the Home Rule Charter for St. Martin Parish, the St. Martin Parish Council does hereby establish and create an advisory board to be denominated as "Keep St. Martin Beautiful." The Board shall operate and function under the direction of the Parish President, or an employee designated by him. The Board shall be advisory only and shall operate under the following nonexclusive guidelines:

- A. The Board shall consist of seven (7) members to be appointed by the Parish President and confirmed by majority vote of the Parish Council;
- B. The term of each member shall be three (3) years;
- C. Each member shall be a resident of St. Martin Parish;
- D. No member shall receive any compensation;
- E. All meetings of the Board shall be conducted and subject to the latest edition of Robert's Rules of Order, except as otherwise provided for herein;
- F. The Board shall have no authority to enter into any contract whatsoever and shall not have the authority to incur any debt or other obligation;
- G. The said Board shall not have the right to accept any donations or apply for any grant or other stipend except upon written approval of the Parish President.

BE IT FURTHER RESOLVED that the Parish President shall be authorized to establish and impose any additional guidelines or restrictions or exercise such other governance over the Board's activities as he deems necessary and proper, except as otherwise provided for herein.

BE IT FURTHER RESOLVED that the Parish President take any and all actions necessary to effectuate the foregoing resolution.
