AN ORDINANCE BY THE ST. MARTIN PARISH COUNCIL, AS THE GOVERNING AUTHORITY OF SAID PARISH, PROHIBITING THE PARKING OF MOTOR VEHICLES ON THE EITHER SIDE OF THE PARISH ROAD, BERGERON RIGS ROAD, LOCATED IN DISTRICT 9, SECTION 109, TOWNSHIP 8 SOUTH, RANGE 5 EAST, ST. MARTIN PARISH.

BE IT ORDAINED by the St. Martin Parish Council, as the governing authority of said Parish, in regular session convened this 1st day of February, 2022, that no person shall intentionally park a motor vehicle on the either side of BERGERON RIGS ROAD, St. Martin Parish owned and/or maintained by the St. Martin Parish Government.

BE IT FURTHER ORDAINED that whoever violates the provisions of this Section shall be fined not less than Two Hundred Fifty and No/l00 (\$250.00) Dollars, nor more than Five Hundred and No/l00 (\$500.00) Dollars, imprisoned for not more than thirty (30) days, or both, at the discretion of the court, and each violation shall be considered a separate offense.

This Ordinance shall become effective immediately upon approval of the St. Martin Parish Council and the signature of the Parish President.

RESOLUTION NO. 22-009-RS

A resolution approving the holding of an election in Recreation District No. 1 of the Parish of St. Martin, State of Louisiana, on Saturday, April 30, 2022, to authorize the renewal of a special tax therein.

WHEREAS, the Board of Commissioners of Recreation District No. 1 of the Parish of St. Martin, State of Louisiana (the "Governing Authority"), acting as the governing authority of Recreation District No. 1 of the Parish of St. Martin, State of Louisiana (the "District"), adopted a resolution on January 27, 2022, calling a special election in the District on Saturday, April 30, 2022, to authorize the renewal of a special tax therein; and

WHEREAS, the Governing Authority has requested that this Parish Council, acting as the governing authority of the Parish of St. Martin, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the St. Martin Parish Council, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Recreation District No. 1 of the Parish of St. Martin, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, April 30, 2022, at which election there will be submitted the following proposition, to-wit:

PROPOSITION (MAINTENANCE TAX RENEWAL)

Shall Recreation District No. 1 of the Parish of St. Martin, State of Louisiana (the "District"), continue to levy a two and one-half (2.50) mills tax on all the property subject to taxation in the District (an estimated \$58,400 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2023 and ending with the year 2032, for the purpose of maintaining, operating and improving recreational facilities in the District?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.

AUTHORIZING RESOLUTION

A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR A GRANT UNDER 49 CFR 5311, NON-URBANIZED AREA FORMULA PROGRAM AND/OR 49 CFR 5339, DISCRETIONARY CAPITAL PROGRAM.

WHEREAS, the Secretary of Transportation and Development is authorized to make grants for mass transportation projects; and

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provisions by it of the local share of project costs; and

WHEREAS, it is required by the Louisiana Department of Transportation and Development in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder; and

WHEREAS, it is the goal of the Applicant that minority business enterprise be utilized to the fullest extent possible in connection with this project, and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts when procuring construction contracts, supplies, equipment, or consultant and other services:

NOW, THEREFORE, BE IT RESOLVED by ST. MARTIN PARISH COUNCIL:

1. That the <u>PARISH PRESIDENT</u> is authorized to execute and file an application on behalf of <u>ST. MARTIN PARISH GOVERNMENT</u> with the Louisiana Department of Transportation and Development, to aid in the financing of operating and/or capital assistance projects pursuant to the FTA Transit Programs.

- 2. That the <u>PARISH PRESIDENT</u> is authorized to execute and file with such applications an assurance or any other document required by the Louisiana Department of Transportation and Development effectuating the purposes of Title VI of the Civil Rights Act of 1964, as amended.
- 3. That the <u>PARISH PRESIDENT</u> is authorized to furnish such additional information as the Louisiana Department of Transportation and Development may require in connection with the application or financial reimbursement of the project.
- 4. That the <u>PARISH PRESIDENT</u> is authorized to set forth and execute affirmative minority business policies in connection with the project's procurement needs.
- 5. That the <u>PARISH PRESIDENT</u> is authorized to execute grant contract agreements on behalf of <u>ST. MARTIN PARISH GOVERNMENT</u> with the Louisiana Department of Transportation and Development for aid in the financing of the operating or capital assistance projects.
- 6. This resolution is applicable for a period of one year unless revoked by the governing body and copy of such revocation shall be furnished to the DOTD.
