The meeting was called to order by Chairman Chris Tauzin.

The Invocation was read by Brooke Gillespie, and the Pledge of Allegiance was led by David Poirier.

Chairman Chris Tauzin asked for public comments regarding the ordinances being considered for final adoption.

Clerk of the Council Brooke Gillespie read each ordinance summary.

Chairman Chris Tauzin requested that Parish President Chester Cedars briefly explain proposed Ordinance Summary No. 1352-OR. Parish President Chester Cedars declared that this is the product of discussions with officials of the St. Martin Parish Sheriff's Office relative to cockfighting in the parish. This ordinance will be a tool to regulate this type of illegal activity (fighting of fowl, hogs, and/or dogs). While the state statues also prohibit the possession, breeding, training, etc., the proposed ordinance has been amended to only considers the fighting of the animals as a nuisance.

St. Martin Parish resident Billy Broussard requested that, before action is taken, each situation is investigated to ensure the activity is actually taking place, as a story may be fabricated.

Upon requesting and hearing no further comments from the audience regarding the proposed ordinances being considered for final adoption, the Chairman requested a motion to close the Public Hearing.

ORDINANCE NO. 22-05-1352-OR

AN ORDINANCE TO AMEND ARTICLE I OF CHAPTER 24 OF THE CODE OF ORDINANCES FOR ST. MARTIN PARISH, LOUISIANA, BY THE ENACTMENT OF SECTION 24-6, ALL RELATIVE TO THE PROHIBITION OF ACTIVITIES PROHIBITED BY LA. R.S. 14:102.23, 14:102.24, AND 14:102.19, AND DEFINING SUCH ACTIVITIES AS A NUISANCE.

BE IT ORDAINED by the St. Martin Parish Council duly convened in Special session on the 25th day of May, 2022, that:

Article I of Chapter 24 of the Code of Ordinances for St. Martin Parish, Louisiana, be amended by the enactment of Section 24-6 as follows:

Section 24-6. Use of premises for activities prohibited by La. R.S. 14:102.23(A)(1), 14:102.24, and 14:102.19(A).

A. Statement of Policy and Applicability.

The St. Martin Parish Council recognizes that the participation in and/or the use of property for the activities prohibited by La. R.S. 14:102.19(A), 14:102.23(A)(1), and 102.24 constitutes a

nuisance as defined in Section 24-1. Moreover, the St. Martin Parish Council is charged with the responsibility of protecting the property owners within the unincorporated areas of St. Martin Parish and as such, the Council is acutely interested in promoting the general health and welfare of the citizens of the Parish and protecting their property interests. Therefore, in order to foster the interest of the general public, the Parish Council does hereby adopt and enact this edict.

B. Prohibition Against the Use of Property for activities prohibited by La. R.S. 14:102.19, 14:102.23, and 14:102.24.

No person, partnership, firm, association, corporation, limited liability company, or entity shall, within the unincorporated areas of St. Martin Parish, Louisiana, use or caused to be used any land, structure, or enclosed area over which the said person, partnership, firm, association, corporation, limited liability company or entity has the ownership, care, custody, or control for any activity specifically prohibited by La. R.S. 14: 102.19(A), 14:102.23(A)(1), and/or 14:102.24. This section is applicable whether the ownership, care, custody, or control is of a permanent or temporary nature.

In addition to its ordinary meaning of the term “structure” for purposes of this Section is defined as further including any temporary or permanent enclosure such as a tent, pen or fenced area, or shed.

C. Penalties and Remedies.

Further, the Parish of St. Martin hereby deems such activities to be a nuisance and unlawful. Therefore, any violation shall entitle St. Martin Parish Government to avail itself of all rights and remedies set forth in Article I of Chapter 24 of the Parish’s Code of Ordinances as well as availing itself of all remedies allowed by the general law of the State of Louisiana inclusive of injunctive relief.

Moreover, whoever violates any term or provision of this Chapter shall be fined not less than Three Hundred and No/100 (\$300.00) Dollars, nor more than Five Hundred and No/100 (\$500.00) Dollars, imprisoned for not more than thirty days, or both. Any penalty imposed shall not be subject to suspension.

BE IT FURTHER ORDAINED that the provisions of this ordinance are hereby declared to be severable, and if any provision, word, phrase, or clause of this ordinance or the application thereof

to any person or circumstance is held invalid, such invalidity shall not affect the validity of the remaining portions thereof.

BE IT FURTHER ORDAINED that this ordinance shall become effective upon approval by the St. Martin Parish Council and signature by the Parish President.

AN ORDINANCE TO AMEND CHAPTER 19, ST. MARTIN PARISH ZONING ORDINANCE, APPENDIX D, PARISH ROAD ZONING DATA SHEETS OF THE CODE OF ORDINANCES FOR THE ST. MARTIN PARISH GOVERNMENT BY: AMENDING ZONING CLASSIFICATION DISTRICT ON A PORTION OF A ROAD ZONED IN THE ORIGINAL ORDINANCE ADOPTED ON DECEMBER 18, 1995. **{1201 CAMP BON TEMPS ROAD}**

The Parish Council of the Parish of St. Martin does hereby ordain as follows:

SECTION I: The Parish Road Zoning Data Sheets are hereby amended to revise the zoning classification district on that portion of the parish road listed below and to allow the remainder of the road to remain as currently classified.

<u>Road</u>	<u>Old Zoning Classification</u>	<u>New Zoning Classification</u>
Camp Bon Temps Road (1201)	R-2 (Mixed Residential)	I-1 (Light Industrial)

This zoning classification change is being made to allow for the operation of an ATV mechanic shop (Neurotic ATV), at 1201 Camp Bon Temps Road, Breaux Bridge, Louisiana, Assessor's Parcel No. 0490001055. If a change in this type of business is desired in the future, the change would have to be approved by the Parish Council in the form of an amended ordinance. This zoning classification shall remain in effect only so long as the subject property remains owned by Thomas Overfelt. Once the mechanic shop ceases operations or the property is sold or otherwise transferred, the zoning classification will automatically revert to the previous zoning classification of R-2 (Mixed Residential).

BE IT FURTHER ORDAINED that the use of the said property for the purposes defined by Appendix A of the St. Martin Parish Zoning Ordinances relative to the I-1 classification are hereby restricted as follows:

- A. Hours of operation of the mechanic shop: Monday through Thursday (8:00 a.m. to 5:00 p.m.), Friday (8:00 a.m. to 11:30 a.m.) and every other Saturday (8:00 a.m. to 10:00 a.m. for pickup and intake only).
- B. All business operations are to be conducted in the rear fenced portion of the property.
- C. Gate to fenced area is to remain closed during operating hours.
- D. Resident must appear before the Council on May 2, 2023, for continuation of the zoning classification change.

This Ordinance shall become effective immediately upon approval of the St. Martin Parish Council and the signature of the Parish President.

AN ORDINANCE TO AMEND CHAPTER 19, ST. MARTIN PARISH ZONING ORDINANCE, APPENDIX D, PARISH ROAD ZONING DATA SHEETS OF THE CODE OF ORDINANCES FOR THE ST. MARTIN PARISH GOVERNMENT BY: AMENDING ZONING CLASSIFICATION DISTRICT ON A PORTION OF A ROAD ZONED IN THE ORIGINAL ORDINANCE ADOPTED ON DECEMBER 18, 1995. **{1245 MELVIN DUPUIS ROAD}**

The Parish Council of the Parish of St. Martin does hereby ordain as follows:

SECTION I: The Parish Road Zoning Data Sheets are hereby amended to revise the zoning classification district on that portion of the parish road listed below and to allow the remainder of the road to remain as classified.

<u>Road</u>	<u>Old Zoning Classification</u>	<u>New Zoning Classification</u>
Melvin Dupuis Road (1245)	R-2 (Mixed Residential)	I-1 (Light Industrial)

This zoning classification change is being made to allow for the operation of a staging yard, warehouse, and office for a cleaning contractor (Superior Contract Cleaning), at 1245 Melvin Dupuis Road, Breaux Bridge, Louisiana, Assessor's Parcel Nos. 06102A3731, 06102A3732 and 06102A3733. If a change in this type of business is desired in the future, the change would have to be approved by the Parish Council in the form of an amended ordinance. This zoning classification shall remain in effect only so long as the subject property remains owned by Rinea Thornton. Once the staging yard, warehouse, and office for a cleaning contractor ceases operations is closed or the property is sold or otherwise transferred, the zoning classification will automatically revert to the previous zoning classification of R-2 (Mixed Residential).

BE IT FURTHER ORDAINED that the use of the said property for the purposes defined by Appendix A of the St. Martin Parish Zoning Ordinances relative to the I-1 classification are hereby restricted as follows:

All structures will have to adhere to the Residential setback requirements, as follows:

- Front Yard- 25 feet
- Side Yard- Total: 20% of lot width (minimum 10 feet)
- Rear Yard- 20% of lot depth (not required to exceed 25 feet)

This Ordinance shall become effective immediately upon approval of the St. Martin Parish Council and the signature of the Parish President.

AN ORDINANCE TO AUTHORIZE THE ST. MARTIN PARISH GOVERNMENT TO SELL BY PUBLIC DISPOSITION ALL OF ITS INTERESTS IN THE PROPERTY DEPICTED AS LOTS 2B AND 7A OF THAT ACT OF PARTITION RECORDED IN THE CONVEYANCE RECORDS OF ST. MARTIN PARISH, LOUISIANA, IN BOOK 815, PAGE 235, UNDER ENTRY NO. 193457, ALL IN ACCORDANCE WITH LA. R.S. 47:2201, *ET SEQ.*

WHEREAS, the following described property was previously adjudicated to the St. Martin Parish Government in accordance with La.R.S. 47:2196:

All of Vendor's right, title and interest in that certain lot or parcel of ground situated on the west side of the Bayou Teche, St. Martin Parish, Louisiana, in Section 7 of Township 9 South, Range 5 East, and being more particularly described as Lot 2B of that Act of Partition recorded in Conveyance Book 815, at Page 235, under Entry No. 193457 of the Conveyance Records of St. Martin Parish and as shown on the plat of survey attached thereto;

TOGETHER WITH:

All of Vendor's right, title and interest in that certain lot or parcel of ground situated on the west side of the Bayou Teche, St. Martin Parish, Louisiana, in Section 7 of Township 9 South, Range 5 East, and being more particularly described as Lot 7A of that Act of Partition recorded in Conveyance Book 815, at Page 235, under Entry No. 193457 of the Conveyance Records of St. Martin Parish and as shown on the plat of survey attached thereto.

WHEREAS, the aforesaid property adjoins property owned by David John Lester, who has furnished due and competent proof of satisfaction of the requirements of La. RS 47:2202(B); and

WHEREAS, no one has availed themselves of any right of redemption relative to the disposition of the said property in favor of the St. Martin Parish Government; and

WHEREAS, no one has filed any litigation seeking to annul the adjudication confected in favor of the St. Martin Parish Government; and

WHEREAS, all interested parties have been advised that the periods for redemption and/or annulment of the aforementioned adjudication may not have not tolled; and

WHEREAS, the property in question serves no useful purpose for the public, in general, and the St. Martin Parish Government, in particular; and

WHEREAS, the St. Martin Parish Government has determined that the said property has little or no value to the Parish; and

WHEREAS, David John Lester, who resides at 1244 Bergeron Road, Breaux Bridge, Louisiana, 70517, has expressed an interest in acquiring the said property, and the Parish Council has acquired competent evidence that for greater than twelve (12) months he has performed significant upkeep to the property which is adjacent to other property owned by him; and

WHEREAS, the said David John Lester has agreed to remediate the said property as regards its blighted and neglected condition; and

WHEREAS, the sale of the subject property to David John Lester will be of significant benefit to both the St. Martin Parish Government and the general public; and

WHEREAS, by virtue of La. R.S. 47:2202(B) St. Martin Parish Government is authorized to sell the property to David John Lester without public bid at its fair market value of \$3,000, which St. Martin Parish Government has determined to be fair and reasonable; and

WHEREAS, the St. Martin Parish has received no other offers to purchase the property since its acquisition by tax sale:

BE IT, THEREFORE, ORDAINED that, on behalf of the St. Martin Parish Government, Parish President Chester R. Cedars be authorized, empowered, and directed to initiate the steps necessary to sell the following described property which has been adjudicated to the Parish, the disposition thereof to be confected in accordance with La. R.S. 47:2202(B), *et seq*:

All of Vendor's right, title and interest in that certain lot or parcel of ground situated on the west side of the Bayou Teche, St. Martin Parish, Louisiana, in Section 7 of Township 9 South, Range 5 East, and being more particularly described as Lot 2B of that Act of Partition recorded in Conveyance Book 815, at Page 235, under Entry No. 193457 of the Conveyance Records of St. Martin Parish and as shown on the plat of survey attached thereto;

TOGETHER WITH:

All of Vendor's right, title and interest in that certain lot or parcel of ground situated on the west side of the Bayou Teche, St. Martin Parish, Louisiana, in Section 7 of Township 9 South, Range 5 East, and being more particularly described as Lot 7A of that Act of Partition recorded in Conveyance Book

815, at Page 235, under Entry No. 193457 of the Conveyance Records of St. Martin Parish and as shown on the plat of survey attached thereto;

The aforesaid property does not currently have assigned to it a municipal address.

BE IT FURTHER ORDAINED that the sale of the subject property shall be in accordance with the procedures permitted by La. R.S. 47:2202(B), *et seq.*

BE IT FURTHER ORDAINED that the sale of the subject property shall be for a minimum amount of Two Thousand Five Hundred and No/100 (\$2,500.00) Dollars.

BE IT FURTHER ORDAINED that the sale shall be pursuant to the normal terms and conditions of cash sales executed in the State of Louisiana and these special terms, conditions, and provisions:

- A. The sale shall be without warranty of title;
- B. All structures situated on the property shall be sold without warranty of fitness, expressed and/or implied, including those set forth in Articles 2520, *et seq.* of the Louisiana Civil Code;
- C. All notices mandated by La.R.S. 47:2706 and La.R.S. 47:2207 shall be the sole and exclusive obligation of vendor;
- D. The provisions specified in La.R.S. 47:2207(B) shall be incorporated in the sales instrument; and
- E. All mineral rights shall be reserved in favor of the St. Martin Parish Government.

BE IT FURTHER ORDAINED that Parish President Chester R. Cedars be further authorized to incorporate in the aforesaid sale document such other terms, conditions, and provisions as he deems necessary and proper.

BE IT FURTHER ORDAINED that Parish President Chester R. Cedars be authorized, directed, and empowered to adopt any and all other steps necessary to effectuate the terms, provisions, and conditions of this edict.

BE IT FURTHER ORDAINED that this ordinance shall become effective immediately upon approval of the St. Martin Parish Council and the signature of the Parish President and shall be further governed by the provisions of La. R.S. 47:2201, *et seq.*


