### FIREFIGHTER / PARAMEDICS



The City of Marysville is accepting applications for the position of full-time Firefighter-Paramedic. Minimum application requirements include being a high school graduate, Michigan Firefighter I & II, Hazardous Materials Operations Level, and Michigan licensed paramedic. A valid Michigan driver's License, acceptable driving record, and clean criminal history are required for consideration. Preference will be given to applicants with a college degree, applicable experience as determined by the city, and military service. Before appointment, candidates must complete an interview, background investigation, physical, and drug screen.

Positions are not grant-funded. The starting wage is \$75,467 plus benefits, including a 457 with a 10% city contribution if the employee contributes 4%.

A City of Marysville employment application is required and can be downloaded at www.cityofmarysvillemi.com. A copy of certifications shall be submitted with the application. The application period will remain open until the position(s) are filled. The Marysville Fire Department is a combination department with 10 career, part-time, and oncall staff providing fire suppression, advanced life support ambulance, and all-hazards emergency service to the City of Marysville and portions of St. Clair Township. The department was established in 1919 and operates a fleet of three fire apparatus, two ambulances, a fireboat, and specialty support vehicles from one central station. In addition to 911-generated runs, the department also provides community education, tactical paramedics, code enforcement, and fire investigations.

- 5. American Heart Association, Advanced Cardiac Life Support Provider
- 6. NIMS-IC100, 200, 700 and 800 Certificates

In addition to the above stated requirements, applicants will be evaluated on the basis of the following:

Work on and around moving machinery, vehicles and equipment.
