I have reviewed the information you provided, the county has not approved the Debt Service in the past. If you can recall at a previous meeting the School District showed Federal Revenue/EIA Revenue/Other State Restricted that is what the County has been adding to the total amount. If there is a statue that does not need to include the Federal portion send it to me so I can explain to County Council that your operating budget did not decrease from \$12,140,773 to \$10,207,520, difference <\$1,933,253>. We just want to convey the same message as the School District and move this County forward. By no means are we trying to challenge any of your efforts. The Bond information provided yesterday put Council & School District on same page, should not be an issue in the future.
