

Annual Budget and Tax Levy

An overview of the County's process and timeline

DEPARTMENT PLANNING

Department Heads are tasked with preparing their anticipated expenses and revenues for the following year. This process begins in June and continues throughout the summer.

FINANCE & BUDGET MEETINGS

The McLeod County Finance Director meets with individual Department Heads, compiling and verifying the budget information before compiling it and presenting it to the budget committee for discussion.

PRELIMINARY LEVY The Budget Committee makes a recommendation to the County Board in September to set the preliminary levy. Once the preliminary levy is set, it cannot be increased, only decreased. After this stage in the process, staff work to fine-tune the budget and prepare it for its final approval.

FINAL LEVY

In December each year, the Finance Director presents the final Budget Committee recommendations to the County Board to set the final levy. Once the levy is adopted, the Finance Director has it printed in the official county newspaper and sends it to the Office of the State Auditor for recording.





Autumn is here and there are plenty of opportunities to enjoy the outdoors at any of the McLeod County Parks; October can offer great camping weather. Campgrounds at Lake Marion Regional Park and Piepenburg Regional Park remain open thru <u>Sunday</u>, <u>October 17th</u> with plenty of sites currently available. In addition to Piepenburg and Lake Marion, we encourage you to visit William May Park by Winsted, Buffalo Creek Park near Glencoe, Swan Lake Park by Silver Lake and Stahl's Lake Park near Hutchinson; all offer hiking trails of varying lengths, ideal for anyone from families with young children to those looking to spend more time enjoying nature.

Veteran Services

Veterans Affairs (VA) Health Care System is once again offering flu shots to enrolled veterans. Options for Veterans to receive a flu shot include:

- At a regularly scheduled appointment at your VA Medical Center or Community Based Outpatient Clinic (CBOC)
- At a walk-in flu shot clinic, occurring on specific dates at the VA Medical facilities
- At a drive-up flu shot clinic, occurring on specific dates and at various locations

REDISTRICTING is the process of redrawing the boundaries of election districts, completed by legislature (congressional and legislative districts), by city councils (wards and precincts), by township boards (precincts), by school boards (school board election districts) and by county boards (commissioner districts) after the completion of the decennial Census in the United States. The purpose of redistricting is to ensure that the people of each district are equally represented.

Estimated timing of redistricting includes the census data released September 2021, legislative sessions beginning January 2022, congressional and legislative plans completed February 2022, precinct and city redistricting deadline March 29, 2022, county commissioner and other redistricting deadline April 26, 2022.

Administrator's Message: American Rescue Plan Act (ARPA)

f federal funds through the eived by the County has been for their funds no later than

McLeod County has been allocated \$6,971,794.00 of federal funds through the American Rescue Plan Act (ARPA); the first "tranch" received by the County has been \$3,485,897.00. Cities and townships must directly apply for their funds no later than October 04, 2021 with the Minnesota Management and Budget Office. Many of McLeod County's cities and townships have already applied and received their first half of funds.

These funds must be allocated to approved uses by December 31, 2024 with funds needing to be spent by December 31, 2026. The Coronavirus Relief Fund Committee and Board of Commissioners are working together and with guidance from the Association of Minnesota Counties and the US Department of Treasury to navigate the preliminary guidelines identifying appropriate uses for the funds.

The County is currently identifying eligible uses and allocating the funds into applicable categories; since the US Department of Treasury has only issued an "interim" final ruling, it is possible that the eligible expenses will be adjusted until a final ruling is issued.

McLeod County continues to research the eligible uses of these funds in cooperation with the municipalities within our borders, and also with neighboring counties. The County's Coronavirus Relief Fund Committee has been tasked with making recommendations to the County Board of good investments in our community.

Health and Human Services: COVID-19 Response Update

We are currently facing a critical stage in the COVID-19 pandemic. The Delta variant is pushing case numbers up across the country, including right here in Minnesota. The Delta variant is significantly more infectious than the original strain of COVID-19 and is the dominant version circulating in Minnesota, causing 3 out of every 4 COVID-19 cases in our state. As children are back in school, we need to do everything we can to prevent a new surge in cases.

According to the CDC COVID Data Tracker, McLeod County has seen an increased rate of COVID-19. McLeod County has moved into the Centers for Disease Control and Preventions' (CDC) high community transmission rate for COVID-19 as positive cases, hospitalizations, and deaths are once again increasing in nearly all states, fueled by the B.1.617.2 (Delta) variant. The highest spread of cases and severe outcomes is happening in places with low vaccination rates. Although COVID-19 vaccination is the most effective prevention measure, vaccination rates across the United States have varied.

MCLEOD COUNTY TO DATE

As of September 24, 2021, the county has had 5,196 COVID-19 cases since the start of the pandemic, and 65 deaths.

Currently, 61.3% of the county's population 16 years of age and over has received at least one dose of a COVID-19 vaccine, and 50.4% of the county having completed their vaccinations.

RESIDENTS ARE ENCOURAGED TO GET VACCINATED

Residents are encouraged to get vaccinated to minimize transmission. Vaccination can build a wall of protection around a large piece of the population, including children under 12, who have not had the opportunity to receive a shot. For those who are eligible (ages 12+) to get vaccinated but haven't yet done so, now is the time to do it. A full vaccination series provides strong protection against serious illness, hospitalization, and death.

Several places currently offer vaccines, including local clinics and pharmacies. McLeod County Health and Human Services continues to offer vaccination clinics for residents ages 18 and up.
