Morningside Avenue

With construction completed in December of 2021, this project is located in the City of Glencoe and included construction of 0.5 miles of new urban roadway, 700 feet of reconstructed roadway, a new railroad crossing and a roundabout servicing businesses, residential homes and the Glencoe Silver Lake School.







HISTORY


- A three-phase project that began in 2005 to provide Glencoe with an important second river crossing and a vital local and regional connection through the community of Glencoe between US 212 and Trunk Highway (TH) 7.
- The Connection had been identified in various comprehensive planning documents and transportation studies over the past several decades.

KEY ELEMENTS

The project included the following elements:

- New regional highway corridor connection
- Roundabout
- Improved drainage and storm water ponding for local flood mitigation
- · Trail connection to public school campus and regional trail system
- Improved rail crossing with gates and signals for both pedestrians and vehicles

DESIGN



- · Adjacent to existing high voltage transmission lines, a public park, HRA housing, wetlands and a former city landfill.
- The final product is the only roadway in the community that provides access across Buffalo Creek to US Highway 212 while also providing direct access to the community and other regional transportation corridors.
- A roundabout promotes traffic calming as high speed vehicles enter the city from the north and also reduced the footprint of the intersection which minimized the overall impact to existing wetlands in the area.

FUNDING

Project funding came from multiple sources, including MnDOT Rail Safety Funding, Twin Cities and Western (TCW) Railroad, Local Road Improvement Plan (LRIP) earmarks (two separate bonding years), County State Aid, Municipal State Aid and local City and County funds.



PARKS

McLeod County's six parks continue to operate on winter hours: 8:00 a.m. until Sunset

All parks have hiking trails available; cross-country skiing and snowshoeing is encouraged. The County's Park and Recreation workers keep trails at Stahl's Lake Park groomed throughout winter months; ideal for cross-country skiing!

Be sure to get out and stay active during the winter season!

McLEOD COUNTY SPOTLIGHT:

Christy Christensen, McLeod GIS Manager, elected as Minnesota County GIS Association (MCGISA) President



The Minnesota County Geographic Information Systems Association (MCGISA) has recently elected McLeod County GIS Manager Christy Christensen as its new president. The organization, originally founded in 2007, represents county-level geographic information systems professionals who create and maintain the digital data that supports mapping, web applications and location analysis for a variety of county functions. These functions range widely from public works asset management, law enforcement, preparing data for emergency and police response systems, property tax collection, property management, environmental protection to managing the collection and maintenance of aerial imagery repositories.

Christensen was unanimously elected as President by MCGISA's ten regiona representatives.

"Christensen is heralded for his extensive technical experience and long-standing leadership in county-level geographic information systems development and management. During his 30+year tenure in county government, McLeod County has been widely acknowledged as a leader in developing and maintaining high-quality address data, road network data, public land survey and parcel data."

The organization has recently been working to both reinvent and reinvigorate itself to meet new upcoming challenges which involve GIS technology including preparing for NextGen9-1-1, improving inter-governmental data interoperability with data standards development and adoption, supporting the professional survey community in the remonumentation of the statewide public land survey system infrastructure as well as aligning themselves with other groups in finding ways to maximize public investment in geospatial technology. Under Christensen's leadership, the organization has already identified goals of prioritizing technology issues common to all counties in Minnesota and establishing a modest scholarship fund for up-and-coming individuals in the profession.

Other officers newly elected in to the MCGISA Executive Team with Christensen include Treasurer Mark Sloan (Clay County), Secretary Justin Lutterman (LeSueur County) and Vice President Geoff Maas (Ramsey County).


