## MAKING PARKS MORE APPEALING

## New County Parks Plan integrates improvements for all six parks



Improvements to County Parks such as Lake Marion Park (top) and Piepenburg Park (bottom) are all part of the new McLeod County Parks Plan. The plan focuses on long- and short-term goals for the six County Parks.

The first McLeod County Parks Plan was adopted by the Board of Commissioners at their meeting on December 19, 2023. The plan will be used for short-term and long-term planning, and for future development of the County's six parks: Lake Marion Regional Park, Piepenburg Regional Park, Stahl's Lake Park, Swan Lake Park, Buffalo Creek Park, and William May Park.

The plan identifies numerous opportunities for improvement at each park, including updated signage, installation of playground equipment, campground upgrades, programming, and the installation of a disc golf course.

A list of "First Focus Areas" was developed to kickoff the

## Safety, maintenance are focus points

implementation of the plan.

Safety for parkgoers is important to McLeod County. Projects that present an opportunity to improve safety or areas where safety concerns have been identified will be prioritized.

Maintenance at all parks will be addressed. Structures that need repair will be attended to or removed if deemed no longer usable. Opportunities for decreasing maintenance will also be prioritized so that resources can be allocated efficiently.

**Restrooms** that are sanitary and updated are a necessity in several parks. Vault-style

restrooms may be converted to a structure with running water and septic or replaced with portable restrooms.

**Drinking water** should be accessible in all parks. Wells with fixtures for drinking

water could be installed in parks where they are not currently available.

**Signage** throughout all parks should be updated and uniform. Parkgoers should recognize when they are in a McLeod County park upon entering. Park rules and expectations should be easily identifiable, and there may be areas for wayfinding or informational signage.

Relevant McLeod County staff will reference the plan and its contents regularly to ensure that decisions being made to improve the quality of each park work with the plan's recommendations. The goal is to create a better experience for all parkgoers.

# What to expect for 2024 property valuations

## Ag property in McLeod County sees 30% increase in average sale price

A new assessment year begins Tuesday, January 2, 2024. Part of the statutory responsibilities for the Assessor's Office is to adjust its values based on the ratio of property sales.

A Sales Ratio Study is done on a yearly basis. In this study we look at properties that have sold and compare that average sale price to the assessed value. Assessed values are required to be between 90% to 105% of that average sale price.

The Sales Ratio Study runs from October to September. For the 2024 assessment, sales that occurred from October 2022 to September 2023 are considered. These sales must be qualified, which means sales that are between relatives, are satisfying a contract for deed, or any sales under duress are not included. Each sale to is verified to make sure it is a qualified sale.

Once staff processes the information, the ratio is determined by taking the assessed value and dividing it by the average sale price. This is done by taxing district and by classification. Each township and city is done on its own, and each type of classification is done on its own. If the ratio in the taxing districts falls below 90%, we are required to increase the assessed value. If the ratio is above 105%, we are required to decrease the assessed value.

This year, with rising interest rates, we are not seeing as big of an increase in values as we have seen in the past couple of years. One exception, however, is with agricultural properties.


The greatest increase for residential properties is 10%, while many areas have held steady with little or no change from last year. Apartment, Commercial and Industrial properties are also holding steady with little or no change. Agricultural properties in our area will see significant change as values increased 30% on average. McLeod County's average sale price per acre is \$9,800.00 compared to \$7,700.00 last year. That is up from \$6,400.00 the year before.

Once values have been updated • valuation notices are sent out to property owners for each parcel. This notice is mailed with the tax statement in the middle of March. There is an appeal process • which starts in April. The date • time and location of these appeals meetings are noted on the valuation notice • along with contact information for the Assessor's Office.

## Changes ahead for property assessing



County Assessor's Office will handle all McLeod property assessing in 2025

Following a split Board vote, McLeod County will join 34 other Minnesota counties in establishing a "true county assessor" system.

The McLeod County Board of Commissioners voted 3–2 at their December 19 meeting to adopt a resolution to make the shift to a true county assessor system. The resolution passed with support from Commissioners Doug Krueger, Paul Wright and Joe Nagel. Commissioners Daryl Luthens and Nathan Schmalz opposed the resolution.

Under this new system, the practice of local assessing will end in McLeod and the County Assessor's Office will be responsible for all property assessments throughout the County. As required by state statute, this change will not take effect until the 2025 assessment period, so there are no changes for the upcoming 2024 assessment period.

During months of deliberation and listening to constituents, the Board of Commissioners considered several factors, such as the impact this change would have on taxing districts that use local assessors, as well as those that do not.

## What will change

- The practice of local assessing will be discontinued, and the McLeod County Assessor's Office will be responsible for all County property assessments
- Annual contracts between the Assessor's Office and taxing districts will no longer be required
- Assessing and maintenance fees will be removed from the fee schedule

## What won't change

- Taxing districts will maintain authority over their local Boards of Review or Boards of Appeal and Equalization
- The Open Book review processes will continue to be maintained by local taxing districts
- There will be no changes to Minnesota Department of Revenue responsibilities and oversight

Out of the County's 23 municipalities (14 townships and nine cities), nine currently use local assessing through three local assessors. Those districts are Collins Township, Hassan Valley Township, Hutchinson Township, Penn Township, Rich Valley Township, Round Grove Township, Sumter Township, and the cities of Silver Lake and Stewart. This means that just 22.9% (4,826 parcels) of the County's parcels are viewed by private assessors, while the County Assessor's Office views the other 77.1% (16,210 parcels).

The County levy currently covers a majority of the costs for property assessments. The expense per parcel is \$27.96, and the County charges a \$3.00 per parcel maintenance fee and a \$7.50 per parcel assessment fee. Those fees cover about 37.5% of assessment costs. Removing those fees would be a reduction of approximately \$177,882.00, or 0.32% of annual budgeted revenue.

The County must also add support to the Assessor's Office to assist with the added workload. This may be an estimated \$89,000.00 cost including wages and benefits, an increase of about 0.15% of annual budgeted expenditures.

## Save time and be prepared for another busy election season this year

It's a busy election year in 2024. Here is information to help voters before elections. If you are unclear about election processes, call our office at 320–864–1203. We are here to help you, and we demand accurate public information. Minnesota is known as a past national leader in ballot integrity, election reform and voter turnout. I thank you for your participation in any of these areas and look forward to serving McLeod County voter needs.

## What is the Presidential Nomination Primary (PNP)?

Beginning in 2020, the Legislature authorized a nomination primary for President of the United States. The PNP supplements the party caucus model that had been used in Minnesota for many years. It does not replace the precinct caucuses, which are an important part of each party's process for endorsing candidates and are required by law.

The PNP is required to be administered similarly to the state partisan primary, with certain exceptions. Separate ballots are printed for each participating political party • and voters are required to affirm the party of the ballot they wish to cast. The voter's political party choice will be recorded and disclosed to the state Chair of that major political party.

## Who can vote?

## To vote • you must be:

- A U.S. Citizen
- At least 18 years old on Election Day
- A resident of Minnesota for at least 20 days
- Not currently incarcerated for a felony conviction
- Not under a court order that revokes your right to vote

Only Presidential candidates chosen by each participating major party appear on the PNP ballot.

# Giving veterans a helping hand

## Welcome Home Vet prepares veterans for life outside military

Transitioning out of enlisted life can be a challenge for veterans when the military is all you've known in adulthood. Fortunately for local veterans and their families, Welcome Home Vet wants to help.

Tim Burley, a veteran from Hutchinson, founded Welcome Home Vet about seven years ago. The goal was to provide a network of resources, education and support to help veterans reintegrating into their communities.

"I was taking suicide and crisis calls from veterans, and they were all stringing together the same reasons (for being in crisis) – finances, family, divorce, issues they weren't able to cope with," Burley said.

The military provides structure for enlisted men and women that they become reliant on, Burley explained. When they leave the military, they no longer have that structure and must learn to provide those needs on their own.

Veterans have needs for education, counseling, employment, health care, life skills, spirituality and more. Welcome Home Vet is there to help.

"We are a community of military and civilian people who have formed an alliance with one specific purpose – to take care of our returning vets," according to the group's website, welcomehome.vet. "We do this by our initial actions and involvement in the lives of our veterans and how we work to organize the cities and communities we live in towards being veteran ready and veteran friendly."

Helping veterans get on their feet isn't just a benefit to them. As Burley points out, veterans can be an economic boon to others.

"In the military currently there are about 495 different job skills, from plumbers to HVAC to cooks, you name it," Burley said.

Veterans are loyal, highly trained people who contribute 11 percent of the gross domestic product of the United States. They can bring the skills they learned in the military and apply them to work in civilian life.

A rising tide lifts all boats, and Welcome Home Vet is dedicated to providing veterans with the assistance they need to become outstanding members of our communities.
