
The points are listed starting with the point above the SE corner and continuing in a counter-clockwise rotation around the section. This normally begins with the East point, Northeast, then North, but may also include Witness Corners, and/or Meander Corners.

### Definitions

**Witness Corner:** A witness corner "stands in" when the true corner cannot be monumented or occupied because of difficult terrain or obstruction of the corner sight. The witness corner must be on the section line and is usually 5 or 10 chains away from the true corner.

**Meander Corner:** The intersection of a township, range, or section line and the banks of a navigable stream or meandering body of water.

1855 -	The original Public Land Survery of the township line was completed by John Ryan. A wood post was set to mark the corner with reference to two bearing trees.
1970 -	Dickman Knutson, McLeod County Surveyor, set a cast iron monument at the corner. According to his notes, it was located 58.50 feet north of the centerline of the railroad as shown on the railroad map and on the centerline of north/south County Road 71.
1982 -	Willard Pellinen, McLeod County Surveyor, found that the cast iron monument set by Knutson was gone. A new cast iron monument was set according to Knutson's reference ties.
1990 -	Willard Pellinen recovered the cast iron monument about 10" below the road surface and set new reference ties.
1991 -	A Mn/DOT survey crew (Gene East, crew chief) recovered the cast iron monument a few inches below the road surface and placed a P.K. nail over it at the road surface. It was located as shown in Pellinen's notes.
	The cast iron monument is accepted as the corner location because it fits long standing occupation lines and it is 0.62 ft. west and 4.43 ft. north of the lost location.



The north quarter corners of the sections lying adjacent to and immediately south of a Standard Parallel were not set in the original survey. The acreages shown on the original plat for the fractional quarter sections adjacent to the Standard Parallel indicate that the quarter corner should be located midway between the section corners. This method of establishing the quarter corner is in paragraph 205 on page 212 of the Manual of Surveying Instructions 1947, published by the Department of Interior, Bureau of Land Management.

A point 0.22 feet south of the cast iron monument on the Fourth Standard Parallel is accepted as the corner location because it substantially fits the highway right of way map location and it is only 0.18 feet east of being midway between the section corners.



- Dickman Knutson, McLeod County Surveyor, interviewed Mr. Fred Zavoral (63) who has lived in the NW 1/4 of Section 2 all of his life. He stated that the old north/south fence line and a large tree about 300 feet north of the railroad were on the section line. Evidence of the old fence line was found. A 1/2" diameter iron pipe was set on the old fence line and 58 feet north of the centerline of the railroad. The old railroad right of way map shows the corner to be 58 feet north of the centerline. This position fits fence corners about 1/4 mile away within 2 feet.
- 1981 Willard Pellinen replaced the iron pipe with a cast iron monument.
- 1991 R. C. Jones, Registered Land Surveyor with Mn/DOT, found the cast iron monument about 1 foot below the ground surface.
   Four of the six reference ties were recovered. No additional ties were set.

The cast iron monument is accepted as the corner location because it fits testimony of a local resident and the location shown on the railroad right of way map. It is 10.11 feet west and 11.84 feet south of the lost location.

- 1855 The original Public Land Survey was completed by A. H. Runyon. A wood post was set above a charred stake in a dirt mound to mark the corner. Trenches and pits were dug as per instructions. Apple seeds were planted at the southeast side of the mound.
- 1978 Dickman Knutson, McLeod County Surveyor, dug for the corner at a point on a north/south field division which was 44 feet south of the centerline of the railroad. This is the location shown on the railroad right of way map. Many stones were found but none of them appeared to have been set to mark the corner. Local landowners have accepted the field division as the section line over the past many years. An iron pipe was set on the north/south field division a distance of 44 feet south of the centerline of the railroad.
- 1979 Willard Pellinen, McLeod County Surveyor, replaced the pipe with a cast iron monument.
- Willard Pellinen measured the east line of the section and found that the distances to the section corners on either side of this corner fits old survey distances within 0.15 ft. to the north and 1.5 ft. to the south.



The north quarter corners of the sections lying adjacent to and immediately south of a Standard Parallel were not set in the original survey. The acreages shown on the original plat for the fractional quarter sections adjacent to the Standard Parallel indicate that the quarter corner should be located midway between the section corners. This method of establishing the quarter corner is in paragraph 205 on page 212 of the Manual of Surveying Instructions 1947, published by the Department of Interior, Bureau of Land Management.

- 1991 R. C. Jones found a 1/2" diameter iron pipe at the surface of an entrance and all but one reference tie.

The iron pipe is accepted as the corner location because it is found to be 42.02 feet west of T.H. 15 P.O.T. 1202+86.90, which closely agrees with all positions shown by various surveys since 1941.

We accept the cast iron monument as marking the correct location of the section corner. It very nearly fits the distances from the 1898 and 1899 surveys by Higgins.

He referenced out the pin and dug a 10 foot long by 5 foot wide by 5 foot deep hole under the pin but did not find any other evidence of monumentation. He set two 5" long spikes, one above the other, to mark the corner. He set reference ties and measured the distance to the southeast corner of the section. He found that the distance to the southeast corner matched Higgins' 1904 survey distance within 1/2 foot.
- 1978 Dickman Knutson recovered the spike set in 1977 and replaced it with a cast iron monument.
- 1991 A Mn/DOT survey crew (Gene East, crew chief) found the cast iron monument about 3" below the road surface and recovered the ties set in 1990. It is located at the centerline of an east/west road.


The cast iron monument is accepted as the corner location because it perpetuates older monumentation that fit a long standing occupation line and substantially fit an old survey. It is 7.75 feet east and 44.07 feet north of the lost location.

May 3, 1904. Old county surveyor notes show a stone at the corner, 2686 feet from the northeast corner of the section.

June, 1926. Carlisle Madson, Sr. set an iron pipe with a standard brass cap on top. He set the corner half way between the section corners. Notes don't show if the corner was set on a straight line.

April 16, 1970. McCombs Knutson Associates (Dickman Knutson, county surveyor) dug for the corner and found a 2 inch diameter iron pipe with a McLeod County brass cap on top. Knutson set a McLeod County cast iron monument at the corner and took reference ties.

April 20, 1981. We found the monument, top broken off, down 2 feet below the road surface. We took new ties and set an iron pipe over the monument. We had a distance of 2669.90 feet to the northeast corner and 2670.34 feet to the southeast corner of Section 12, compared with 2671.7 to each corner by Madson in 1926. We found the corner to be 1.2 feet west of a straight line between the section corners.

June 5, 1990. We found no ties remaining. We dug and found the iron pipe down 4 inches below the road surface and took new reference ties.

We accept the monument set by Carlisle Madson and found by Knutson as marking the correct quarter corner.

- R. C. Jones, Registered Land Surveyor with Mn/DOT, found the cast iron monument about 3" below the surface of the gravel shoulder of T.H. 15. It was located 14.73 feet west of T.H. 15 P.O.T. 1149+46.04. Reference ties were set and a certificate was filed with the McLeod County Recorder, Document No. 202054.
- Willard Pellinen, McLeod County Surveyor, found an indication of iron and set a railroad spike at the surface of the bituminous shoulder of T.H. 15. The bituminous was widened by Mn/DOT sometime between 1983 and 1989 and the top of the cast iron monument may have been destroyed during that reconstruction.
- 1990 A Mn/DOT survey crew recovered the railroad spike.
- 1991 R. C. Jones found the railroad spike at the road surface.

The railroad spike is accepted as the corner location because it was found to be 14.50 feet west of T.H. 15 P.O.T. 1149+45.16, which substantially fits earlier locations, and it very nearly fits the reference ties set in 1983.

February 25, 1980. We found a 2 inch diameter iron pipe 5 feet east of a fence corner. Fences north, south and west. Iron pipe was 1 foot below the ground surface.

September 15, 1980. We replaced the iron pipe with a McLeod County cast iron monument and took reference ties.

Our measured distances match Higgins' 1910 distances to the northeast and northwest corners of the section within a foot. July 16, 1990. We found the cast iron monument in good condition 8 inches below the road surface and took new reference ties.

The monument is accepted as the location of the corner because it perpetuates the position of the old iron pin, it fits the occupation lines, the center lines of the road and it agrees very nearly with the old survey distances.

#### Certificate of Location of Government Corner

August, 1855. This corner was originally established by the General Land Office. A.H.Runyon set a post, drove a charred stake, raised mound with trench as per instructions and planted apple seeds southeast of the mound.

December 23, 1899. Survey notes by E. L. Higgins, county surveyor, show a distance of 2721.5 feet to the northeast corner of Section 36. (calculated distance)


January 31, 1979. We measured the north line of Section 36 and found a 3/4 inch iron pipe at the fence intersection, fences south and east. Emma Kaufman, 70 years old, had lived in the Northeast Quarter of Section 36 since 1944, and William Dahlke, 41 years old, and had lived in the Southeast Quarter of Section 25 since 1941, both testified that this was the quarter corner.

July 6, 1979. We replaced the iron pipe with a McLeod County cast iron monument and took available reference ties.

This corner is about 33 feet west of a splitbbetween the section corners and about 16 feet south of a straight line between the section corners.

We accept the found iron pipe as having perpetuated the location of the quarter corner.

February 8, 1993. We found the monument in good condition. All old ties destroyed so we took new reference ties.

July, 1855. This corner was originally established by John Ryan of the General Land Office. He set a post, deposited charcoal, dug pits and trench, built mound and planted osage orange seeds at the corners of the mound.

September 10, 1969. McCombs Knutson Associates (Dickman Knutson, county surveyor) found a stone at the fence intersection. Fences north, east and west. Mr. Oliver Brecht, who had lived in the Southwest Quarter of Section 36 for 32 years, testified this was the correct location of the quarter corner. Knutson replaced the stone with a McLeod County cast iron monument and took available reference ties.

The monument is accepted as marking the quarter corner. It fits long standing occupation lines, the fences and has been accepted by adjoining land owners as the quarter corner.

February 10, 1993. We found the monument in good condition and checked the ties.

September, 1969. Clarence Ondrachek, in the Northeast Quarter of Section 1, said there is an iron at the corner, near an iron post. Dickman Knutson, county surveyor, found iron rod beside an iron post and replaced it with a McLeod County cast iron monument. He took available reference ties.

February 5, 1993.We found no ties remaining. We found the monument in good condition along the east-west fence, and took new reference ties.

The monument set by Knutson is accepted as marking the correct location of the section corner. It fits long standing occupation lines and it replaces an older monument which had been accepted by adjoining land owners as the section corner.
