The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Unlawful Ouster or Exclusion by Landlord

Minnesota Statute: 609.606, with reference to: 609.606 Maximum Sentence: 90 days in jail, or \$1,000 fine, or both

Offense Level: Misdemeanor

Offense Date (on or about): 04/07/2024

Charge Description: On or about 4/7/2024, within the County of McLeod, State of Minnesota, defendant Herbert Carl Hubbard, a landlord, agent of a landlord, or person acting under the landlord's direction or control, intentionally interrupted or caused the interruption of electrical, heat, gas, or water services to the tenant with intent to unlawfully remove or exclude the tenant from lands or tenements.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

That your affiant is a Peace Officer with the McLeod County Sheriff's Office. Your affiant has learned that on or about April 7, 2024 at approximately 10:26 a.m. Deputy Blake Dahlke of the McLeod County Sheriff's Office responded to a call regarding 501 Mowbray Street #2 in the City of Stewart, County of McLeod, State of Minnesota. Deputy Dahlke arrived and spoke with Victim who stated that Herbert Carl Hubbard (DOB 2-20-1971), Defendant herein, turned off the power to her apartment. Victim stated that earlier Defendant drove around the building a few times in a white van which Deputy Dahlke saw on the scene. Victim stated the main door on the south side of the building leads to a common area that all tenants can use. This door was usually unlocked but now was locked. Victim stated that Defendant had locked the door so she could not turn her power on.

Victim stated that Defendant told her he was the acting landlord. Victim stated Defendant was harassing her and trying to get her to move out so he could move his boys in.

Deputy Dahlke viewed the door on the south side of the building. A tenant unlocked it and let him in. Deputy Dahlke could see the electrical panels for the building. Only one panel was locked with a pad lock and that was the one that controlled the power to Victim's apartment.
