The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Disorderly Conduct - Brawling or Fighting

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

That your affiant is a Peace Officer with the McLeod County Sheriff's Office. Your affiant has learned that on or about May 3, 2025 at approximately 7:03 p.m. Sgt. Brian Stiles responded to a call of a fight at Neisen's Bar in the City of Biscay, County of McLeod, State of Minnesota. Reporting Party stated there were about 10 people involved in the fight and someone was on the ground and people were kicking him on the ground.

Sgt. Stiles arrived and observed a party bus with numerous people on the bus. Sgt. Stiles observed a male party with cuts and scrapes who was identified as Defendant herein, Michael Wayne Petree Jr. (DOB 12-1-1979) who stated that he had gotten into an argument in the bar that ended up in the parking lot. Defendant stated they were pushing and shoving each other and that he tripped and fell down and numerous people ended up falling down. Defendant stated the pushing and shoving was between him and his brother in law Adam Timothy Seefeldt (DOB 5-3-1985).

Deputy Barilla spoke with Adam Seefeldt who stated that he had gotten into an argument with Defendant and they were pushing and shoving each other and Defendant fell to the ground and a bunch of them ended up on the ground.

Deputy Barilla also spoke with Witness who stated that Defendant and Seefeld were grabbing each other and threw each other on the ground and that she broke it up.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
