As a new year approaches, many property owners may be looking to make changes to their property. What you may not know is that the Assessor's Office can help.

ew homes, sheds, additions or remodeling can add value to your property. This additional value can increase what you owe on property taxes. One of the services the County Assessor's Office can perform is a tax estimate. We can give you a general idea of how improvements may impact your property taxes.

We also do tax estimates on classification changes. For example, you may have a shed or building on your property that you are thinking of renting out for storage. This change of use--from personal to rental-may have an impact on your property taxes. The building that is being rented out would change from a residential or agricultural classification to a commercial classification. This is important to note, as commercial classification has a higher classification rate of 1.5%. This change in classification may cause the property taxes assigned to the property to increase. If you are thinking of making a change and want to know how it may affect your property taxes, please contact the Assessor's office for an estimate.

The estimates are free, but you will need to provide the Assessor with information related to cost, size and location. More information may be needed, depending on the situation. Most estimates can be done quickly and may only take a few minutes. If it is a more complicated change, we may need a day or two to get an estimate back to you.

Changes to your property could impact your property taxes. We are here to help you understand what these impacts may be. Please call our office at (320) 864-1254.
