In regards to the residents' concerns voiced at the annual and 5-year plan meeting about nuisance false fire alarm events that occurred on Sunday and not having hot water, it appears the false alarms were the result of vagrants smoking prohibited substances in the stairwell.

Operations Staff confirmed that a part is needed for one of the boilers, but the backup boiler is working. Ops Staff was asked to verify today since the complaints were voiced yesterday afternoon.

Issues are not being brought to our attention timely, if at all. Upon inspection we address any and all issues found and that includes ventilation. Vagrancy is a big issue here, and we do our best daily to keep that at a minimum. In my opinion the best way to combat this issue is to have residents. The word is out that we are empty and that we have no security. Maximum capacity my not deter all but some might think twice before trying to sneak in.

Mr. Swindle, the reason we had 4 false fire alarm Sunday was due to vagrants. I came to Jefferson Sunday because I got excessive call from Miller Protection. I check the fire panel and I had 4 false alarm from stairwell east 8th floor. I went to investigate and discovered two non resident in the stairwell smoking crack, marihuana , and black and mild cigars. I immediately call the police but they left before the police arrived. This is not an isolated incident the week before we had an alarm went off in the basement stairwell. We ran the camera back and discovered the same two and they were accompanied by two more running from the basement. Vagrant is the bigger issue at Jefferson. As for the boiler issue, we do have a boiler down waiting for parts. But I assure you the resident do have hot water. There were an issue over the weekend with the hot water but not one resident called the emergency hotline. We found out about the hot water Monday morning and I immediately took care of the issue. As I stated I was at Jefferson Sunday and if I had none it would've been addressed.

I heard from the residents that the boiler(s) was not working because a part was needed and fire alarms are activating because ventilation damper motors for fan are not functioning properly. I think they stated four false alarms occurred on Sunday.
