

## **PROJECT UPDATES AND AGENDA NOTES**

### **Wastewater Treatment Facility Report**

#### **Cady Road Culvert #2- Bid Recommendation; Green Mountain Engineering – Construction Admin, Construction Services and Record Drawings.**

Ten (10) Bids were received on Friday, February 28. The lowest responsive bidder is Debisschop Excavating at \$74,556.00. See the attached recommendation from Jamie Simpson of Green Mountain Engineering. I request the IC send this bid to the Selectboard for approval.

Also attached is the original Proposal from GME for this project. Items #10, 11, and 12 need to be considered and sent to the Selectboard for approval.

### **Route 116 – Dow Pond Water Main Project**

- Bid Consideration – Seven (7) bids were received on February 28. Low bidder is Desroches Construction Services is the low bidder at \$266,095. See the attached recommendation from Jamie Simpson of Green Mountain Engineering. I request the IC send this bid to the Selectboard for approval.
- Engineering services for construction administration and construction review will be presented at the April 9<sup>th</sup> IC meeting.

### **Police Dept Water & Site Improvements (demolition) - Bid Recommendation**

Three (3) bids were received on February 28. The lowest responsive bidder is Parker Excavation at \$265,907.88. Parker did the removal of the old municipal building. See the attached Otter Creek Engineering Bid Tab and

Recommendation. I request the Committee send the Parker Excavation bid to the Selectboard for approval.

### **Court Street Water Main Project**

Otter Creek Engineering has provided a proposal for bid services and construction services. See attached document. The rates and fees are consistent with their original submission to our Request for Qualifications.

I request the IC send this proposal to the Selectboard for approval.

### **Library Heating/AC system – Engineering Proposal- consideration**

Dana and I have been working with Engineering Services of Vermont to propose design, construction, and bid services to address the Heating/AC systems in the Library. The proposal and the evaluation report are included for your review. We are requesting the proposal be sent to the Selectboard for approval. Funds for this proposal are in the FY21 Capital Improvement Budget. Engineering Services is aware that any invoicing cannot be paid prior to July 1<sup>st</sup>. The design will take several months to complete. We want to have a budget number for the next CIP process.

### **Library Window Restoration**

Dana will give a brief update on the restoration project and additional other window repairs.

### **Pulp Mill Bridge – Programmable Message Board Sign**

Jim Gish, Bill Kernan and I met with the VTrans, Kubricky, and VHB staff three weeks ago about various topics, including the Traffic Control Plan in the downtown, and the Programmable Message Board for the bridge.

There *will* be a sign on Seymour Street located near Bourdeau Bros. entrance. The concern was adequate Right-of-Way to place a board; which

there is along Seymour Street. There will not be a programmable board posted on the Weybridge side of the bridge.
