2017 Local Implementation Grant Programs

The Lake Champlain Basin Program, in cooperation with the New England Interstate Water Pollution Control Commission, is pleased to announce the 2017 Local Implementation Grant programs, including the following groups of grants:

Grant Applications due November 15th, 2017

- Education and Outreach Grants (up to \$10,000 per award)
- Organizational Support Grants (up to \$4,000 per award)

- Pollution Prevention & Wildlife Habitat Conservation Grants (up to \$25,000 per award)
- Aquatic Invasive Species Spread Prevention Grants (up to \$15,000 per award)
- Community Resilience Grants (up to \$20,000 per award),

Grant Applications due November 20th, 2017

- CVNHP Local Heritage Grants (up to \$2,500 for local or \$5,000 per award for regional projects)
- CVNHP Making of Nations Grants (up to \$5,000 per award)

The LCBP anticipates awarding more than 50 grants, reflecting over \$500,000 to support local community involvement in the implementation of the comprehensive management plan Opportunities for Action: An Evolving Plan for the Future of the Lake Champlain Basin (plan.lcbp.org). Funds to support these awards are anticipated from the Great Lakes Fishery Commission and the US Environmental Protection Agency through agreements with the New England Interstate Water Pollution Control Commission.

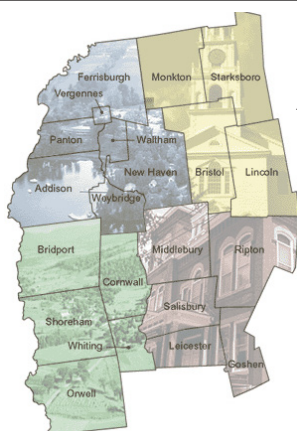

2018 VTrans Transportation Alternatives Grant Program Officially Announced

The FY 2018 Transportation Alternatives Program has been officially opened and will be providing funding to municipalities in order to assist in their efforts of improving the quality of state waters.

Grants funded through this program must have a transportation link. The enabling legislation that determines eligibility follows: “Any environmental mitigation activity, including pollution prevention and pollution abatement activities and mitigation to address stormwater management, control, and water pollution prevention or abatement related to highway construction or due to highway runoff.”

The program will have \$2.2 million available to award, and federal funding will have a cap of \$300,000 per project with a 20% local match required. Informational workshops will also be provided to the public as webinars, and attendees may log on to vtrans.webex.com to fully understand the require-

ments associated with federal-aid projects. No password or pre-registration is required. Two sessions are scheduled as follows:

- Session 1: October 5th from 10:00 AM to 12:00 PM
- Session 2: October 10th from 6:00 PM to 8:00 PM

Rivers and Roads Training Program

The Rivers and Roads Training Program targets a wide range of state, municipal and private sector transportation staff from general maintenance workers and equipment operators to Select Board members and design and construction oversight engineers. The free workshops are open forums for participants to share their experiences in flood recovery and discuss what worked well and what didn't in reconstruction efforts.

Participants will better understand physical river and floodplain processes and be better equipped to design and implement maintenance and repair projects that will enhance the stability of the adjacent river, increase infrastructure longevity, and minimize impacts to aquatic habitats.

The next workshop held by VT Local Roads will take place October 18-19, 2017 (Starksboro Town Garage). These trainings are open to municipal road crew staff, VTrans staff, RPC, and those working directly with a town road crew (such as a conservation district).

Lake Champlain Basin Program Seeks Pre-Proposals to Fund Technical Projects

The Lake Champlain Basin Program (LCBP), in conjunction with the New England Interstate Water Pollution Control Commission (NEIWPCC) is pleased to announce a Request for Technical Pre-Proposals for services to further the goals and objectives of the Lake Champlain management plan Opportunities for Action. The total request for each project may range from \$25,000 to \$300,000 for projects anticipated to begin in early 2019.

Through this request, the LCBP seeks pre-proposals for projects that address strategies outlined in Opportunities for Action. The LCBP is particularly interested in funding projects that address the following priorities:

1. Innovative pilot or demonstration projects that reduce nutrient loading to Lake Champlain
2. Research or implementation projects that use existing, LCBP-funded or other publicly available datasets to create outputs leading to improved water quality in the Lake Champlain Basin
3. Projects that improve diversity of native aquatic and riparian species in the Lake Champlain Basin
4. Projects that research or control sources of contaminants in the Lake Champlain Basin

“The aim of this new inclusive process is to invite a wide range of innovative and effective projects that will address the complex challenges facing the Lake Champlain Basin,” said Dr. Eric Howe, LCBP Program Director. “We anticipate awarding funds to complete multiple projects.”

This Request for Technical Pre-Proposals is a new process for identifying technical projects for consideration in the next LCBP budget. Applicants will be required to submit a two-page conceptual pre-proposal. After an independent evaluation, a subset of pre-proposal applicants will be invited to submit a ten-page full proposal this winter. Grant award recipients will be selected from the pool of full proposals, and will be notified of their anticipated award in late spring 2018.

Pre-Proposals are due to the LCBP by electronic submission on November 8, 2017 at 4:30 p.m.
